RC46 Regional Representative for Japan, Johanna Zulueta, reports on the RC 46 sessions during the 2019 AACS Meeting in Oregon. This is followed a description of the timetable and panel sessions for the RC 46 Clinical Sociology at ISA Forum in Porto Alegre, Brazil in July 2020 by Vice President, Tina Uys. Please take note of the relevant deadlines.

Meanwhile, Agnès Vandevelde-Rougale is calling for proposals for the International Symposium of Clinical Sociology on "Contemporary Subjectivations" to be held in Paris, France on June 2020. The deadline for proposal submissions is on January 15 (<a href="https://www.sociologie-clinique.org/france/colloque-international-subjectivations-contemporaines-appel-a-contributions/">https://www.sociologie-clinique.org/france/colloque-international-subjectivations-contemporaines-appel-a-contributions/</a>). Quite a number of activities were organized by clinical sociologists in Europe. The RISC General Assembly took place last November 25th in Paris, France (<a href="http://www.sociologie-clinique.org/assemblee-generale-2019-le-25-novembre-a-paris/">http://www.sociologie-clinique.org/assemblee-generale-2019-le-25-novembre-a-paris/</a>). Jacques Rhéaume announces the next Congress of the International Association of the French Sociologists to be held in Tunis, Tunisia (July 2020); a conference on "Life Stories in a Changing World: at the Crossroads of Research, Education and Intervention HV2020 UQAM" will be held in Montréal, Québec in May 2020 and the formation of a small research team which advances the Clinical Sociology perspective, called TIP, (Work, Interculturality and Democratic Process).

Gianluca Piscitelli, in collaboration with an Italian agency of sociologists of communication called CONSCOM, is implementing a national project and calling for submissions for the QSC-Quaderni di Sociologia Clinica. We would like to congratulate two members for their publications: Johanna O. Zulueta and her book entitled "Transnational Identities on Okinawa's Military Bases: Invisible Armies" and Miriam Boeri and her book entitled "Inside Ethnography: Researchers Reflect on the Challenges of Reaching Hidden Populations".



We would like to encourage all of you to send us information about your publications and activities.

# RC 46 Members Present at the 2019 AACS Meeting in Oregon

Members of RC 46, led by RC 46 President Emma Porio, VP Tina Uys and Immediate Past President Jan Fritz, presented their work at the Association for Applied and Clinical Sociology (AACS) Annual Meeting held at the Embassy Suites in Portland Washington Square (Oct. 17-19, 2019). A total of four sessions were organized by RC 46.

Starting off on the first day, October 18th, Sharon Everhardt, Daniela Jauk, and Brenda Gill held a session on community gardening, "Veggies Against Barriers – An Interactive Workshop on (Community-) Gardening as Sociological Practice to Promote Social Change". The interactive workshop motivated the participants to think about how community gardening can promote awareness and effect social change. The afternoon session saw Tina Uys and Johanna Zulueta present their research work for the RC 46 Paper Session I: Clinical Sociology Interventions. Tina's research, "Protecting South African Whistleblowers: Policy and Practice", suggested policies to further protect whistleblowers in South Africa, while Johanna's paper, "Empowering Migrants through Leadership and Entrepreneurship: A Case Study of the Ateneo LSE Program in

Tokyo", examined a social entrepreneurship program by a university in the Philippines educating overseas Filipinos on financial literacy and leadership.

On the second day of the conference, three undergraduate students--Sakura Imamura, Minami Nakane, and Sayaka Aono--from Soka University (Japan) gave a presentation for the RC 46 Paper Session II: Clinical Sociology Interventions. Focusing on their work as BeLive Soka members--a student group addressing sexual harassment on campus – they discussed the consent workshops they organized to inform students (mainly Japanese) of the concept of consent, as well as misunderstandings and misinterpretations regarding consent and how this was associated with instances of sexual harassment on campus. Their presentation, "Sexual Violence in Japan and its Countermovement", reported on the results of a survey they conducted among students on the effectiveness of the workshops in educating students regarding this issue. Sakura, Minami, and Sayaka are thesis advisees of RC 46 Regional Representative for Japan, Johanna Zulueta, and are scheduled to graduate in March 2020.

The last session on October 19th titled "Clinical Sociology, Citizen Science, and the Environment", with presentations from Emma Porio, Jan Fritz, and Suava Salameh, examined various clinical sociological practices across the globe. Emma's paper, "Participatory Community Risk Assessment: Citizen Science for a Gendered Climate Action", investigated the case of flood prone communities in Metro Manila (Philippines), which offered opportunities for citizen science and gendered climate action among marginalized groups. Meanwhile, Jan shared her analysis of environmental conditions in U.S. prisons. She showed how prison life is affected by environmental issues in her paper on "Environmental Justice Issues and U.S. Prisons". Capping the day was Swava's study, "Building Capacity for Citizenship and Constructing Citizen Science: Case Study from Western Poland", where she presented her ongoing work on citizen science in Western Poland.

**Business Meeting**. The RC 46 participation at the AACS was like a reunion of sorts for RC 46 and AACS members. During the business meeting, a suggestion was made to have the next RC 46 meeting in Poland. **Suava Salameh** was tasked to look into this possible venue for our meeting in 2021 as this would be more convenient for members in Europe. Meanwhile, **Emma Porio**, announced that the 2020 Asia-Pacific Sociological Association (APSA) Conference will be held in Manila on October 5-6, 2020. She will organize a couple of clinical sociology sessions within the APSA2020. We highly encourage RC 46 members to attend and present papers here, especially those from Asia. The call for abstracts will be in the January-March Newsletter.

**Please note:** As you know, the ISA determines the number of sessions that each Research Committee can host based on the number of members who are both members of the ISA and the particular RC. RC46 received 16 sessions for the Forum in Porto Alegre as we have between 100 and 149 members. We therefore require that all presenters in our programme at the Forum should be members of both the ISA and RC46 to be included in our programme. If you are presenting a co-authored paper, at least one author should be a member of both ISA and RC46.

Keep in mind that ISA membership is valid for a period of **4 years**. If you become a member now, you will still be a member at the time of the ISA World Congress in 2022. Also, ISA members register for the conference at a reduced rate.



# Transnational Identities on Okinawa's Military Bases: Invisible Armies (c: 2020, e-book version published September 27, 2019)

This book considers the role of civilian workers on U.S. bases in Okinawa, Japan and how transnational movements within East Asia during the Occupation period brought foreign workers, mostly from the Philippines, to work on these bases. Decades later, in a seeming "reproduction of base labour", returnees of both Okinawan and Philippine heritage began occupying jobs on base as United States of Japan (USFJ) employees. The book investigates the role that ethnicity, nationality, and capital play in the lives of these base employees, and at the same time examines how Japanese and Okinawan identity/ies are formed and challenged. It offers a valuable resource for those interested in Japan and Okinawa, U.S. military basing, migration, and mixed ethnicities.

# Revealing the Reality: Getting your Hands Dirty in Ethnographic Fieldwork. By Miriam Boeri

#### **MEMBER UPDATES**

Mariko Inoue is a professor of Sociology at Nara Gakuen University, Japan. She recently gave a presentation titled "Family Violence and Community Intervention in Japan" at the XIX ISA World Congress of Sociology held in Toronto, 2018. She has been engaged in clinical sociology studies and researches for about 20 years. Here she reports on the state of clinical sociology in Japan: In 1998, The Japan Sociological Society (the largest sociological association in Japan) held a symposium titled "The Conception of Clinical Sociology" at its annual meeting. This session elicited considerable attention among Japanese sociologists. Since then, the number of books and articles concerning clinical sociology has been increasing rapidly during the 2000s. Also, clinical sociologists have been working as practitioners in various areas, namely, juvenile justice, ADR (Alternative Dispute Resolution) procedure in family court and product liability center, to cite a few. Mariko has been working as a mediator at the ADR procedure in Kyoto Family Court for about 15 years. So it can't be said that Japanese sociologists are not very much familiar with clinical sociology. Last October, she has published the book titled *Family Violence and Community Intervention* (2018, Tokyo: Taga publishing company, written in Japanese)

She would like to keep in touch with all of RC46 members for the further development of Japanese Clinical Sociology.

**Natalia S. Erokhova,** along with her colleagues from Russia, Chile and Brazil participated in the International project "**Intercultural Studies in Higher Education.
