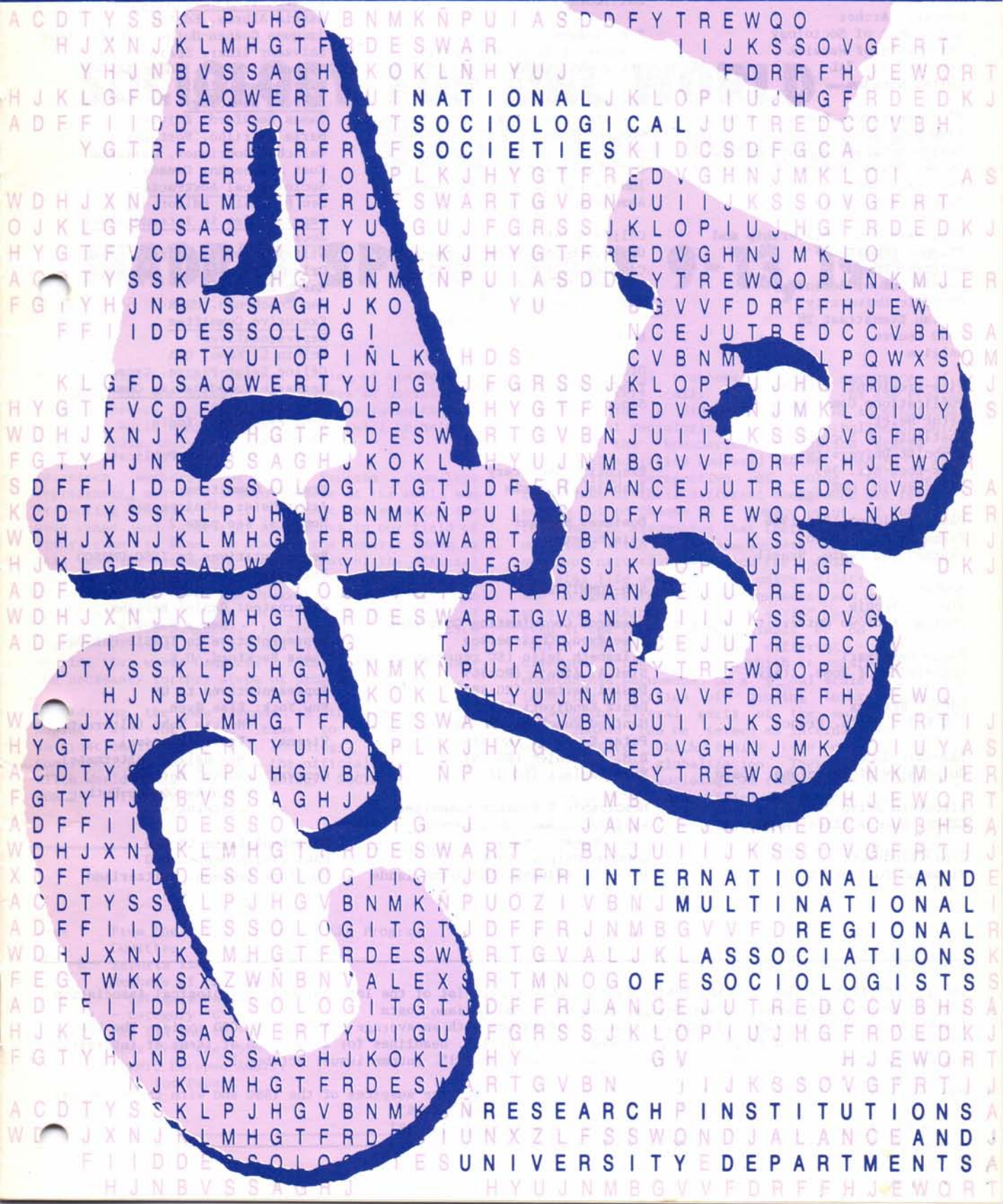

# XII WORLD CONGRESS OF SOCIOLOGY

## SOCIOLOGY FOR ONE WORLD — UNITY AND DIVERSITY

### MADRID, SPAIN, JULY 9-13, 1990

At the first constitutional meeting of the Program Committee for the XIIth World Congress of Sociology (Rome, February 1988), the decision was taken that the next World Congress of Sociology will be held in Madrid, Spain, July 9-13, 1990.

Seventeen members of the Program Committee representing nearly all main regions of the world and reflecting through their academic orientation the wide range and variety of approaches in our field of study, came to Rome to discuss the general theme as well as the structure and content of the official program. Following the guidelines provided by the ISA Executive Committee, the Program Committee was in a good position to define precisely the main theme of the next World Congress, to propose symposia topics closely related to it, and last but not least, to outline the whole Congress' format, and to envisage the necessary further steps of program preparation.

Considering the new trends in the discipline and hoping at the same time to stimulate the internationalization of sociology, the Program Committee has chosen as the official theme of the XIIth World Congress of Sociology: **SOCIOLOGY FOR ONE WORLD - UNITY AND DIVERSITY.**

Worldwide social problems and the emergence of a global society call, in view of the ISA Program Committee, for a dialogue among the international community of sociologists about the challenges which transcend the boundaries of nation states and individual societies and need to be seen in a more cosmopolitan perspective. Of course, sociologists regardless of their different background are realistic enough not to choose as a common point of departure the romantic assumption that there already exists one undivided world or global society. It would be an apparent naivité to approach the complexity of global societal life only with an universalistic conception and to ignore the contrasting ways and multitude of versions within which "the world" occurs. However, even if the focus cannot simply be on one agreed "world" but rather on the different - often even divergent - facets through which it exists, we witness nonetheless phenomena on a global scale which point into the direction of growing interdependencies between the several parts of the world, processes which indeed can be termed as internationalization, and structures which really come out of this or another kind of globalization. There can be noticed nowadays in the sociological community a growing awareness that human affairs in the late XXth

century are largely grounded on the emergence of a global society, not denying that this "world" is contradictory in itself, full of problems and tensions, yet nevertheless, it is the only one we have not only to investigate but also to strive for. The World, in its unity through diversity, is the global topic which now challenges the sociological discipline as an area of academic inquiry and practical application. An inescapable theme which certainly allows for very different perspectives, universalistic as well as pluralistic, and which excludes parochialism. Time is ripe to make fresh approaches to a new subject which brings at the same time rich promises and immense difficulties.

The Program Committee hopes that sociologists throughout the world will find the general theme attractive enough to participate in the next World Congress to be held after again in Europe after a span of 12 years. We have learnt from our experience that scientific topics are not the one and only reason to attend a congress. It is the quality of the academic program that is the measure of the success of a world congress. Therefore the Program Committee at its meeting in Rome spent several brainstorming hours selecting the appealing subthemes of six symposia, each with four sessions (total of 24 sessions) covering the general topic as much as possible. The intention was to stress thereby several major dimensions. In consequence, there will be plenty of food for thought at the Congress; for instance, about changing social, cultural and power structures in and between nation states within a context of global interdependences, about new social actors and new social identities, about new technologies, changes of work and emergent interest groups and conflicts, about moral issues in a global society, and, of course, about the global problems and the social resources of survival. The theoretical level of analysis can be best labelled by: universal discourse and diverse paradigms.

It is still too early to give exact information on what one can expect from the symposia sessions and other parts of the Congress program. A more detailed report will be published after the Executive Committee has ratified the proposals of the Rome meetings. Anyway, the program preparations are in full swing now.

The Congress' format adopted by the Program Committee is very similar to that of the last convention in New Delhi: Symposia Sessions (reduced to 24) in the mornings, 9 meetings for each Research Committee and Working Group in the afternoons, time-slots for special and ad hoc sessions late evenings. (Below you will find a provisional scheme).

One strongly requested innovation was made: the next Congress will be closed with a final Plenary Session generalizing its overriding results. While it will be for the President of the Association to address the forthcoming intellectual event at the Opening Plenary session, the Vice President in charge of the Congress program will invite to the Closing Plenary three outstanding scholars of our discipline to make an attempt of synthesising the main strands of thoughts on the selected topics.

The Program Committee left Rome with good feelings. First and foremost, the members felt indebted to the generous hospitality of the Italian colleagues. It has been a special merit of Paolo Ammassari that the Program Committee could have such a fruitful meeting in a stimulating environment. Moreover, the members really acted in a democratic way as a collective body and thereby got the feeling of an "esprit de corps" leading their work to creativity and efficiency. Finally, there was a jointly shared impression among

the members of this newly founded Committee on having opened a new door to future sociology by proposing a World Congress program which, hopefully, will find the recognition of the academic community worldwide and will lead both to further advances of our sociological knowledge, and to new answers to the most crucial questions inside and outside the discipline.

SCIENTIFIC PROGRAM OF THE CONGRESS

The scientific program of the XII World Congress of Sociology will include:

- **Presidential Session**  
to be organized by the ISA President, Margaret S. Archer (Monday 11:00-13:00);
- **Six Symposia**  
consisting of 24 sessions. These six symposia will run simultaneously from Tuesday through Friday 10:00-13:00;
- **the Research Committee's sessions**  
will be given nine time slots of two hours each 15:00 - 17:00 and 17:30 - 19:30 from Monday through Friday ending at 17:00hrs, plus a slot for a business meeting. When two or more Research Committees plan a joint session, an additional period of two hours will be allotted for that purpose in the evening 20:00-22:00 hrs.
- **Working Groups**  
will have the same time available as the Research Committees
- **Ad Hoc Groups**  
will be granted maximum of 5 sessions to be held in the evening 20:00 - 22:00 from Monday through Friday;
- **Ad Hoc Sessions and SSO** (special sessions by international organizations affiliated to the ISA) will be granted maximum 2 sessions to be held in the evening 20:00 - 22:00 from Monday through Friday;

PROCEDURES FOR SOLICITING AND ENDORSING AD HOC AND SSO SESSIONS

Special Interest Organizations (SSO) (i.e. organizations affiliated with the ISA, preferably international organizations, with at least an international content) and Ad Hoc Sessions may be allotted up to 2 sessions to be held in the evening. To qualify for a place in the program, the potential group must consist of (a) a substantial number of sociologists, (b) from several countries, (c) who have already engaged in some collaboration, and (d) whose special interest does not properly fit within the field of an established research committee.

Application forms can be obtained from the ISA Secretariat. **March 31, 1989** is the deadline for receipt of applications by the Program Committee Chairman and by the ISA Secretariat.

The Westermarck Society was founded in 1943 to promote sociological research in Finland. A special aim of the Society is to further the memory of Edward Westermarck and his scientific works.

The most visible activity of the Society are the Days of Sociology organized yearly together with the department of sociology at different universities.

Another annual activity is the Edward Westermarck Memorial Lecture organized together with the Finnish Anthropological Association.

In December 1987 the Society had 943 members, 359 of them are students.

The Board of the Society consists of 15 members, who elect the President from their ranks. The Secretary can be a member of the Board or from outside. Present officers are:

La Société Française de Sociologie s'est proposée à sa fondation, en 1962, de rassembler tous les sociologues français, d'établir des contacts avec les spécialistes de disciplines voisines et avec les utilisateurs de sciences sociales, en même temps que d'assurer la représentation des sociologues français au sein de l'Association Internationale de Sociologie.



Parmi toutes ses activités, il semble qu'au cours des dernières années ait été particulièrement privilégiée celle consistant à rendre compte, à partir d'exposés de travaux, de certaines des orientations prises effectivement par la théorie et la recherche sociologique.

Cette activité doit être évidemment maintenue dans la mesure où elle est naturellement conforme à ce qui peut être attendu d'une Société dite Société Savante. Il est toutefois apparu à l'évidence aux membres du Comité Directeur de la SFS que celle-ci ne pouvait rester indifférente au vaste mouvement de réflexion engagé sur les sciences humaines et, plus particulièrement, sur la sociologie.

Compte tenu des diverses initiatives déjà prises à l'extérieur de la Société, il a été considéré que celle-ci devait contribuer à cette réflexion, et se donner les moyens de poursuivre, de la favoriser, de façon spécifique, conformément à sa vocation.

Il a semblé aussi pertinent d'entreprendre une série d'analyses portant sur la discipline à partir de contenus de recherches précis, soit liés à un thème particulier, soit suscités par la confrontation de différentes "champs" d'intérêts à l'intérieur de la discipline, soit fondés sur une approche pluridisciplinaire. "Sociological Abstracts" offers a collection of nonevaluative abstracts which reflects the world's serial literature in sociology and related disciplines. Each of the five issues of SA contains the following:

a brief user's guide; a Table of Contents consisting of 33 major and 79 subcategories into which sociological subjects are categorized; a subject index; an author index; a source index; a supplement International Review of Publications in Sociology - consisting of a bibliography of books reviews taken from the journals abstracted in the same issue; some issues also contain Supplement(s) consisting of abstracts of congress papers.

Selection and coverage: three types of journals have been distinguished in the following order of priority: Type 1 - journals published by sociological associations, groups, faculties and institutes; and periodicals containing the word "sociology" in their title. In recent years the Vietnamese society has experienced a significant transformation from a traditional agricultural society into a modern one. To understand profoundly this long and difficult process of change, the Institute has focused its research on sociological problems posed by everyday life:

- social structure of the Vietnamese society with the emphasis on understanding the formation and growth of the cities in Vietnam, the disintegration of the traditional village system under the impact of urbanization and industrialization;
- changes in the norms and value system along with the transformation of the social structure
- impact of socio-economic and cultural factors on demographic behaviour and variables.

In addition to these projects, researchers of the Institute paid special attention to the problems of social policy, youth and their way of life, and family relations.

Along with its research activities, the Institute has been developing training programmes for other universities and colleges in Vietnam by sponsoring and conducting several courses in sociology (so far there have been no sociology departments established at the Vietnamese universities).

The Institute consist of five scientific departments: Policy and Social Structure, Personality and Way of Life, Population and Family Sociology, Theory and History of Sociology, Methodology; and two service departments: Information, Documentation and the Library

The Yugoslav Sociological Association (JUS) was established in 1954. Its founders represented a variety of social science disciplines: Oleg Mandic, Boris Zihelr, Radomir Lukic, Rudi Supek, Jozse Goricar, Veljko Korac, and the others. The first President of the Association was Oleg Mandic.

Those were the years when the Yugoslav Sociological Association as well as Yugoslav sociology started developing rapidly due to new social conditions resulting from industrialization and urbanization, economic growth (with its positive and negative consequences), self-management, expansion of higher education. In the 1970's Yugoslav sociology went through a kind of stagnation period which was then overcome in the 1980's.

At present, the JUS consists of sociological societies of the following six republics and two provinces: Bosnia and Herzegovina, Kosovo, Macedonia, Montenegro, Serbia, Slovenia, Vojvodina. The nucleus of the Association is composed of professional sociologists, but naturally its membership is open to any social science specialist. Currently it has 1650 members, most of them active in scientific institutes, universities, research institutions, or working as industrial sociologists.

Main aims and goals of the JUS, as defined in its Statutes and program of activities, are:

- development of social sciences, especially sociology, in Yugoslavia;
- promotion of sociological research and implementation of its results;
- promotion and improvement of professional qualifications of sociologists, coordination of their activities;
- dissemination of information and exchange of experience among sociologists in Yugoslavia;
- organization of scientific meetings and regular annual conferences;
- representation of Yugoslav sociology in the country and abroad as well as stimulation of international cooperation among sociologists.

The supreme body of the JUS is the Assembly which convenes once in two years. The Assembly elects a president, a vice-president and a secretary of the Executive Board. Other board members are representatives of the member Societies, an Editor of the JUS journal "Sociology", a president and two delegates of the Research Council. Everyday activities

of the Association between the meetings of the Assembly are supervised by the Executive Board and the Research Council of the JUS.

The Association's program includes activities of the following twenty sociological sections whose work is coordinated by the Research Council: methodology and statistics, urban and rural sociology, women in society, sociology of work, sociology of youth, sociology of leisure, social theory, sociology of public opinion and communication, sociology of law, sociology of religion, sociology of culture, social structure and mobility, social movements, sociology of social development and social planning, sociology of sport, social pathology, sociology of organization, sociology of migration, interdisciplinary cooperation.

The JUS organizes, always in a different place, annual three-day scientific meetings whose themes are chosen by the Research Council and the membership. The attendance at these meetings ranges from 150 to 200 scholars who participate in the work of as many sociological sections as they wish.

Empirical research activities have been renewed in the course of the last two years thanks to the creation of the Consortium of Institutes of Social Sciences. The Consortium was founded in March 1985 by the Institute for Social Sciences of the Belgrade University, Institute for Social Research of the Zagreb University, and the Institute of Sociology of the Ljubljana University. The Consortium unites 35 Yugoslav scientific institutions and about 300 scientists and specialists. Currently a macroproject on the structure of the Yugoslav society is carried out by the Consortium. So far, four publications were sponsored by the Consortium: "Property" by Mladica Gams, "Heading for an Exclusive Society" by Mladen Ladic, "Social Inequalities" by a group of authors, and a paper on workers' strikes published in a journal "Sociological Review" (3/1987).

The themes of some recent conferences organized or/and hosted by the JUS in 1987 and 1988 were: Intelligence and Socialism; Development of the Yugoslav Sociology; Civil Society, State, Nation - commemorating the 200th anniversary of the French Revolution; The Future of Socialism: theories, practice, movements; Social Stratification in Slovenian/Yugoslav Society; Social Movements as the Force of Dealienation (jointly with the ISA Research Committees on Participation, Workers' Control and Self-Management, and Alienation Theory and Research); Social Stratification and Mobility in Comparative Perspective; Methodology in Social Sciences; Research of Public Opinion; Sociological Aspects of Education (Sociological Summer School); Cross-cultural and International Research: Theory, Methods, Projects, Organization (ISA Research Council); Theoretical and Methodological Problems of Structure Studies of a Socialist Society; Theoretical Pluralism in Sociology; Class Structure of the Contemporary Yugoslav Society; Prospects and Perspectives of the Yugoslav Society Development at the Turn of the Century".

"Sociological Review" - published quarterly by the Croatia Sociological Society and the Department of Sociology of the Faculty of Philosophy, and the Institute for Social Research of the University of Zagreb.

"JUS-Information" - published three times a year by the JUS, contains news about activities, research program, JUS official reports and proceedings.

## THE ISA AND THE UN

---

---

On December 9 and 10, 1987, on the occasion of the commemoration of Human Rights Day, a consultation with NGOs (non-governmental organizations) collaborating with the UN was organised jointly at the United Nations Headquarters in Geneva by the Office of the Director-General, the Information Service and the Center for Human Rights. Aside from presentations and ceremonies focussing on activities in the field of Human Rights, the consultation was devoted to a general examination of the cooperation between NGOs and the UN in the light of recent development as well as forthcoming events in various areas of activities. Particularly helpful to NGO representatives were guidelines provided by Ms. Raymonde Martineau, NGO Liaison Officer, on the Consultative process, and information supplied by Ms. Thérèse Gastaut, Director of UNOG Information Services, on facilities offered to NGOs. The ISA was represented by Dr Jacques Coenen-Huther (University of Geneva) who stressed the need for periodical exchange of information between the ISA and the various departments of the UN, with the aim of promoting research and studies at the international level. It is hoped that this meeting will lead to more diversified exchanges of views in the future.

Directory of European Training Institutions in the fields of Bilateral and Multilateral Diplomacy, Public Administration and Management, Economic and Social Development, has been recently published by the United Nations Institute for Training and Research (UNITAR). This publication aims at being a useful and practical source of reference. One of its objectives is to identify those institutions with which the various bodies of the United Nations system could cooperate more closely and regularly in the future. There is no doubt that the Directory in its present form will contribute to better identify avenues of co-operation. One can hope, however, that further editions will include more collective members of the ISA. The ISA representative at the UN Office in Geneva, Dr Jacques Coenen-Huther, could be instrumental in establishing a procedure to that effect.

### THE HUMAN RESPONSE TO GLOBAL CHANGE PROGRAMME

---

---

The Human Response to Global Change Programme (HRGCP) is a new international initiative, designed so as to analyse, understand, and evaluate human activities in the face of the rapid changes - specially environmental - occurring across the face of the earth.

The HRGCP has been designed so as to focus on the further - and perhaps more important - element in this complex array of global changes: the human activities which are in large part generating these changes.

The HRGCP will encourage and facilitate the study, management, and interpretation of the human causes of - and the options for - human response to the unprecedented stresses inherent in the current global situation. It proposes to initiate an innovatory, interdisciplinary network of scholars, social science researchers, and those actively involved in managing human activities. This network will operate from a global perspective, but will concern itself with the local scale where many of today's global problems both originate and have their ultimate impacts.

The Programme will carry out its research through the decade of the 1990's and beyond. It will identify and promote research into the areas of global change which would most benefit from a better understanding of the social forces at work in their shaping and alteration. Many of the goals of the HRGCP are shared by the International Geosphere-Biosphere Programme launched by the International Council of Scientific Unions in 1986.

#### Progress to Date:

An Ad Hoc Preparatory meeting for HRGCP was held in Toronto, Canada in June 1987, at which time the International Federation of Institutes for Advanced Studies, the International Social Science Council, and the United Nations University, were designated as an Interim Steering Committee for the Programme. A Prospectus, entitled "Human Response to Global Change: A Prospectus for an International Programme" was prepared and sent out to interested parties and prospective donors.

Further meetings of potential participants and organisers were held through the fall and winter 1987. As a result of these meetings, a consensus was reached that the Steering Committee and its Secretariat will appoint a Scientific Committee for HRGCP, to plan and propose and screen scientific projects for the Programme. Specialised study groups, project teams, and tasks forces will be established in due course, under the direction of the Scientific Committee and with the advice of the Steering Committee and the Committee of Donors.

The process of developing public awareness and support for the Programme is now underway, and funding from possible donors and sponsors is now being sought.

In addition, it is expected that the initial steps will be taken in the organisation of Working Groups on special themes for the HRGCP. The interim thematic structure of the HRGCP is as follows:

1. Environmental History / Social History
2. Processes and Institutions
3. Methodologies and Values

Within this general thematic approach, more specific themes will be addressed, including such topics as global risk assessment, the analysis of complex systems, international policy conflict and cooperation, and the human response to the pending global climate warming.

ISSC/UNESCO RESEARCH STUDY GRANTS
