En présence du recteur, M. Maurice Brossard, et du président de l'Association internationale de Sociologie, M. Tom Bottomore, avait lieu, le lundi 21 octobre, au pavillon Read, l'ouverture officielle du Secrétariat de l'Association internationale de Sociologie. Le Secrétariat a été transféré de l'Université de Millan à l'Université du Québec à Montréal pour une période de quatre ans.

L'UQAM a été choisie par le comité exécutif de l'Association comme siège du Secrétariat, en même temps qu'étaient élus comme secrétaire-exécutif de cet crganisme, Mme Céline St-Pierre, rofesseur au département de sociologie de l'UQAM, et comme secrétaire-exécutif adjoint, M. Kurt Jonassohn, du département de sociologie de l'Université Concordia (antérieurement Sir George Williams).

L'Association internationale de Sociologie a été fondée en 1949 à Oslo, sous les auspices de l'UNESCO, dans le but de développer les contacts entre sociologues des divers continents, de stimuler la recherche à l'échelle internationale et de diffuser l'information reliée aux activités des sociologues dans la recherche et l'enseignement.

L'Association est composée de membres nationaux: 46 pays sont présentement membres du Conseil de l'Association internationale de Sociologie, lequel est l'instance décisionnelle de l'Association, avec le Comité exécutif. Les représentants du Canada au sein du Conseil sont: MM. Paul Bélanger, professeur de sociologie à l'Université Laval, et Guy Rocher, professeur de sociologie à l'Université de Montréal. De plus, l'Association regroupe des instituts de recherches et des départements de sociologie, des associations régionales, internationales et multi-nationales, et des membres individuels (au nombre de 2,500 à l'heure actuelle).

Les activités de l'Association se regroupent autour de la publication d'une revue, «La Sociologie contemporaine», d'un journal d'information, «Newsletter», et de l'organisation de réunions, colloques et congrès internationaux. Le dernier congrès mondial de sociologie s'est tenu à Toronto, du 19 au 24 août 1974 et il a réuni des représentants de

plus de soixante-dix pays. Le prochain congrès aura lieu en pays. Le prochain congrès aura 1978 et l'endroit reste à déterminer.

#### REPORT ON THE VIII WORLD CONGRESS

It had been decided in Varna to accept the invitation of the Canadian Sociology and Anthropology Association to hold the next World Congress in Canada. This decision generated intensive activity on the part of many colleagues, working on several committees, to prepare for this event. The Program Task Force met several times and the final Congress program listed 293 sessions. The Travel Grants Committee raised and distributed over \$38,000; a separate report on the distribution of these funds will be found below. The Canadian Local Arrangements had by far the largest task and organized itself into several sub-committees under the overall chairmanship of Harry Nishio of the University of Toronto.

The Canadian Association and the University of Toronto were the joint hosts of the World Congress. Due to the large number of sessions and the large number of delegates expected, the location of meetings had to be distributed between the campus and the hotel. This did create a transportation problem because of the unforeseen strike which left private cars and taxis as the only available transport between the two sites. Inevitably, a number of other problems occurred. But on the whole, the Congress seems to have been successful. Many delegates expressed their satisfaction with both the arrangements and the contents of the Congress.

No final count is available, but it is estimated that well over 3,000 delegates attended the Congress. Although about one half of them came from North America, 80 countries were represented. We have a computer print-out for those who registered up to Wednesday and it contains 2,942 names. Delegates were asked to put their nationality on the registration form and the following table is based on the answers to this question, not on addresses. Not included are 272 delegates who did not answer this question.

#### REPORT ON THE MEETINGS OF THE EXECUTIVE COMMITTEE

CLAC : The Executive Committee unanimously praised the efforts of the Canadian Local Arrangements under the chairmanship of Professor Harry Nishio.

Publications:

The Executive Committee unanimously decided to discontinue the publication of the Transactions, and to publish instead a series of topical volumes based on Congress papers and additional materials so that the series may become a continuing one. It was also decided that the series be published by Sage Publications. (Since then the ISA has signed a contract with Sage Publications for this series, to be known as the ISA MONOGRAPH SERIES.)

Membership: The applications of the Ghana Sociological
Association and of the Egyptian Sociological
Association were accepted in Category A.
Several other applications were discussed.
Many were found incomplete; some were given temporary observer status. The Executive Committee decided unanimously to review the status of members in categories A, B and C in accordance with the criteria of ongoing activities and payment of dues, as specified in the Statutes. The Membership and Finance Committee will make recommendations to the next meeting of the Executive Committee in 1975. The next issue of the Newsletter will appear after this meeting and will contain an updated listing of all members in these three categories.

Through the initiative of Professor Scheuch, a meeting of Social Science Research Institutes (category C) was organized at which 19 such organizations were represented. A report on this meeting was presented, suggesting ways of furthering international cooperation among them. After some discussion, this report was passed on to the Finance and Membership Committee which is to study it and make recommendations to the next Executive Committee meeting.

#### REPORT ON: THE MEETINGS OF THE ISA COUNCIL

Communication :It was agreed that more communication between the Council members and the Secretariat is needed to allow Council to play a more active role. The Secretariat promised to make every effort in that direction.

Congresses: A proposal to either lengthen the period between World Congresses, or to abolish them, was discussed. The consensus of Council was in favour of maintaining the present arrangements, however. Council members preferred to encourage the holding of regional meetings and of joint meetings of several related Research Committees in addition to, rather than instead of, World Congresses.

Council also agreed to defer the decision on the location and theme of the next World Congress to the meeting of the Executive Committee in 1975.

Proposed Amendments to the Statutes:

While five amendments had been proposed, only two of these were accepted. The first of these makes it now possible for individual members to join more than two Research Committees. The second one limits an individual member to serving on the Board of no more than two Research Committees, and to being a President, Vice-President or Secretary of no more than one Research Committee.

Voting: Council also asked the Executive Committee to review the voting procedures and to make recommendations for changes to the Council. The aim of these recommendations should be to ensure greater regional representation and increased participation by women sociologists.

<u>Chile</u>: The following motion on the issue of academic freedom, with special reference to Chile, was proposed by Prof. Himmelstrand and adopted by the Council:

The International Sociological Association, meeting at its VIIIth World Congress in Toronto, Canada, from August 19-24, 1974, hereby reiterates its appeal to UNESCO to protest the situation of violence existing in Chile since the brutal installation of the book-burning fascist junta on September 11, 1973, and thereby declares:

Whereas numerous independent international commissions of scientists, jurists, churchmen and others have reported the junta's total violation of the United Nations' Declaration of Human Rights through summary executions, arbitrary mass arrests, lengthy detentions without trial, and torture;

Whereas UNESCO's Latin American School of Social Sciences in Santiago (FLACSO), the Latin American Council of Social Sciences (CLASCO), the XIth Latin American Congress of Sociology at its 1974 meeting, and the International Institute of Sociology at its meeting in Algiers have all denounced the systematic repression of sociology and related disciplines in Chile;

We, as sociologists, want to add our voices to this general condemnation of the state of repression existing in that country; more specifically, we denounce the appointment of military rectors to all Chilean Universities, the arbitrary expulsion of students and faculty, the arbitrary closure of departments and institutes of social science, the military's reorganization of established curricula, the censorship of research and publications, and the expurgation of all University libraries.

We are alarmed not only with the increasing repression of academic freedom, but also with the physical safety and indeed the very existence of our profession in Chile, whose governmental authorities seem to fear the public service and the popular enlightenment offered by our science. Unfortunately, this tragic situation exists in other Latin American countries as well.

We therefore demand:

that CLODOMIRO ALMEIDA, ex-Director of the School of Sociology, University of Chile, and former Foreign Minister, be immediately released from a year's detention in inhuman conditions and without trial:

and that all other detained and exiled colleagues and their students be reinstated without further persecution.

#### REPORT FROM THE RESEARCH COMMITTEES

During the period between the VIIth and VIIIth World Congress of Sociology, the ISA Research Committees sponsored 34 general meetings, of which 5 took place in 1971, 14 in 1972, 15 in 1973 and early 1974. Apart from these general meetings, a large number of regional meetings were sponsored by ISA Research Committees, mainly in North America, Western and Eastern Europe. In particular, the 34 meetings sponsored by the ISA Research Committees show the following geographical breakdown: 18 in Western Europe, 4 in North America, 10 in Eastern Europe (including 2 meetings in Yugoslavia), 2 in Asia. During the VIIIth World Congress of Sociology, 31 Research Committees organized meetings (with the exception of the Research Committee on Urban Sociology) for the four afternoons of Monday, Tuesday, Wednesday, and Friday, for a total of 133 afternoon sessions and about 500 hours of scientific discussion.

The Research Committee on Urban Sociology has been dissolved. Two new Research Committees have been accepted at the Cologne meeting in 1973: Research Committee on Sex Roles and Society, and Research Committee on Logical Methodology of Sociology.

A large number of proposals for new Research Committees have been received. They will be studied by the Research Coordinating Committee, who will make their recommendations to the Executive Committee for a final decision at the 1975 meeting.

The Research Council recommended that the representation of the Research Committees into the Executive Committee be increased from 4 to 6.

# Activities during the VIIIth Congress in Toronto:

The program of the sessions has been realized with changes owing to the absence of certain participants. The reduced number of papers made it possible to devote more time to discussion. Several important theoretical and methodological problems were raised, namely:

- Contradictory approaches to education regarded as a system of transmitting knowledge and moulding the personality or rather as a means of setting conditions for free development of personality and spontaneous acquiring of knowledge.
- The problem of the expansion of education and of the program and level of instruction. (ii)

- The problem of instrumental versus uninstrumental functions of education, especially under the conditions of life-long education.
- The relation between social structure and various school systems as reflected (iv) in comparative data from the countries representing different levels of eco-nomic development and different social systems.
- Finally the "background assumptions" and different models of the sociology (v) of education have been made an object of penetrating discussion.

# Future Activities:

We shall develop over these next months and years we shall develop over these heat months and years four types of activities, each pointing to the next World Congress of the ISA. First, we shall hold meetings and seminars at different locations, each in conjunction with activities consonant with the interests of the Committee. For example, the Van Cle organization of Brussels will be hosting a conference on a theme devoted to leisure; the annual session on youth and leisure in Dubrovnik, Yugoslavia will be the scene of another meeting; while Hamburg-Luneburg will be the setting for a third meeting in 1975. Announcements on these will follow shortly.

Second, the Committee will encourage publication of research reports and developments in theory in leisure sociology through the good offices of the European Centre for Leisure and Education in Prague which publishes the journal <u>Society and Leisure</u>. We shall continue the policy of being the editorial consultant to the Centre and hope to explore some new interests for publication. Above all we want to make it possible for a wider participation by leisure sociologists all over the world.

Third, we intend to refine and expand the building of a central retrieval system for documentation in leisure. We are particularly excited about the new relationship established at Toronto with SIRLS (Information Retrieval System for Leisure and Sport Sociology) of the University of Waterloo, Waterloo, Canada. This will enable us to have an efficient means to obtain the relevant literature related to a research interest.

Fourth, we shall sponsor and encourage specific research projects. The comparative study on leisure continues. The initial part of this four-year period will concentrate on family-related leisure consumption. Joffre Dumazedier is the director of this project.

We also will seek to expand the number of Institutes and Centers related together within the framework of the Committee, especially emphasizing as wide a geographical representation as we can. The interchange of these organisms is vital to the development of the field.

Finally, we shall concentrate on building the active membership, all the while seeking to improve the financial base of the Committee, which will enable the furtherance of international meetings of exchange and the development of research and subsequent publication.

Our goals are ambitious. However, the quality of the new Board of Directors is extremely high and the calibre of the total  ${\sf T}$ membership is enormously impressive. Leisure sociology is an idea whose time has come. The future of our work together is tremendously positive and the promises of creative scholarship are impressive. Bon courage et bon voyage.

#### Newsletter plans:

New plans for the Leisure Newsletter were announced at the Toronto meeting. It will continue to be prepared at the Tampa center, edited by Max Kaplan, and issued quarterly. However, the University of Three Rivers, Quebec, Canada, has agreed to duplicate and distribute this official organ of the team. As in the past, the team members of the various countries will duplicate and distribute copies in their respective region of the world.

A second decision was made to establish a subscription fee of \$1. per year, to begin with the next issue.

In between successive World Congresses, the executive explored possibilities of sponsoring international projects in order to do justice to the stated primary goal of stimulating and advancing high quality academic research in the sociology of religion with particular emphasis on international comparisons. Finance has always proved to be the spoiler of these endeavours, although in 1972 Western Religion ( a country-by-country sociological enquiry)

was published by Mouton in The Hague. The secretary intimated that he hoped to concentrate on a similar project in the next 4 years; this time however, he hoped to be able to utilize a better theoretical frame of reference, to have better translations, to do more incisive editorial work, provide more uniformity and clarity in the use of statistics and more comprehensive comparisons.

In the early seventies there was a tendency on the part of the committee to recruit membership on the basis of national representation, level of scholarship and interest in international comparisons. However, in the last two years research committees have tended to admit everybody whom ISA headquarters had accepted as a member. This more liberal policy avoided the embarrassment of members being acceptable to ISA but not to some of its Research Committees. There seemed to be consensus that the policy of the last few years should also be followed in the next 4-year period. It was reported that the Sociology of Religion Research Committee was one of the bigger ones in the ISA. According to the ISA administration, there are now 53 members.

#### ADMINISTRATIVE CHANGE CONCERNING MEMBERSHIP IN RESEARCH COMMITTEES:

Up to the present, the Secretariat has collected the membership fees for the Research Committees. With the increasing number of Research Committees, this has become a very complicated procedure. For example, if a Research Committee Board decided not to accept a member, then the Secretariat had to refund the fee to the applicant. In many cases, the postage and the bank charges for this processing exceeded the amount of the fee.

As of 1975, a new system will be used for dealing with Research Committee memberships. The ISA membership form will contain a list of Research Committees; applicants will check those committees that they wish to become members of; the Secretariat will forward their names to the respective Research Committees; but no money will be required at this stage.

After the Board of a Research Committee has decided which applicants to accept for membership, its secretary will communicate directly with the applicant. If he/she has been accepted, he/she will be billed for the membership fee directly by each Research Committee.

REPORT ON THE SYMPOSIUM ON SOCIOLOGY AND SOCIAL DEVELOP-MENT IN ASIA

Asian Regional Conference of Sociology. Report submitted by Prof. Kiyomi Morioka.

#### 1. Introduction

The symposium on Sociology and Social Development in Asia was organized jointly by the Japan Sociological Society and the Japanese National Commission for UNESCO under the joint sponsorship of the ISA and UNESCO. It took place mainly at Akasaka Prince Hotel, Tokyo, over a period of 7 days from October 16 to 22, 1973, with the participation of 65 sociologists predominantly from countries in Asia. The aim of the symposium was to promote regional contact and cooperation among Asian sociologists.

#### 2. Organization of Sessions

The symposium consisted of 4 topics for reports and discussions. Allocation of sessions to each topic and the number of papers presented at each session were as follows:

About half of the total (21) papers were circulated to participants in advance. The rest of papers were available when the attendants arrived in Tokyo. Participants were expected to have read most of the papers beforehand.

Each session was scheduled to last for 2½ or 3 hours including a 20-minute intermission. Reporters were instructed to give only the gist of their papers in 10 minutes or so, and after all the presentations were completed a number of pre-nominated discussants made comments. The remainder of the session was open to discussion from the floor.

One Hong Kong and an additional Thai representative who were allocated travel funds could not attend the conference because of illness and internal political unrest respectively.

The Organizing Committee for the Symposium (Prof. T. Fukutake, Chairman) extended an invitation also to Mongolia, the People's Republic of China, Pakistan and the USSR. The People's Republic of China (State Council) and Pakistan (Ministry of Education) indicated the non-availability of representatives, and Mongolia (Mongolian Sociological Society) and the USSR (Soviet Sociological Association) failed to respond to the invitation. The Committee was unable to invite colleagues in Taiwan because the conference was held under the Unesco participation program.

All Asian regular participants except those from Japan were allocated travel assistance from the Unesco Participation Program (7 persons), Unesco subsidies to the University of Tokyo (5), the Asia Foundation (2) and the Japan Foundation (1). All regular participants from countries in Asia and on the rim of the Pacific Ocean (except one from Canada) received aid for living expenses from the Japanese National Commission for Unesco.

#### 4. Outcome

1) Preparatory Committee for the next regional conference.

It was agreed upon at the session for Topic IV that special efforts should be made by the Preparatory Committee consisting of presidents or representatives of national sociological societies or local sociological study groups to explore the possibility of holding the next regional conference of sociology in Singapore. Profs. Evers (Singapore) and Ali (Malaysia) were chosen to lead the Committee.

2) Publication of the symposium proceedings.

Symposium papers will be published in book form by the University of Tokyo Press in September 1974, under the joint editorship of T. Fukutake and K. Morioka (pp.464, \$26.50).

#### 5. Evaluation

- The present symposium is perhaps an epoch-making event in the development of regional contact and cooperation among sociologists in Asia.
- 2) Although the number of Asian countries represented in the symposium was only ten, it is obvious that almost all Asian countries where sociology is an established discipline were represented. The problem of geographical representation will be improved in future by the following four strategies:
  - (a) Accumulation of information about names, addresses, nature (general or special) and officers of sociological study groups, and names, addresses and interest areas of sociologists in Asia.
  - (b) Increase of financial assistance (travel and stay) to qualified attendants.
  - (c) Rotating location of the regional conference.
  - (d) Repeated holding of the regional conference.

REPORT ON THE SECOND NATIONAL SOCIOLOGICAL CONGRESS OF THE BULGARIAN SOCIOLOGICAL ASSOCIATION

April 16-18, 1974 in Sofia. Submitted by Dr. Oshavkov.

122 delegates and about 250 guests took part. At the formal opening, Prof. J. Oshavkov, the president of the Bulgarian Sociological Association addressed the participants.

The main theme was *The Sociological Structure of the Contemporary Bulgarian Society*. The topic was discussed at two Plenary sessions and at the sessions of the 13 sections, which actually play the same role and have the same activities as the Research Committees of the ISA.

Some amendments in the Statutes were made by the meeting. The amendments are especially in the activity and the organizing of the sections.

Resolution about the future activity of the Bulgarian Sociological Association was accepted and taken for the next 4 years.

A new council of the BSA, including 53 members as well as a Supervising Commission of 5 members were elected. At its first session, the council elected a new Executive Committee as follows:

MOTIONS CONCERNING THE BOYCOTT OF SIMON FRASER UNIVERSITY PASSED BY THE EXECUTIVE COMMITTEE AND THE ANNUAL GENERAL MEETING OF THE CANADIAN SOCIOLOGY AND ANTHROPOLOGY ASSOCIATION

#### First Motion:

"The Executive Committee of the CSAA strongly reaffirms its position on the censure and boycott of Sim Fraser University. Our view is that the only just resolution of the case would involve the reinstatement of the seven faculty members who were improperly treated. The reasons for this position are stated in the accompanying document, 'Basis of the CSAA Position'. We resolve to circulate this reaffirmation of our position widely, not only in the Canadian academic community but also in the U.S.,

Britain, Australia and New Zealand, as well as to submit in the Newsletter of the International Sociological Association".

Second Motion:

"WHEREAS there are reports of extensive blacklisting of former Simon Fraser University faculty members based on their political views and associations by academics remaining at SFU, and

WHEREAS political blacklisting contradicts the very essence of academic values and the academic spirit,

BE IT RESOLVED that the President of the Canadian Sociology and Anthropology Association is mandated to conduct an investigation into the circumstances of alleged blacklisting involving former Simon Fraser University faculty members and to report and recommend appropriate action on this matter during the coming academic year, with a view to formal action by the Association no later than the Annual Meeting of 1975."
