1. *President's Column*

Our 2012 seminar will be held in Belgium and will focus on divorce and its consequences on new family forms. We have already sent out some information and you will find a preliminary description of this seminar in this Gazette. This seminar follows our tradition of seminars organized by members of our research committee. It encourages activities and help young researchers to settle in the international community in a smooth way.

We had a discussion in the board following this tradition as in the same year the interim meeting of the ISA will also take place. Originally intended as an exchange between the RCs of general problems in international sociology and coordination, it turned out to be a world congress in between the big ones. World congresses might broaden weak ties but weaken strong ties, both necessary for setting up global research networks and exchange. We thought this time a huge congress every four years is enough. Nevertheless if ISA follows their strategic lines, they might establish big interim meetings and we would have to discuss our strategy at the next world congress in Japan.

Mentioning Japan brings me to another issue. We felt with our Japanese colleagues who suffered from the incident in Fukushima. The web pages of the universities in Japan are filled with concerns and all efforts to comfort foreign students, guest professors and visitors. We will have a seminar in September in Kyoto and we encouraged Emiko Ochiai to proceed. Kyoto is far away and safe from radiation, as independent internet pages suggest. The program has been finalized and we are looking forward to an inspiring seminar. Thanks to Emiko for organizing this seminar during difficult times.

Looking forward to meet some of you in Japan.

2. *Honorary President's Column*

Long time ago, meaning about sixty years ago, the CFR was inaugurated and very fast CFR became one of the most lively committees of the International Sociological Association, and number 6 from the start of the ISA. We have kept the record of being one of the biggest and most active committees.

At the beginning of the 1960s a renewed feminist movement came and in the circles of the CFR it was named the sex role movement. After some years the Sex Role Committee was accepted by the ISA and in 1974 at the World Congress in Toronto this committee was inaugurated. I wouldn't claim that there was any kind of break out from the CFR but some of us were supportive and even instrumental for the establishment of the Sex Role Committee, which later changed name to Women in Society, number 32.

The CFR has never been very concerned about youngsters even if we have organized sessions on youthhood, for example in Munich in 1987, *Family and Youth*. But already previously the Sociology of Youth Committee became one of the committees of the ISA, number 34.

To my understanding both sex roles (as they were called at that time) and youth belonged to the field of family studies even if we were not so much concerned about these areas. The same is true for childhood; in 1979 the CFR had a seminar in Helsinki on *Family and Child*. Later the committee on Sociology of Childhood came, which also has become an official committee of the ISA as number 53. As Floyd Martinson showed many years by studying 20 text books in family sociology, children were absent or if they were mentioned they were either connected to fertility or to problems. Ageing is another area traditionally a part of family studies. Early on a separate committee was established in the ISA, i.e number 11.

There are probably more committees with clear connections to family studies and we will probably face more to come. One never knows how many committees there is a need for.

When the ISA had its world congress in Uppsala in 1978 the Mayer of Uppsala in her welcome speech among other nice things said something to the effect that she had believed that sociology was sociology. But when she looked into the program of the world congress she found that there were more than 50 sociologies!

How many are there need for and how many will be active and lively?

NEW FAMILY FORMS FOLLOWING DIVORCE: CONSEQUENCES IN /ON POSTMODERN SOCIETY

K.U.Leuven, September 12-15, 2012

Aim

For the majority of the population, family has been and continues to be the most fundamental of social contexts. One that shapes behaviour and beliefs, and affiliations and vocations. As such the institution of the family serves as the fulcrum for research on multitude of significant social and demographic issues. The preceding three decades have been characterized by intertwined transitions in demographic regimes and family structures. These transitions are both cause and consequence of the dramatic increase in separation and divorce.

The aim of the CFR-seminar 2012 is to shed light on the specific dimensions of these changes and the mechanisms behind them. Participants are expected to build bridges between theoretical issues, (new) methodological approaches and empirical results. Inspiring strategies may be:

- (1) Describe the features of contemporary family formation following divorce;
- (2) Illuminate the mechanisms underpinning these processes with the most appropriate methods for modelling longitudinal data, to study individual change;
- (3) Elaborate the opportunities for and advantages of comparative analysis, based on parallel designs, to study social change;
- (4) Develop an agenda for the identification and investigation of the most important substantive questions in the field of sociology of divorce, questions that will resonant with a number of contemporary issues (e.g. social mobility, kin relations, intergenerational transmission).

Possible themes

- ✚ Divorce as a macro-social catalyst: the ambivalent position of the family in postmodern times
- ✚ Post-divorce family formation
- ✚ Beyond the exes: divorce consequences for children, stepchildren, stepparents and grandparents
- ✚ The chameleon family: new parenting styles after divorce
- ✚ The juridical interplay between divorce and society: family and divorce policies
- ✚ Researching the family: methodological challenges and renewals
- ✚ The Leuven 1981 CFR conference revisited: review papers

The number of participants is limited to 60.

Complete all information. Please note: The last two entries require you to enter a 500-800 word summary of your presentation and biographical sketch. Please have this information ready in a word document, then copy and paste your information into the fields provided on the online form as you will not be able to edit your information in the fields. Proposals for reporting primary research symposiums and research posters should include: objective or problem, methodology (sample, measurement, procedure or design, type of analysis), results, and conclusions. Proposals are limited to 5 presenters.

SESSION DESCRIPTIONS:

Content: Workshops should be relevant to the audience and provide practical knowledge and application.

Format: 90 minute symposiums which include three (3) presentations and a discussant.

Format: During a 45 minute round table session, scholars will briefly present their findings to a small group of rotating conference participants.

Content: Brief presentations will include updates on effective parenting strategies, informational research, and special content areas relevant to the field of parent education, parenting, and family studies.

“Meet the Scholars” Research Posters: (Original Research and Graduate Student Completed Research)

Format: During a 45 minute session, scholars will briefly present their findings to small groups of rotating conference participants. Posters will be on display for the day.

Content: Meet the Scholars will include a detailed table-top display of completed research. Undergraduate and graduate student research is encouraged. Display specifications will be available.

- ✚ Graduate and undergraduate awards are available for the best poster presentation.
- ✚ Graduate Students: Graduate students can present a detailed table-top display of completed research.
- ✚ Undergraduate Students: Undergraduate students can present a detailed table-top display of a literature review.

Call for papers

Submissions to the journal are invited from subject areas across the social sciences and related life course disciplines, for example, sociology, social policy, social work, childhood studies, demography, youth studies, family studies, gender studies, ageing and gerontology, health and social care, education, psychology, social history, socio-legal studies, politics, criminology, and psycho-social studies. Papers will be expected to have relevance to academic, policy and practitioner audiences, enabling a wide range of perspectives to be brought together in one place to foster innovation and development within disciplines and advance interdisciplinary research and practice.

Articles should be between 5,000 and 8,000 words (including references) in length. An abstract of not more than 150 words should be included. All articles are refereed to assess their suitability for publication.

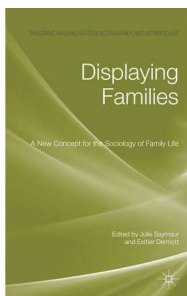
