ISSA 2014 will be held at Peking University

Founded in 1898, and originally known as the Imperial University of Peking, it was the first national university covering comprehensive disciplines. It played a pioneering role in the course of China's modernization. Peking University is located in the Haidian district of Beijing, the capital city of China. The district is concentrated with many well-known colleges and universities, in the western suburb of the city. The university campus

is the former site of the Qing Dynasty royal gardens and it retains traditional Chinese-style landscaping including traditional houses, gardens, pagodas as well as many notable historical buildings and structures. The campus site is also situated near the Summer Palace, the Yuan Ming Yuan Imperial Garden and the Fragrant Hill, famous tourist sites of Beijing. In addition, Peking University is also adjacent to Zhongguancun, China's Silicon Valley, and thus enjoys convenience of life - economically, technologically and socially.

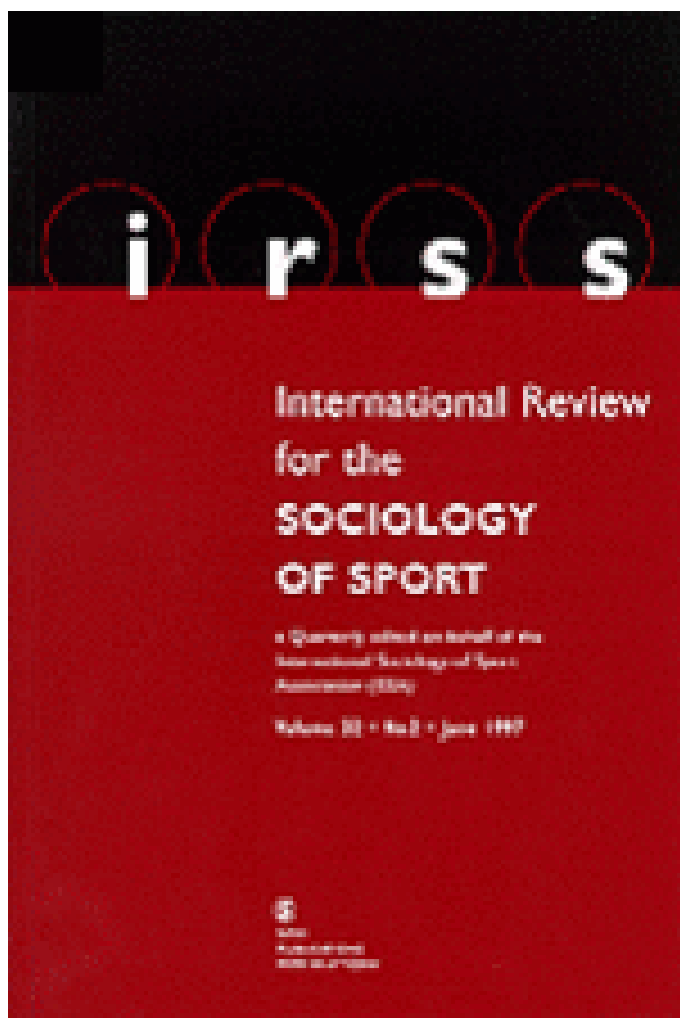
The International Sociology of Sport Association will consider applications to fund Special Initiatives which meet the mission of the association.

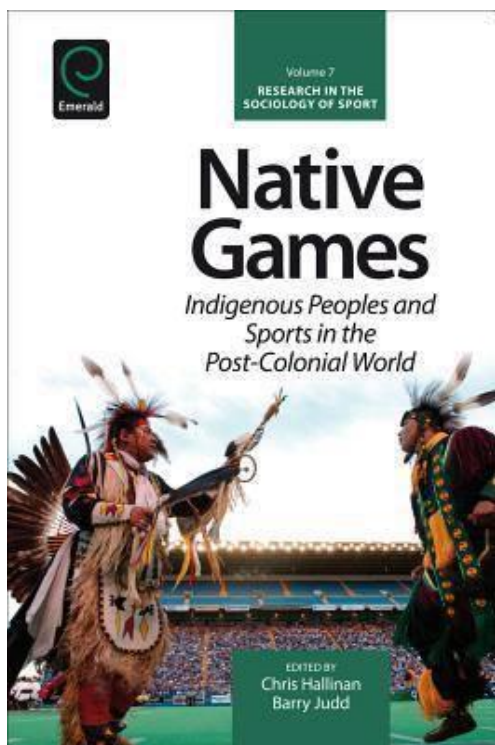

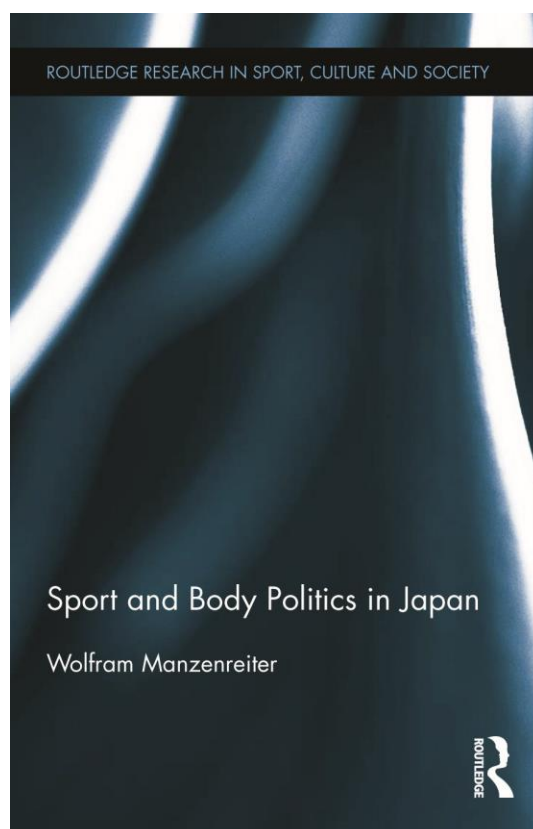

Sport and Body Politics in Japan by Wolfram Manzenreiter

There is more to Japanese sport than sumo, karate and baseball. This study of social sport in Japan pursues a comprehensive approach towards sport as a distinctive cultural sphere at the intersection of body culture, political economy, and cultural globalization. Bridging the gap between Bourdieu and Foucault, it explains the significance of the body as a field of action and a topic of discourse in molding subject and society in modern Japan. More specifically, it provides answers to questions such as how and to what purposes are politics of the body articulated in Japan, particularly in the realm of sport? What is the agenda of state actors that develop politics aiming at the body, and to what degree are political and societal objectives impacted by commercial and non-political actors? How are political decisions on the allocation of resources made, and what are their consequences for sporting opportunities and practices of the body in general? Without neglecting the significance of sport spectatorship, this study takes a particular angle by looking at sport as a field of practice, pain and pleasure.

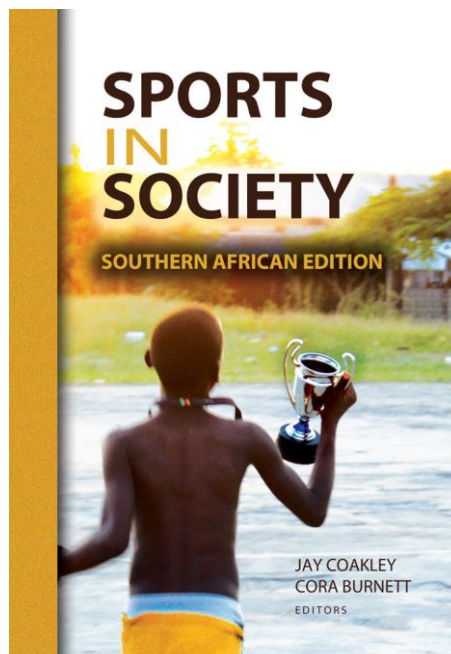

Sport and Physical Activities as Psycho-Social Interventions will be published in May 2014.

It is a practical handbook, aimed at humanitarian aid workers, is due to be released in May 2014. It will include background information on psychosocial intervention as well as different guidelines on how to better implement sport and physical activities in practice (activity cards will be available). This handbook, which has been developed in cooperation with the Red Cross and

Physical Activity, Workplace Wellbeing and Bridging the Policy-Practice Gap: A Study of Everton Football Club

This collaborative project between the Department of Sport and Physical Activity and Everton in the Community brings academics, policy-makers, practitioners and the general public together to develop an innovative way of analysing the effectiveness of Everton Football Club's Workplace Wellbeing Programme (WWP). The WWP is intended to address the health and wellbeing of more than 1,000 employees from across all areas of its business, from match-day stewards to the Senior Executive team. The successful applicant will be given the opportunity to undertake a mixed methods research study with all employees at Everton to make positive changes in the workplace to benefit their physical and mental health. The project is intended to develop models of best practice in workplace physical activity and wellbeing that can be disseminated to other organisations inside and outside of sport.

Policy, Performativity, and Accountability: Community Sport Work and Mental Health Promotion in Neoliberal Times

The neo-liberal project has been the subject of increased critique within many domains, including in sport and health policy. However, there remains a paucity of research addressing the ways in which sports and health workers experience the increasingly performative nature of their labour, especially as it relates to the achievement of a diverse range of public policy outcomes, the use of public league tables, targets, assessments, and the individualised measurement of work place performance. Delivered in collaboration with Everton in the Community, this study will combine policy analysis with the ethnographic fieldwork in order to explore the impact of performative policies on community sports workers' (e.g., youth coaches, sport development officers, mental health workers, managers) identities and practices in the field of mental health promotion.
