# Taoyuan City, Taiwan, May 30 – June 2 Call for Abstracts

From May 30-June 2, 2017 the International Sociology of Sport Association (ISSA) will hold its World Congress in Taoyuan, Taiwan at the National Taiwan Sport University (NTSU). The local Organizing Committee – Taiwan Society of Sport Sociology (TSSS) and NTSU – is honoured to organize this event with the theme "Reimagining Democracies and Sport".

The main goal of the conference is to gather the international community of sociologists of sport to discuss the key issues and debates surrounding the role and place of sport in a global society. The congress will allow common interests linked to this theme to emerge, provide networking opportunities to develop collaborative research projects, and extend international scientific knowledge in human and social sciences. This congress is organized with the support of the Ministry of Education, Ministry of Science and Technology, the City Government of Taoyuan.

#### **Reimagining Democracies and Sport**

"If we take the simple democratic view that what men (sic) are interested in is all that concerns us, then we are accepting the values that have been inculcated, often accidentally and often deliberately by vested interests. These values are often the only ones men (sic) have had any chance to develop. They are unconsciously acquired habits rather than choices" C. W. Mills (1959: 194)

Democracy and Sport has increasing importance for global sport society. In this process, democracy and sport may be seen as one of the most important issues in the social sciences of sport. The common understanding of democracy in sport as participation by members or citizens in the decision making of a sport organization or sport society still leaves considerable room for dispute.

Two issues are essential in discussion of democracy and sport:

First, who are, or should be, considered members of the sport society? Second, what does, or should, constitute a minimum level of control over decision making by members for a sport system to be thought of as democratic?

In short, how much participation is necessary for a sport system to be democratic? These questions are not simply matters of empirical observation of the sport world, but also matters for moral and political thought in sport and requires critical sociological views. Beyond the main theme, the congress will also feature a diverse range of sessions to enable scholars, including postgraduate students, the opportunity to share their latest research.

International Sociology of Sport Association Graduate Paper Award 2017

The 2017 ISSA Graduate Paper Award is co-sponsored by ISSA and SAGE

#### Description

The aim of the International Sociology of Sport Association's (ISSA) Graduate Paper Award is to recognize the scholarship of outstanding graduate students in the international community of sociology of sport. The award will be granted to a scholarly paper, authored by a graduate student, which is deemed by a panel of judges to demonstrate considerable originality, critical and analytical ability, and to be of the highest quality from among those submitted<sup>1</sup>. The winning author will be invited to receive the award and present or distribute the paper at the annual conference of the ISSA.

#### Eligibility

• The student must be registered for masters or doctoral level graduate work at the time her or his paper is submitted.

- It must be a single-authored paper.
- The student must be a member of ISSA at the time her or his paper is submitted.
- The committee will accept only one submission per author.
- Full-time faculty and academic staff are not eligible.
- Previous winners are not eligible.
- A paper cannot be considered for the ISSA GPA at the same time it is submitted for another award.
- A paper that won a previous award cannot be submitted to ISSA GPA.

#### **Award**

- The winning author will be invited to present or distribute the paper at the ISSA World Congress in Taiwan, at the National Taiwan Sport University, 30 May to 2 June 2017.
- The winning author will receive a SAGE Publisher sponsored prize of £150 worth of books.
- The winning author will receive an ISSA sponsored prize of membership in ISSA for 12 months in the year in which the award is granted.
- The panel of judges may also give up to two honourable mentions. Graduate students receiving
  honourable mentions will also have their papers accepted for presentation or distribution at the
  ISSA conference.
- The name of all winning authors will be posted on the ISSA website

#### Requirements

- Candidates are to submit a 3000-6000 word (excluding references) scholarly paper on a topic that is of interest to the international sociology of sport academic community.
- Papers with a text of over 6000 words will not be considered.
- Authors are to submit a cover page that contains the title of the paper and the full contact information of the author.
- The author's identity must not be recognizable in the text.
- Authors must be graduate students at the time the paper is submitted.
- Authors must be members of ISSA at the time the paper is submitted.
- Authors are to submit a letter, signed by her or his academic advisor, verifying graduate student status.

- Authors are to follow a style consistent with the publication guidelines for the *International Review for the Sociology of Sport*.
- Papers should be submitted electronically (in Microsoft Word format attachment) to the Award

#### IRSS Journal Update and Call for Submissions from Editor Lawrence Wenner

#### 2015 IRSS Impact Factor Update



In recent years, the continued work of the *IRSS* editorial team and editorial board has resulted in a general upward trend in the impact of the journal on its home disciplines. In the June 2016 40<sup>th</sup> edition of the Thomson Reuters *Journal Citation Reports*, the 2015 IRSS 2-year Journal Impact Factor score rose to 1.341 and its 5-year IF rose to 1.933. In this report, the *IRSS* ranking amongst peer journals improved as well; the *IRSS* was ranked as 18<sup>th</sup> of 44 journals in the Hospitality, Leisure, Sport & Tourism category and 41<sup>st</sup> of 142 journals in the Sociology category. In this most recent report, the *IRSS* was ranked ahead of its most relevant journal competitors focused on the socio-cultural study of sport and leisure.

#### Call for Research Articles

The *IRSS* continues to solicit diverse research articles seated in the sociology of sport, broadly defined, that shed light on social and cultural understandings of sport. Interdisciplinary, inclusive, and global, the *IRSS* is the journal of the International Sociology of Sport Association and is published in partnership with SAGE Publications. Beginning with 2015 to mark its 50<sup>th</sup> year of publication, the *IRSS* publishes eight issues each year and has expanded to 1024 annual pages. Reviews of books or media provide a scholarly assessment of key works that may advance understanding of sport in social and cultural contexts. Reviews that provide an assessment of one work by a single reviewer are normally of 1500-2000 words in length, inclusive of references, notes, tables, and figures. Reviews that provide a comparative assessment of more than one work or an assessment of one work by multiple reviewers are more substantial integrative essays and are normally of 2000-3000 words in length, inclusive of references, notes, tables, and figures. IRSS accepts book or media review essays comparing 2 or 3 items on one topic and written by a single author as well as book or media review symposia in which the same item is reviewed by 2 or 3 different reviewers. Reviews do not require an abstract or key words.

Book or Media Reviews should contain a heading, which includes the Book or Media Title, Author, Publisher's Name and Location, Date of Publication, Number of Pages, ISBN Number (and, if appropriate) eBook Number. 

#### SSJ CFP Sport, Feminism, and the Global South

Feminist scholars have long been at the forefront of advancing the study of sport to address the intersections of race, gender, class, sexuality and ability in framing sporting encounters and experiences. The field, however, is largely dominated by research that details the gender operations of sport across North America, Europe and the UK (what is often referred to as "the Global North") leaving women's everyday encounters with sport as players, audiences, workers and media subjects across "the Global South"; that is Australasia, Africa, Latin America and the Middle East open to further investigation. It is timely then to re-examine feminist approaches to conceptualising sporting encounters, identities and relations in the Global South so as to widen the empirical and theoretical base of sporting feminisms and, better understand the political geography of knowledge production in sport.

This special issue of the *Sociology of Sport* seeks to broaden the geographical, theoretical, social, cultural and intercultural scope of writing about women, gender and sport by assembling key contributions from feminist sport research undertaken in or by scholars from the Global South. While the Global South can be understood in terms of geographical space (as above) alternatively it envisions a critique of the production of knowledges 'from the viewpoints, perspectives and problems of metropolitan society', which are presented as universal and applicable to all cultures and contexts (Connell, 2007, vii-viii). This special issue is keen to include contributions that engage with social experiences of sport from the periphery, including those peripheral knowledges in colonised "Global North" countries such as Canada, the Artic and Australia and New Zealand who are geographically South of the dateline yet can be understood as part of the global metropole that decentralises its Indigenous "Others". We seek to solicit articles on sport research undertaken in or by contributors that critically interrogate gender relations, inequalities, the production of gendered subjectivities, pleasures and knowledges through sporting encounters in the Global South in ways that advance methodological, theoretical and conceptual boundaries of feminist sport research.

Papers which address, but are not limited to, the following are particularly welcome:

• Feminist analyses of the dualities, dichotomies and discourses of sport in the Global North and

Global South;

• Empirical or textual accounts of gendered sporting pleasures as transformative experiences;

Accounts of women's participation in sport the Global South, including mainstream and

• Feminist perspectives on sport and development in or from the Global South;

Feminist perspectives on sporting organisations, governance and sports policy from the Global

South;

• Methodological issues and innovations in exploring sport, feminism and the Global South

There is a rapidly growing body of scholarly research about 'lifestyle sports' (sometimes referred to as 'action sports' or 'extreme sports'). Activities that often fall under this umbrella term used in scholarly research in the West include surfing, skateboarding, snowboarding, parkour, climbing, BMX, Moto-X, BASE jumping, windsurfing, etc. Research addresses tourism, industry, identity, place/space, bodies, emotional life, risk, technology, consumption, and more. Recently, a critical dialogue has emerged around the cultural tensions of inclusion of surfing, skateboarding, and climbing in the Tokyo 2020 Olympics.

The vast majority of lifestyle sport research has been conducted in Western countries (Wheaton, 2010). Most of the research about lifestyle sports in non-Western countries has been in relation to tourism. There have been a few instances in the field which briefly touch on the cultural politics of lifestyle sports in 'East Asia' (Thorpe, 2014; Laderman, 2014). However, there are only the

beginnings of a body of empirical research focusing on this region (See Sedo, 2010; Cheng & Tsaur, 2012; Hung & Lee, 2012; Tien-Ming & Chiang-Chuan, 2015; Manzenreiter, 2013; Evers, in press). The expansion of lifestyle sport into 'East Asia' is resulting in specific histories, encounters, and manifestations of activities, experiences, industry, identity, place, technology, and media. There are examples of colonization but also localization and indigenous realisations. Cultural, political, social, material, and capital encounters and exchanges are taking place by way of inter-Asian and Asia-Global South connections, rather than simply East-West. The complex refiguring of geopolitics through lifestyle sports enables new and interesting networks, politics, and possibilities that are in need of further critical attention.

This special issue of the Journal of Sport and Social Issues asks: how are East Asian networks of lifestyle sport enthusiasts, workers, governing bodies, and associated communities-ecologies forming? What are the politics of the worlds, experiences, values, and imaginaries coming about (or being blocked)? How is such being negotiated by humans and non-humans?

The purpose of this special issue is to provide a forum for discussion on the latest developments, trends, and research concerning lifestyle sports in East Asia. To achieve this, we invite contributions from across sport sociology, cultural studies, human geography, tourism studies, postcolonial studies, sport history, anthropology, gender studies, media and communication studies, and more.
