# From the President: In anticipation of the Vienna Forum

The next Forum at Vienna will take place not far from the Balkans where important battles between the East and the West took place in earlier centuries, even at the gates of our host city in 1683. This time, however, many thousands of people mainly from a few countries in the East are seeking refuge in countries of the European Union, which is precisely a union of countries that stands as a model where one main purpose has been to avoid wars – but could we also add "to minimize conflicts between countries"?

In this sense a careful use of migration policies is at the centre of the problem as perhaps the only way to avoid more troubles. This is the context in which we will have our next Forum at Vienna.

Our Research Committee 31 will host 17 sessions and co-host 7 more with other RCs. The issues in the different sessions vary a lot, but three orientations could be emphasized: One has to do with conflict and integration from various newer perspectives focusing on contributions to art and culture as well as on migrants' well-being and suffering. A second orientation seeks newer information on present flows of migration in general but more specifically in Asia, a continent of which we have had less knowledge. A third one

has to do with newer methodological questions about the future of migration research as well as about the insights coming from other disciplines; in particular, how can we make our visions of migration flows more interactive with other perspectives?


There is no doubt that our next Forum in Vienna will offer to all of us a great possibility for exchanging our visions and views about some of the common problems we face in our different national contexts.

## Doctoral Program in Sociology and Social Research University of Trento

The doctoral programme in Sociology and Social Research (SRS) was established in 1981 with the aim of providing state-of-the-art research training and advanced professional skills in sociology and social research. It joined the School of Social Sciences in 2011.

The PhD programme provides a solid basis in the discipline, including a broad range of quantitative and qualitative methods, in an interdisciplinary research environment. Since its foundation the programme has placed special emphasis on theoretically driven empirical sociology. In particular the PhD programme educates professionals that are able to apply their knowledge in an interdisciplinary fashion in various areas covered by the department, such as: epistemology of the social science, sociological theory, social stratification and inequalities in relation to gender, education and cohort, comparative welfare systems and their evolution, social networks, social and political change, the sociology of labour markets and the evolution of employment systems in comparative perspective, sociology of migration, sociology and demographics of the family, analysis of value change and of political behavior, sociology of organizations.

The goal of the doctoral programme is to qualify its alumni for high level positions in academia, as well as in the public and private sector.

The PhD programme offers students a stimulating international research environment and important opportunities, not least through an international network of high quality. Beyond a wider range of teaching and research opportunities, SRS offers an intensive calendar of seminars and conferences including distinguished scholars from an international context.

The official languages of the doctoral programme are English and Italian and it has a duration of three years.
