### From the New President

Last July, RC40 had its biannual meeting at the ISA Congress in Gothenburg. There were 14 interesting sessions with contributions from various approaches and on diverse themes, including alternative food systems, choice in the agri-food sector, rural development, the food crisis, food security and food safety, the role of food in sustainable city-regions, food governance, local food, responses to climate change, amongst others. Two of the panels were joint sessions with RC47 (Social Class and Social Movements).

Support for the panels and the high quality of the presentations contributed to the success of the congress for our RC. We want to thank the session coordinators for organizing them and especially thank the outgoing officers for organizing the entire RC program.

The dinner after our business meeting was an occasion to enjoy what several members called "the warm atmosphere that makes RC40 unique" and to share a nice meal and a good time.

Now, we have to look forward and work on new initiatives in order to strengthen the dynamic of RC40 and its contribution to the academic debate on Agriculture and Food in these difficult times. For example, the impact of climate change on grain production is bringing, once more, the question of food security to the foreground of politics and public concerns. One of the decisions coming out of the business meeting was to work to give greater visibility to RC40. particularly in regions where its presence is only partially developed. A key means accomplish this is through our members participating in regional and national congresses and academic events. Participation in our sessions Gothenburg was mainly from our members from Northern countries and we need to try to incorporate more contributions from Southern or less developed regions in our discussions. Therefore, before our next general meeting at the IRSA Congress, in Lisbon, 2012, we strongly encourage all our members to organize RC40 sessions—and present contributions at those meetings— in their own regions. A first call for volunteers has already received an encouraging response, as detailed below.

Part of RC40 life relies on its publications; this Newsletter and the online International Journal of Sociology of Agriculture and Food (IJSAF). The RC needs your contribution to the Journal and we invite all members to submit articles and disseminate the journal amongst your colleagues and in your institutions.

The economic crisis all countries and academic institutions are going through represents a further challenge to our tasks, making it difficult sometimes to perform them as we would wish. There is no doubt, however, that by bringing together our efforts we will strengthen our organization and improve our reputation.

### Report from the Past President of RC40 Gianluca Brunori

I would like to take the opportunity of this space in the RC40 newsletter to give some elements of reflection on the experience accumulated in the past four years, during which I had the honour to serve the RC40 community as president.

The first point I want to highlight is an increasing attention towards RC40, both from other sociology branches and from other disciplines, such as, for example, geography and agricultural The theme of food is the economics. object of increasing attention of public opinion, and I think we have succeeded in turning our activity to the events in the world by addressing the most relevant themes in a timely manner and with scientific rigour and a critical view. During my four years participating in RC40 events I have seen very lively debates attended by many people, of which many of them were young scholars.

The second point is that RC40 is well on the way of reaching a truly global status. Our working sessions during the ISA conference in Gothenburg were populated by scholars from everywhere in the world, illustrating an incredible variety of situations and a true interest in creating a common understanding and an enrichment of our knowledge basis.

to our capacity to create links between civil society, producers and public administrations, to learn from successful and unsuccessful initiatives, to give voice to people and to turn this voice into scientific knowledge.

Finally, I wish to express my happiness for the outcomes of the election of the new representatives, which are highly appreciable for competence, gender and geographical composition.

I would like to thank the past secretary, Masashi Tachikawa, all members of the past executive council and the editors of the 'International Journal of Sociology of Agriculture and Food', our scientific journal, for having worked as a true team. A special thanks is to be addressed to our old fellows, and first of all Bill Friedland, who have transmitted to the new generations the enthusiasm they had when founding RC40.

My best wishes to the new president, the secretary and the executive council for the challenges of the four years ahead.

### **RC40 Business Meeting**

July 14, 2010, 18:20-20:00

Handels D32, ISA Congress, Gothenburg, Sweden

- 1. Opening from President, Gianluca Brunori

- 3. Introduction of new officers and discussion of future issues

#### (a) Role of regional representatives:

- Stressed importance of improving the visibility of RC40 within regions
- Need to specify the role of regional representatives in order to enhance collaboration and raise the profile of RC40 at local and regional meetings
- Need to identify new regional representatives and encourage young people to participate
  - New council will decide the role of the regional representatives and give clear instructions to them

#### (b) Raising the visibility of RC40

- Suggestions for raising the profile of RC 40 and enhancing collaboration among members included:
- Organize RC40 workshops or working groups at regional or national congresses
  - For example, Salete Barbosa Cavalcanti will organize an RC40 mini-conference at the Brazilian Sociological Association meeting in 2011
- Creating a restricted access Blog for communication among members
- Uploading RC40 presentations (or video recordings of presentations) onto our website
  - brochure/flyer (downloadable from the website) for promotional use at regional meetings
- Encourage those members who were involved with establishing RC40 to write a history of RC40 and draw on some of its important lessons (this could include re-printing an interview with Bill Friedland that was published in a past edition of our newsletter).
- Need to involve younger generation in order to expand our organizational base

- Should increase efforts to recruit members from diverse regions of the world
- Need to connect relevant activities with the journal

#### 4. IJSAF

### Report from Mara Miele, Co-Editor of the IJSAF

- Problem with low submission rate to journal, therefore struggle to meet goal of three issues per year. Many irrelevant papers submitted from non- social science field
- Journal is not viewed as avenue for publishing by our members
- How we can increase submissions to IJSAF, while maintaining quality of papers, in order to achieve ISA ranking for journals?
- Special issues achieve the highest visibility.
   Should increase number of special issues.
- IJSAF invested in new website

#### Discussion

- Ongoing problem with delays in review process. Process needs to be more efficiently organized
  - O IJSAF is currently in process of shifting towards an e-submission system which should help improve the review process and turnaround time
- Idea of a submission fee to help cover the cost of the journal and help reduce the number of inappropriate submissions considered. However, difficult to ask for a submission fee to a non-ranked journal
- Need to expand varieties of contributions to the journal, such as discussion papers, guest columns, book reviews, etc.
- Could advertise IJSAF in other journals, such as Agriculture and Human Values
- Should disclose the number of hits (visits) to the IJSAF on the website since it is quite large
- Need to identify editorial board for the journal made up of individuals with strong reputations
- Consider commissioning papers to increase visibility

#### 5. Amendment of RC40 By-Laws

- Proposed revision of RC40 By-Laws discussed (as outlined in the meeting's agenda).
- Gianluca motioned to approve the proposal to amend the By-Laws (seconded by Alessandro Bonanno). Adopted unanimously (29 persons).
- All members must be notified of this decision and the decision must be ratified by mail ballots.

# RC40 By-Laws\*

\* As outlined in the Minutes above, these By-Laws were revised in 2010 and approved by the RC40 membership.

#### I. MEMBERSHIP AND GOVERNANCE

- I.A. Members are those who pay RC-40 dues and participate in the scientific activities of the committee. Dues are set by the Executive Committee of RC-40.
- I.B. Members of RC-40 have the right to
- I.B.1. Run for office
- I.B.2. Vote in all RC-40 elections
- I.B.3. Participate in RC-40 business meetings
- I.B.3.a. To participate in the quadrennial business meetings, individuals must be members of the International Sociological Association
- I.B.4. Have priority status for participation in any of the scientific activities of the committee
- I.C. Members are strongly urged to maintain membership in good standing in the International Sociological Association
- I.D. Officers of the RC-40 are
- I.D.1. The President
- I.D.2. The Secretary
- I.D.3. The Executive Committee, which consists of
- I.D.3.a. The current president and secretary-treasurer
- I.D.3.b. The immediate past president and secretary-treasurer
- I.D.3.c. Four elected representatives

- I.E. Officers are elected in the year prior to the quadrennial World Congress and take office at that Congress
- I.E.1. Officers cannot succeed themselves I.E.2. All Officers must be members in good standing in the International Sociological Association

#### I.F. Duties of the President

- I.F.1. The president has executive authority to organize the scientific and administrative work of the committee in consultation with the secretary-treasurer and members of the executive committee I.F.2. The president convenes and organizes the quadrennial business meeting as well as any meetings of the executive committee
- I.F.3. The president appoints the editorial committee of the International Journal of the Sociology of Agriculture and Food
- I.F.4. The president, with the assistance of the secretary, organizes the publication and distribution of the semi-annual newsletter
- I.G. Duties of the Secretary-Treasurer
- I.G.1. The secretary assists the president in the coordination of the scientific and business activities of RC-40
- I.G.2. The secretary-treasurer shall maintain a record of all committee business and executive meetings, and maintain the financial records

- I.G.3. The secretary shall make a yearly financial accounting to the executive committee and a quadrennial financial accounting to the membership at the quadrennial business meeting
- I.G.4. The secretary shall be responsible for conducting the elections of new officers
- I.H. Duties of the Members of the Executive Committee
- I.H.1. Advise the President and Secretary on all scientific and business matters pertaining to the activities of the Research Committee
- I.H.2. Review the secretary's annual financial report

# II. SCIENTIFIC WORK OF THE COMMITTEE

- II.A. To promote and encourage scientific analysis of the social organization of agriculture and food systems
- II.B. Organization of the substantive content of the RC-40 session of the quadrennial meetings of the World Congress of Sociology
- II.C. Organization of additional international meetings, including those that are held in conjunction with the World Congress and other scientific meetings

#### III ORGANIZATION OF THE JOURNAL

- III.A. The International Journal of the Sociology of Agriculture and Food is the official scientific journal of RC-40.
- III.B. The content of the journal shall reflect the scientific interests of the Research Committee, which is the sociological study of agriculture and food.
- III.C. The editor(s) are appointed by the president in conjunction with the executive committee. The term of service for editors shall be negotiated in consultation with the executive committee.

- III.D. The editors shall between them nominate a representative who is the main point of contact for, and liaison between, the journal and the executive committee.
- III.E. The editors shall, in consultation with the executive committee, appoint an editorial assistant to take charge of the daily running of the journal. The editorial assistant shall have responsibility for co-ordinating the entire submission, reviewing and publication process; responding to contributors; liaising with reviewers; maintaining the website; ensuring that the editors are provided with regular updates on contributions and reviewing; and, assisting in the planning of future issues.
- III.F. The president of RC-40, in consultation with the editors and the members of the executive committee, shall appoint the members of the editorial board. The editorial board members consist of distinguished researchers in the sociology of agriculture and food and at the time of appointment must be members of RC-40.
- III.G. The executive committee shall, where possible, provide financial support to ensure the ongoing viability of the journal.
- III.H. The editors shall transmit regular reports on the journal to the RC-40 newsletter and shall present a report at the quadrennial business meeting.
- III.I. The editors shall transmit a complete record of journal finances to the secretary of RC-40, who shall add those records to the yearly financial report that is to be submitted to the executive committee and the quadrennial report submitted to the business meeting.

#### IV. AMENDMENTS TO THE BY-LAWS

IV.A. Amendments to the by-laws can be submitted by any member in good standing of the Research Committee.

IV.C. Amendments must then be ratified by mail ballot of members by a majority of those voting
