Candidates for the RC46 Executive Board

RC46 members were asked to nominate someone and/or apply for RC46 board membership. As specified in our statutes, a nominations committee reviewed the applications to see that the applicants met the standards. All applicants met the standards and have been put forward for board membership. **Candidates for the Board will be introduced at our lunch reception (Monday, July 14 at 12:30 in room 415). Voting will take place at the first RC46 Business meeting (July 14, 17:30-18:30; Booth 55)** and the new board will convene (probably on July 15, 12:30 pm) to discuss a preliminary first- year agenda as well as elect officers from among the board members. **The new officers will be introduced at the second RC46 Business meeting (July 15, 17:30-19:20; Booth 55).**

Here are the standards that applicants were asked to meet. **1. Have been an active participant in one or more RC46 meetings in the past three years** (RC46 meetings in Argentina, Spain, and /or Yokohama; RC46 session at the IIS meeting in Norway); **2. Be willing to attend all or at least most RC46 meetings in the next four years (2014-18).** (It is expected that one meeting may be in 2016 in Austria and another in 2018 in Toronto. Other meetings may

be arranged.); **3. Have actively fostered clinical sociology at some point or points in the last three years** e.g., solicited new members, published something clearly identified with clinical sociology, promoted clinical sociology, organized a clinical sociology session, gave a presentation about clinical sociology, developed clinical sociology in a city or country, took on a responsibility for RC46); **4. Be willing to assume a responsibility (leading or assisting) for RC46 during the next four years** (e.g., training, newsletter, website development, archives/special collections, membership recruitment, coordination of regional representatives, program coordination, scholarship development, take charge of the RC46 awards process, translate RC documents).

5. Be willing to update your membership (when needed in the future) to be a member (in good standing) of both the ISA and RC46 through 2018. (The ISA does not allow an RC to apply for certain ISA opportunities if one or more Executive Board members are not in good standing.)

According to our statutes, each past president of RC46 is asked if he/she would like to be an Executive Board Member. Vincent de Gaulejac (France), Jacques Rheume (Canada) and Jan Marie Fritz (USA) accepted the invitation. (Robert Seigny from Canada will serve as an adviser.) According to our statutes, the past presidents do not need to be voted on to be members of the RC46 Executive Board. All the other board positions are elected. Please note there are four candidates from the US, but, according to our statutes, only three from one country can be elected. The election will take place on

Here are the candidates in alphabetical order for the Executive Board and their responses to our five standards for Executive Board applicants:

Rosemary Barberet (USA) - Associate Professor at John Jay College of Criminal Justice and Director, MA in International Crime and Justice Degree Program/City University of New York (USA); Current ISA representative to the United Nations in New York City and Vienna; Current candidate for the ISA Executive Board; Herbert Bloch Award, American Society of Criminology, November, 2006; Rafael Salillas Award, Sociedad Española de Investigación Criminológica, April 2006; Publications include Barberet, R. (2014). *Women, Crime and Criminal Justice: A Global Enquiry*.

1. I will be a participant in RC46 meetings in Yokohama.
2. I am willing to attend most of these meetings.
3. I have oriented my own work on women in prison, to be presented in Yokohama, towards the viewpoints of human rights and clinical sociology.
4. I am willing to translate RC documents.
5. I am currently an ISA and RC46 member and will continue to be.

Weizhen Dong (Canada) – Associate professor in the Department of Sociology and Legal Studies at the University of Waterloo, Canada and Senior Fellow with the Munk School of Global Affairs at the University of Toronto; Visiting professor at Peking University, Beijing; Current RC46 regional representative; Publications include *Healthcare in an Age of Transition*.

Since I joined the RC46 of the ISA, I became an active member of the RC. Currently I am the Regional Representative (Canada) of the RC46. In the past three years, I have actively participated in RC46 meetings, which include in Argentina (2012) and Spain (2013). I have also been promoting clinical sociology at various settings, including at the Canadian Sociological

Association in May 2014. I will update my membership with the ISA and RC46 through 2018, and attend the RC46/ISA meetings in the future years, such as Austria (2016) and Toronto (2018). If I was to be elected a member of the RC46 Executive Board, I will actively take responsibilities involving training, membership recruitment, coordination of regional representatives, program coordination, scholarship development, or the awards process.

Melodye Lehnerer (USA)

Background and Positions. I am a Professor Emeritus from Missouri State University who specialized in community corrections. I am currently Professor of Sociology at the College of Southern Nevada (USA). I earned my doctorate in sociology at York University in Toronto, Canada. During my career I have worked with a variety of social groups who often have been disadvantaged by a social structure that devalues them – ranging from ex-offenders, members of the LGBTQ community, to first generation college students. I am certified as a Sociological Practitioner/Clinical Sociologist through the Association of Applied and Clinical Sociology. I received the Award for Extraordinary Service to Organization and to Sociology from the Sociological Practice Association.

Contributions to Clinical Sociology. I have actively fostered clinical sociology in three ways. First, I was a long time board member and past Chair of the Sociological Practice Association (formerly Clinical Sociology Association). In this capacity I ensured that the organization remained true to its clinical sociology roots by overseeing the nurturing of a membership that embraced the principle of using sociology to bring about positive social change. Second, I participated in the establishment of the Commission on the Accreditation of Programs in Applied and Clinical Sociology and served as board member, chair, and vice-chair. This organization sets standards for applied, clinical, and engaged public sociology programs that are training the next generation of social change agents. Third, I have published on the importance of accrediting applied, clinical, and engaged public sociology programs and have conducted many workshops informing sociologists worldwide the importance of accreditation.

Contributions and Activities for RC46. I am a new member to RC46. I first attended the meetings in Buenos Aires (2012) at which I presented two papers - one on the accreditation experience in the United States and another on training students to be social change agents. I am scheduled to present on certification and accreditation at the ISA Yokohama meetings. I believe my experience as a chair of two major sociology organizations that have consistently promoted the relevance of clinical sociology will be a benefit to RC46.

Gwyn Øverland (Norway) – Senior advisor/advisor for the Regional Trauma Centre RVTS Sor / Psychosocial Team for Refugees (Norway) and formerly a researcher with the Sorlandet Hospital trust; Current RC46 Executive Board Member with responsibility for the regional representatives; Publications include *Post-Traumatic Survival: The Lessons of Cambodian Resilience* and the forthcoming *Nordic Work with Traumatized Refugees: Do We Really Care?*

I, Gwynyth Øverland:

1. Have been an active participant in one or more RC46 meetings in the past three years: RC46 meetings at Universidad Complutense, Madrid 2013, with paper (Mediating cultural resilience in mental health care); facilitated the RC46 session at the IIS conference in Uppsala 2013. (plus ISA with paper in Gothenberg 2010!)
2. Am very willing to attend all or at least most RC46 meetings in the next four years (2014-18).
3. Have actively fostered clinical sociology at some point or points in the last three years (e.g., published two books (*Post Traumatic Survival: The lessons of Cambodian Resilience*, 2013 and *Nordic work with traumatised refugees* (forthcoming) and numerous papers clearly identified with clinical sociology at international conferences.
4. Am willing to assume a responsibility (leading or assisting) for RC46 during the next four years (e.g., coordination of regional representatives, which I have done in the last year).
5. Am willing to update your membership (when needed in the future) to be a member (in good standing) of both the ISA and RC46 through 2018.

Harry Perlstadt (USA) – Professor Emeritus, Department of Sociology, Michigan State University; Current RC46 Secretary-Treasurer; Current Candidate for ISA Vice President for Finance and Membership; Former Chair of the Commission on Applied and Clinical Sociology; American Sociological Association 2014 Distinguished Career Award for the Practice of Sociology.

1. I presented a paper at the ISA Forum of Sociology, Buenos Aires, Argentina, attended the RC 46 meeting in Madrid and will present a paper at the ISA World Congress in Yokohama.
2. I am willing to attend all or at least most RC46 meetings in the next four years (2014-18).
3. I have been active in RC 46 serving as secretary treasurer for the past two years. I will have a chapter “The Healthy Cities/Communities Movement: The Global Diffusion of Local Initiatives: In Jan Fritz and Jacques Rheaume (eds) *Community Intervention: Clinical Sociology Perspectives*. 2015
4. I am willing to assume a responsibility (leading or assisting) for RC46 during the next four years and would be willing to continue to serve as Secretary Treasurer if chosen.
5. I am willing to update my membership (when needed in the future) to be a member (in good standing) of both the ISA and RC46 through 2018

Emma E. Porio (Philippines) - Professor of sociology and chairperson of the Department of Sociology and Anthropology (DSA) at the Ateneo de Manila University, Loyola Heights, Quezon City, Metro Manila; current RC46 vice president with responsibility for publications/website; current Executive Committee member of the ISA; a past president of the Philippine Sociological Society; publications include a chapter in RC46's *Community Intervention*; consultant-adviser to community-based organizations, civil society organizations and development assistance agencies.

1. YES, I have presented papers in the ISA-RC 46 meetings in Buenos Aires, Madrid and in the forthcoming Yokohama Congress.
2. YES, I have already put these meetings in my calendar and expect to present papers in these conferences. I am also thinking of organizing a meeting sometime in Manila or Bangkok.

3. YES, I have tried my best to support the program goals of RC 46 by presenting papers on clinical sociology, doing research relevant to clinical sociology issues and supporting the creation of the RC 46 website and its maintenance until 2018.
4. YES, I am willing to assume responsibilities and functions that will advance the goals of ISA RC 46 (e.g., membership recruitment, website development and maintenance, assembling special collections of RC46 materials in developing economies, etc.).
5. YES, I am willing to pay my membership dues to RC 46 until 2020 and beyond.

Abdul-Mumin Sa'ad (Nigeria) Provost and professor of sociology, Federal College of Education, Yola, Adamawa State, Nigeria; Former dean of faculty of social sciences and head of the department of sociology at the University of Maiduguri, Nigeria; Current member of the RC46 Executive Board; Current candidate for ISA Vice President of Finance and Membership; Former member of the ISA Executive Committee; Consultant/convener/technical expert; recent publications about child hawking, public policy, juvenile justice and policing.

1. I am pleased to point out that I attended the meeting in Madrid, Spain, in December 2012. I actively participated by presenting a paper as well as chairing a couple of sessions. I am now set to attend the World Congress at Yokohama, where I will present a paper entitled: "Clinical Sociological Analysis of the Issues and Challenges to Healthcare Delivery in Nigeria Today". I have registered for the Congress, booked accommodation and bought a return ticket. Currently I am processing a visa to Japan.
2. I am very willing to attend most, if not all the meetings of RC46, especially the ones that will be held in Austria (2016) and in Toronto (2018). I am also contesting for the post of Vice-President, Finance of ISA. This, if I win, will further enhance my capacity to participate even more actively in RC46 meetings and assist the committee in very special ways.
3. As a member of RC46 Extended (Additional) Executive Board from Nigeria for almost four years now, I used every opportunity in Nigeria and outside Nigeria when attending a conference or workshop to advertised ISA in general and RC46 in particular. I also took several responsibilities for RC46. For example, I was a member of the RC46 Award Committee in 2013. I assisted in developing one of the sessions of RC46 in the forthcoming ISA Congress. I also accepted to organize/chair session 2 of the RC46 Yokohama programme, namely, *Clinical Sociology: Epistemology and Research/ Sociologie Clinique: Épistémologie et la Recherche*
4. I am very willing to lead and/or assist in all RC46 activities in the next four years, particularly in membership recruitment, program coordination, training, newsletter contribution and RC46 Awards process.
5. I know very well that the ISA does not allow an RC to apply for certain ISA opportunities if one or more Executive Board members are not in good standing, and so I cannot afford to jeopardize RC46 by failing to remain a member in good standing. Moreover, I have been a member in good standing of both ISA and many other RCs since I joined ISA in 2000. And because of my active membership (in good standing) of both ISA and other RCs (RC29) I was nominated and elected as one of the eight (8) EC members on the Research Council in 2006 for a term of 4 years, which expired in 2010.

Mariam Seedat Khan (South Africa) – Senior lecturer in the Department of Sociology at the University of KwaZulu-Natal, Durban; Previously a lecturer in the Department of Sociology at

the University of Johannesburg; Currently an executive member of the South African Sociological Association (SASA); Former SASA secretary; Recent publications about work/family life balance, indentured women and South African Indianess.

1. Conferences:

- Spain: Madrid (Presented a paper with my Phd candidate **RC46**)
- Yokohama (Presenting a paper **RC46**)

2. As an active member of the local South African Sociological Association, I intend to be involved in Sociological meetings at both national and international levels. I would be willing to attend meetings as and when arranged by the President of RC46.
3. Through my personal research funding, I have encouraged and supported my Phd candidates to become members of the group, attend conferences and present paper. I am currently working on new publications and have published in the field. Together with Professor JM Uys we have established a Clinical Sociology working group within the South African Sociological Association.
4. I would be willing to assist the executive in the planning and co-ordination of RC 46 activities.
5. I will ensure that my membership is updated timeously.

Tina Uys (South Africa) – Professor and former head of the Department of Sociology at the University of Johannesburg (South Africa). Former director of the University’s Centre for Sociological Research. Current ISA Vice President for National Associations; Current RC46 Vice President for Programs; Former president of the South African Sociological Association and president of RC42 Social Psychology; Awards include Fulbright Visiting Scholar Award and Oppenheimer Fellowship; Publications include *Exclusion, Social Capital and Citizenship* and *Contemporary India and South Africa*.

1. Have been an active participant in the following RC46 meetings : Argentina, Spain, and will be in Yokohama.
2. Am willing to attend all or at least most RC46 meetings in the next four years (2014-18).
3. Have actively fostered clinical sociology in the last three years in the following ways: introduced an undergraduate clinical sociology module at UJ; established a Clinical Sociology Working Group at the South African Sociological Association – the first sessions of clinical sociology papers will take place at the 2014 SASA annual conference; have solicited new members at my department; was program coordinator for RC46 programs in Spain and Yokohama.
4. Am willing to assume a responsibility (leading or assisting) for RC46 during the next four years.
5. Am willing to update my membership (when needed in the future) to be a member (in good standing) of both the ISA and RC46 through 2018.

Jeffrey A. Will (USA) Professor of Sociology and Director of the Northeast Florida Center for Community Initiatives, University of North Florida, Jacksonville, Florida; Managing editor of

the *Journal of Applied Social Science*; former chair of the American Sociological Association section on sociological practice and public sociology (SSPPS); former president of the Association for Applied and Clinical Sociology (AACS); Among his publications is *The Deserving Poor*; Research consultant to many organizations.

1. I am very interested in becoming a RC46 Executive Board member. I attended the RC46 session at the IIS meeting in Norway, June 2013. I also had a paper accepted for the Yokohama meetings, but because of personal issues I have had to withdraw from the meetings.

2. I am definitely planning on attending future ISA and RC46 meetings. I believe that it is important to share our work with, and learn from the experience of, our colleagues from around the globe in our efforts to improve our Clinical and Community Based Sociology.

3. For the past 20 year, in addition to being a Professor of Sociology at the University of North Florida, I have also been the Director of the Northeast Florida Center for Community Initiatives (CCI). During this time, CCI has garnered over \$3.8 million in research funding. Much of that funding has come through partnerships with clinic based programs, serving as evaluation partners for Healthy Start programs including The Magnolia Project (to reduce infant mortality in minority areas of Jacksonville); the Azalea project (addressing women at risk for HIV); the 4ME! Program (a teen pregnancy prevention program) and working with the March of Dimes Florida to establish “Best Practices” for working with women in the NICU through a 3-site evaluation of programs in Florida; among other projects. In addition, I served as President of the Association for Applied and Clinical Sociology and Chair of the Section on Sociological Practice, American Sociological association.

4. I believe that my experience as President of AACS, and Chair of the SSPPS have prepared me to take a leadership role in RC46.

5. I have every plan to remain a member in good standing with the ISA and RC46 throughout 2018 and beyond. I also plan to attend future meetings in Austria and Toronto – I apologize for not being in Yokohama, as the sessions there look tremendous.

The RC46 program starts at 10:30 am on Monday, July 14 (session 751), just after the first Presidential plenary (which begins at 8:30 am) and continues through to the Thursday, with the last RC46 session being from 3:30 PM-5:20 PM on Thursday July 17.

Please remember to attend our reception (Monday, July 14 at 12:30 in Room 415) and both of our business meetings (Monday, July 14 at 17:30 in Booth 55 and Tuesday, July 15 at 17:30 in

Booth 55). During our business meetings, we will be holding elections, discussing activities, giving out awards and making plans for the next year. We also hope you will take part in as many of our sessions as possible. **Apart from the Integrative Session organized by our RC and the joint session with the Working Group on Human Rights all our sessions will be held in Booth 55 in the Exhibition Hall of the Convention Centre.** <http://www.isa-sociology.org/congress2014/wcs2014-venue-site-maps.pdf>

### **Advice to presenters**

All presenters should have received a notification from Confex with regard to the scheduling details of your presentation. Most sessions are 110 minutes long. Speakers should prepare to present their papers within the time limit of 10-15 minutes maximum (depending, in part, on the number of presentations in the session) to ensure sufficient time for discussion. Keep in mind that some people in the audience (and some of the presenters in your session) might not speak English/French/Spanish/Japanese so it is a good idea to have a hand-out of your slides or a hand-out in another language or more than one language (e.g., French and English). (You can use Google translate - it will probably not be correct but will give people an idea of what you are talking about). We are, therefore, asking each presenter to have a two-language approach in written communication.

### **Technical information for presenters**

All rooms will be equipped with a computer, LCD projector, screen, microphone, and pointer. We recommend you bring either PowerPoint or Adobe PDF presentation files in a USB memory compatible with Microsoft Windows OS. The expected format of the presentation file is Microsoft Windows PowerPoint version 2003, 2007 or 2010. Speakers also can use their own computers for presentation. **The session room computers will not have internet access or sound connection.**

If a presentation includes animation, it is recommended you use your own computer. Speakers are requested to upload their presentations to the session room computer, or to connect their own computer to the on-site projector, not later than during the break proceeding a session. Speakers will operate the slides themselves.

### **Note to those who bring their own computer:**

- Please make sure that the PC has D-Sub 15 pin mini terminal for monitor output. Some compact PCs require another connector; in this case, please bring your own connector.
- Please bring your own battery charger adapter.

### **Responsibilities of session organizers/chairs**

Thank you to those who agreed to act as session organizer/chair of one of our sessions. Your efforts make a difference to the smooth running of the conference. Your duties are relatively straightforward, and we hope, undemanding but rewarding.

Please contact your speakers before the conference to answer any questions they may have and to make sure they know when and where their presentations will take place. This is also an

opportunity to request a short CV from them that you can use when introducing them. Read the abstracts to familiarize yourself with the content of the individual presentations.

It is a good idea to be present in the lecture theatre for your session in the 15 minutes before it is due to start. Describe to your speakers the method you will use to notify them when they are nearing the presentation time limit and how you will interrupt them if they have reached the end of their allotted time. It is important that the audience gets a chance to ask questions and give feedback.

Introduce each speaker when it's her/his turn. If you introduce everyone at once, it's too easy for audiences to forget who is known for what. Please keep your introduction to 15 seconds or less per speaker, so the talks can begin.

Ensure the session starts on time and finishes on time, as some in the audience may wish to move to other sessions. Please remember that one of the officers may need to make an announcement or two at the beginning of a session. Try to leave time for pertinent questions and answers (especially if the talk is particularly inspiring or controversial). If all time has expired for a speaker, it is acceptable to ask the audience to discuss issues with that speaker after the end of the session. It is up to you as the Session Chair to ensure that ALL speakers receive their allotted time and that the audience has opportunity for their questions and comments.

It is generally a good idea to initiate questions after all the speakers have made their presentations rather than allowing question time after each speaker. It sometimes works well to allow three questions to be asked at a time before giving the presenters a chance to respond. Keep the questioner as brief as possible. Have a few questions ready in case the audience doesn't. If questions are too long, or complicated, please suggest to the audience member that the issue be discussed after the session.

At the end of the session, please thank each speaker for her/his contribution and give the audience a chance to applaud.
