RC46's first book, *Community Intervention: Clinical Sociology Perspectives*, with contributions from some 12 RC members, is now in Springer's production process. The book, a volume in Springer's Clinical Sociology series, will be available this summer.

We are very pleased to announce that Harry Perlstadt, RC46's secretary-treasurer, will receive the American Sociological Association's (ASA) 2014 Distinguished Career Award for the Practice of Sociology. Harry is very well known in the field of sociological practice.

Harry, a long-time faculty member at Michigan State University, conducted evaluation research projects for international, federal and state agencies as well as private foundations. He has written about research ethics and the history of applied sociology; he also has a chapter on the healthy cities/communities movement in *Community Intervention*, the forthcoming RC46 book. Harry was a co-founder and head of the Commission for the Accreditation of Programs in Applied and Clinical Sociology; a chair of the ASA Sociological Practice Section; a Fulbright lecturer about American Health Policy and Politics; and a co-chair of the American Public Health Association Joint Policy Committee. Harry will receive this prestigious award this August at the ASA annual conference in San Francisco, California. (Previous RC46 recipients of this ASA award include Judith Blau and Jan Marie Fritz.)
