RC52 will meet at the Third ISA Forum of Sociology in Vienna, Austria, 10-14 July 2016. This Forum is designed as a mid-term meeting of Research Committees (RCs), Working Groups and Thematic Groups. The theme of the ISA Forum in Vienna is "The Futures We Want: Global Sociology and the Struggles for a Better World".

- On-line abstract submission take place from 14 April to 30 September, 2015 24:00 GMT.
- Participants must submit abstracts on-line via Confex platform. Abstracts must be submitted in English, French or Spanish. Only abstracts submitted on-line will be considered in the selection process.

Fourteen sessions have been allocated to RC52, including a Board meeting; an invited session with research contributions from Southern Europe and Latin America countries; and a joint session with RC17 (Sociology of Organizations). RC52 participate also as secondary RC in other two joint sessions, with RC30 (Sociology of Work) and RC15 (Sociology of Health).

Abstracts of up to 300 words are invited for the substantive sessions set out below. Only abstracts submitted through the ISA website platform by the deadline of 30 September, 30, 2015 will be considered. Session Organisers will handle all correspondence concerning the session and are responsible for informing authors by November 30, 2015. Presenters will need to register by 1 April 2016.

Also many thanks to 46 Phd Students and Early Career Researchers (ECRs), who clearly illustrated that sociology of professions is an expanding research area in terms of both the geographical distribution and the occupational groups and research topics. Seven PhD students and ECRs were awarded an ISA RC52 grant for conference support, as reported in our previous Newsletter (November 2014).

International Conference Professionalism reconsidered: changes and challenges in welfare states May 21–22, 2015 NRU HSE

On May 21-22 the International Conference "Rethinking professionalism: challenges and reforms of the welfare state" supported by RN 52 ISA, NRU HSE and Independent Centre "Social Research ltd." took place at the NRU HSE (Moscow, Russia). The event was dedicated to the memory of the co-founder and the first Editor-in-Chief of the Journal of Social Policy Studies, Professor of Higher School of Economics, Pavel V. Romanov (1964-2014).

More than 50 researchers from different regions of Russia (Moscow, Saint-Petersburgh, Tomsk, Saratov, Omsk, Chelyabinsk, Krasnodar, Samara, and abroad (Israel, Germany, Serbia, Ukraine, UK, USA) participated in the event.

At the plenary sessions welcome speeches were delivered by Elena Iarskaia-Smirnova (NRU HSE Professor, Editor-in-Chief of the Journal of Social Policy Studies), Ellen Kuhlmann (the President of the Research Committee on Professional Groups (RC52) of the International Sociological Association) and Lilia Ovcharova (NRU HSE Tenured Professor, member of the HSE Academic Council). Major lectures of the plenary session were devoted to such issues as the role of social work academics in the policy process (John Gal, Israel), tangled discourses about inclusive education in Russia (Michael Rasell, the Great Britain), retrospective review of relations between professionalism and the state in Russia (Elena Iarskaia-Smirnova, Roman Abramov, Russia), social workers' participation in legislative committees (Idit Weiss-Gal, Israel).

More than 10 sessions devoted to the substantial and methodological aspects of the modern research on professionalism in Russia and the world were held during the two days of intensive work. The topics of the sessions were as follows: Professional cultures in the context of welfare

reforms; Childcare: borders of professional competence; Youth in the context of labour and consumption: career, professionalization and success; Methodology of research on professionalism and professional groups; "Moral career" of social professions: new values and competences; The Key Elements of Professionalism in Our Times: Specialists between State, Market and Civil Society; Professionals in the Service of Law and State: Controversies between Status and Professional Practice; Professions in the Science and Education System: Potential and Constraints for Reforms. Moreover, there was a special session held by the Institute for Comparative Labour Relations Research, and Round Table "Characteristics of professional standards implementation in the conditions of the Law (On the basics of social service of the population of the Russian Federation) implementation".

At the closing event the results of the International Competition of research papers in memory of Pavel Romanov was announced. More than 40 papers were submitted to the Competition, so a great amount of work was done by the judges in order to pick the best. The premier place was taken by the paper of Ekaterina Ivanova (European University, Saint-Petersburg, Russia) devoted to the gender imbalance in the Russian Judicial System, the second place was taken by Evgeniya Podstreshnaya (NRU HSE, Moscow, Russia) with a paper on the perception of pain by the doctors of trauma ward, and the third place was taken by Lyubov' Chernysheva (European University, Saint-Petersburg, Russia) with a paper on the challenges of academic profession shown in strategies and tactics of interaction between young researches and funds in the domain of bio medicine. The fourth place of honour was won by Anton Kazun (NRU HSE, Moscow, Russia) with a paper on Social Responsibility of Russian Lawyers. The winners received diploma, memorial prizes and their papers have been accepted for the publication in the Journal of Social Policy Studies.

The recent attempts towards opening a global dialogue in the sociology of professions have met with great interest. Global Dialogue - A Note Challenging times across Southern Europe and Latin America: policies, publics and professions

New global trends and recent economic crisis has significant implications in society, introducing new issues in sociology of professions. However, this new challenges are not similar across the globe. The specificity of some regions and their countries, as Southern European and South America, opens new possibilities for research in the field of professions and professionalism, introducing opportunities for new theoretical approaches. For instance, the particularity of Southern European countries, as Portugal, Spain, Greece and Italy, leveraged by the economic breakdown and the subsequent structural adjustment programmes and austerity politics, has been set very particular trends in terms of professions and professionalism. Also South America countries, as Brasil, Argentina and Chile, present several forms of economic, political and cultural

transformation, creating new configurations in terms of professional expertise and organisations, in both public and private sectors.

Little is known on this local/national dynamics and there is a lack of knowledge and empirical studies about this particular contexts. Can we find any similar features between South European and South America countries, considering their mutual cultural and linguistic influence? How Southern European and South America realities impact in or/and alter concepts and theoretical frameworks of professions, professionalism and professionalization? The impact of global transformations in this particular contexts call for a critical revision of the current theoretical approaches, including material drawn from research country cases, local perspectives and contexts.

With this in mind, there will be an invited session, in the ISA RC52 Program (Third ISA Forum of Sociology) with research contributions from Southern Europe and Latin America countries. A steep forward in Global Dialogue, open to discuss the challenging times across Southern Europe and Latin America. First step is made for critically reflect on policies, publics and professions in this particular contexts, and new theoretical approaches.

This international handbook brings together a group of 70 authors from all over the world. In 39 chapters key themes in the debates over changing healthcare policy are addressed. <u>The Professions, State and the Market: Medicine in Britain, the United States and Russia, Mike Saks (Abingdon: Routledge, 2015)</u>

The book is published in hardback (ISBN 978-0-415-67438-6) and is priced at £95.00.

This unique book enhances our understanding of the links between professions, the state and the market – and their implications for the public in terms of professional practice. In so doing, the book adopts a neo-Weberian perspective, in which professions are seen as a form of exclusionary social closure based on legal boundaries established by the state.

To illustrate the overarching theme, the book considers how healthcare in general, and medicine in particular as a form of professional work, is organized in public and private arenas in three societies with different socio-political philosophies - namely, Britain, the United States and Russia. As such, it examines the varying extent to which the development of independent professional organizations has been enhanced or restricted in public, as compared to more privatized social contexts. The comparative perspective adopted in this book thereby provides insight into the organization of professional work in different contexts and the all-important effects of this on delivery to the public.

<u>From Vocational to Professional Education. Educating for social welfare</u>, edited by Jens-Christian Smeby and Molly Sutphen. Routledge 2015

During the last few decades there has been an academic drift in professional education, especially for many shorter professional programmes. Many of these shorter programmes have left the realm of vocational education to enter higher education. On the one hand, graduates are confronted by an increased demand for research and evidence-based knowledge, and on the other, they are criticised for lacking the knowledge and skills relevant for professional work. *From Vocational to Professional Education* presents new research into programmes suggesting how best to prepare students for professional work and addresses the challenges facing the education of professionals for social welfare. The book identifies and clarifies key problems, as well as outlining the political and historical context in which they are embedded. Chapters discuss theoretical and analytical ways to address these challenges and suggest recommendations for the further development of education for professional practice.

Proposal for a special issue: Twenty-five Years since "P2": Taking stock and charting the future of the professional organization

2015 marks the 25th anniversary of Greenwood, Hinings and Brown's (1990) seminal paper on the "P²" archetype of the professional partnership, presenting an opportunity to take stock and consider the future of studies on professional service firms (PSFs) and professional organizations more broadly. PSFs, such as law, accounting, consulting and engineering firms, but also more broadly those in lesser-researched occupations like architecture, reinsurance or executive search (von Nordenflycht, 2010) are commonly recognized as lubricants of the world economy, but also economic powerhouses in their own right (Brint, 1994; Muzio, Brock, & Suddaby, 2013).

Much has happened in the professional service landscape - and its scholarship - over the past 25 years. For instance, the liberalization of the legal market in the UK and elsewhere has led to outside ownership and "Alternative Business Structures". The "Big Four" accounting firms are showing a renewed interest in the provision of legal services and rekindling debates about multidisciplinary practices (Greenwood & Suddaby, 2006). What does the liberalization of professional service markets mean for the governance, management, and professional ethics of PSFs? While the "P2" archetype was introduced to account for the "distinctive characteristics" of professional partnerships 25 years ago, to what extent are they still distinctive today? Or, do we need to shift attention to understanding how PSFs may be different from each other (Malhotra & Morris, 2009) and, in fact, similar to other types of organizations? If so, what can different types of PSFs and/or other organizations learn from each other? More broadly, as PSFs diversify and internationalize, what are the dynamics between international, multi-disciplinary ambition and national, professional oversight (Smets, Morris, & Greenwood, 2012)? What kinds of institutional work do professionals, clients, firms, and field-level actors perform to shape professional landscapes to their tastes? In the quest for profitability, the focus of innovation is increasingly shifting from service to process and business model innovation, going beyond outsourcing and value chain disintegration (Sako, 2013) to produce entirely new service delivery models, including virtual firms and subscription based payments. What new models of innovation, but also business models and organizational forms are emerging? Finally, how are individual professionals incentivized to accomplish all this? Specifically, how do PSFs accommodate the work-life preferences of millennials (Malhotra, Morris, & Smets, 2010). Will the 'up-or-out' system, a cornerstone of the professional partnership (Gilson & Mnookin, 1985, 1989) disappear? And, if so, what would replace it to keep millennials engaged?

To address these questions, we invite scholarly papers from a wide range of disciplines and academic perspectives on the topic. We welcome contributions grounded in organizational theory, the sociology of the professions, business history, communication studies, evolutionary economics, political science, strategy, economic geography, and anthropology.

The editors (Michael Smets, Saïd Business School, University of Oxford, UK; Tim Morris, Saïd Business School, University of Oxford, UK; Andrew von Nordenflycht, Simon Fraser University, Canada; and David Brock, Ben-Gurion University, Israel) call for contributions.

New global trends have significant implications in society, introducing new issues in professions and professionalism. However, this new challenges are not similar across the globe. Studies have primarily looked at western countries, and little is known on professions in other parts of the world. The specificity of some regions and their countries opens new possibilities for research in the field of professions and professionalism. The impact of global transformations in particular contexts call for a critical revision of the current theoretical approaches, including material drawn from research country cases, local perspectives and contexts.

While the sociology of professions originally was developed within an Anglo-American context, emphasizing professional autonomy and the key role of the professional association, professionalization patterns, in continental Europe, characterized by the role of a strong state, highlighted regional and national differences. Neoliberal reforms, globalization and new emergent economies have fundamentally expanded the scope and practice of the professions.

The special issue invites contributions that present empirical research carried out in south and eastern countries.

Deadline for submitting abstract is **15 July 2015** and the preliminary deadline for submitting full paper is **1 March 2016**. All papers will be peer reviewed.
