Guidance on Health Practitioner Regulation

Several members of ISA RC52, along with colleagues from Hong Kong, Canada, and Australia, conducted a large-scale study for the Health Workforce Department of the World Health Organisation (WHO). Mike Saks (University of Suffolk) was a member of the Technical Expert Group, and Ivy Bourgeault (University of Ottawa) and Stephanie Short (University of Sydney) were members of the research team, along with Giorgio Cometto, Coordinator of human resources for health policies, norms, and standards at the World Health Organisation in Geneva.

The international team of sociologists and health service researchers was successful in responding to a Request for Proposals to provide evidence on the 'Design, Reform and Implementation of Health Practitioner Regulation across Countries' in mid-2021, and the project was completed at the end of 2022. Funding for the study was provided by the European Commission and the Federal Ministry of Health (BMG) of Germany through grants administered by the Health Workforce Department of the World Health Organization.


During the COVID-19 pandemic, the researchers and technical experts were unable to meet in person during the course of the study. However, they adopted a rapid review approach; conducting integrative analysis of literature published between 2010 and 2021, and searched 14 databases using a systematic strategy. The large-scale review synthesised evidence from 410 academic sources and 426 sources from the grey literature relevant to health practitioner regulation. Findings were categorised into themes derived from a modified Donabedian framework, including health practitioner regulation structures, processes, and outcomes.

The resulting 'Guidance on Health Practitioner Regulation' will be the first WHO product on this subject to be used by Member States. It will be informed by the evidence provided by the systematic review commissioned by WHO and inputs from the Technical Expert Group. In fact, this was the most interesting aspect of the study, involving the integration of scientific findings from the systematic review with advice from the international Technical Expert Group, which comprised regulators, researchers, and practitioners from low, middle, and high-income countries.

Health practitioner regulation systems are primarily designed to promote patient safety and support health workforce availability, accessibility, quality, and sustainability. While there was a good deal of evidence on HPR structures and processes, most studies were descriptive, resulting in a low certainty of evidence. Limitations were also identified in the evidence base across jurisdictions and professions, emphasising the need for more evaluative research on regulatory outcomes.

The main takeaway from the study is that sociologists of the professions are well-positioned to inform the future of health practitioner regulation by tracking and evaluating the impact of innovations in health practitioner regulation systems and analysing how interventions affect patient safety, the health workforce, and health systems goals. Papers are currently being prepared for publication, and the findings will be reported at the forthcoming ISA Congress in Melbourne.

The book presents a collection of studies covering different countries and professions to demonstrate the analytical potential of the within-between-beyond model. The conclusions show how "neo-liberal" professionalism is putting the very idea of collegiate professions at stake while exposing emerging professions to market risks.
