

Meet Dr. Rosemary Barberet Who Just Got Elected to the UN Executive Committee of the NGO Committee on the Status of Women

Dr. Rosemary Barberet is a professor at John Jay College of Criminal Justice, City University of New York, in the United States; a former member of the ISA's Executive Committee; and a representative of the ISA to the UN. She is a member of RCs 05, 29, 32 and 46. Rosemary just has been elected by acclamation as member-at-large of the Executive Committee of the NGO Committee on the Status of Women, NY (or NGO CSW/NY). The NGO CSW/NY convenes global civil society for the annual UN Commission on the Status of Women (CSW) session in New York City and does global gender equality advocacy. The organization's main project is organizing the annual NGO CSW Forum during the CSW annual meeting. The NGO CSW/NY wants to bridge the gap between the official UN Commission on the Status of Women process in New York and global civil society as well as grassroots organizations.

RC46 member Rosemary Barberet, with six graduate students at John Jay College of Criminal Justice, City University of New York, USA, conducted a systematic content analysis of the most recent State Party Reports and Common Core Documents to the Committee on the Elimination of Racial Discrimination of the United Nations, on compliance with Article 5(a) of the ICERD convention regarding efforts taken by states to prevent law enforcement racial and ethnic discrimination. They presented it at a side event of the 32nd session of the Commission on Crime Prevention and Criminal Justice in Vienna. Passcode: mR589Mj* They were later invited to present it directly to CERD in a closed session on August 25th. Findings revealed that most State Parties who mention taking action have either developed anti-discrimination plans or strategies, or conducted human rights/anti-discrimination training with law enforcement. The reports rarely mentioned research, data or statistics on this topic. The full findings will appear in an academic article.

Rosemary was also elected by acclamation to the Executive Committee of NGOCSW, a large coalition of feminist NGOs active at the United Nations (https://ngocsw.org/)

News from Melati Wan

Received grant by IPWSO and Friends of IPWSO USA: PWS CIRCLE: EMPOWERING FAMILIES, ENERGIZING LIVES (International Prader-Willi Syndrome Organization US [IPWSO] and Friends of IPWSO) (USD 1,500) 1 Sept. 2022 – 31 March 2023 (Chief Investigator). This fund enables us to conduct a Support Group for Parents with Prader-Willi Syndrome using a Clinical Sociological approach.

As Deputy Director of Eradicating Poverty Impact Lab, I have led and organized a few programmes to empower low income households, promote healthy well-being, and support income generation activities.

- a. **Pasar Makmur** "Pasar Makmur" is a transformative weekly bazaar that spans over seven weeks, designed to create a platform for low-income households to showcase their products and entrepreneurial skills at Taylor's University. This initiative not only provides an opportunity for these individuals to promote their brands and generate income but also encourages the development of valuable entrepreneurial skills. Beyond financial gains, Pasar Makmur fosters a sense of community and networking among participants, promoting a supportive environment where individuals can learn from one another and collectively strive for economic empowerment and success.
- b. **Fit.Ria** "Fit.Ria" is a transformative initiative that partners with local celebrities to champion healthy living and well-being among low-income households, a demographic often challenged by prioritizing health amid pressing survival needs. This program offers participants an opportunity to engage in rejuvenating yoga and stretching exercises, providing physical and mental relief. Moreover, it introduces essential concepts of mental well-being and encourages the adoption of healthy eating and lifestyle choices. By combining the influence of local celebrities with holistic wellness practices, Fit.Ria empowers individuals to take proactive steps toward improving their health and overall quality of life.
- c. **MyPeriod Story** "MyPeriod Story" is an impactful initiative dedicated to educating high school students about the pressing issue of period poverty. This program is a collaborative effort that brings together a diverse group of experts, including health practitioners, social entrepreneurs, NGOs, and psychology and sociology specialists. By pooling their collective knowledge and resources, MyPeriod Story seeks to shed light on the challenges faced by those affected by period poverty and create a supportive and informed community. Through education and awareness-building, this initiative empowers high school students to become advocates for change, fostering empathy, and inclusivity while addressing a critical social issue.



d. **Ibu.Niaga** - "Ibu.Niaga" is a remarkable project dedicated to empowering women micro-entrepreneurs. Through a series of workshops focused on motivation, resilience, and various essential skills like innovative pastry making on a budget, financial literacy, and effective business promotion, this initiative equips women with the tools they need to succeed. The project takes it a step further by encouraging participants to share their stories on social media, amplifying their voices and building a supportive community. To put their newly acquired knowledge into practice, "Ibu.Niaga" provides a unique opportunity for income generation with a two-day bazaar right on the Taylor's University campus. This comprehensive approach not only fosters economic empowerment but also promotes personal growth and community building among these inspiring women entrepreneurs


Recent Publications in Clinical Sociology
