3rd UN Regional Forum on Business and Human Rights in Eastern Europe and Central Asia	In 2011, the UN Human Rights Council unanimously endorsed the UN Guiding Principles on Business and Human Rights (UNGPs), which have strengthened its position as the authoritative global framework on business and human rights (BHR) and provide a fundamental basis for governments and businesses to contribute to the achievement of the Sustainable Development Goals (SDGs). However, implementation of the UNGPs in the Eastern Europe and Central Asia (ECIS) region remains uneven. The numerous crises in the region further complicate the effective implementation of the Guidelines. The current situation imposes additional responsibilities on both authorities and companies to comply with internationally recognized human rights standards and corresponding constitutional guarantees in times of conflict. The UNDP scoping study on the state of implementation of the UNGPs on business and human rights in Europe and Central Asia, which will be presented during the event, addresses some of these challenges and seeks to identify current trends and key developments in the region. Ensuring healthy diets for all in face of a warming planet: Challenges,	The 3rd UN Regional Forum on Business and Human Rights in Eastern Europe and Central Asia will take place on 10-11 November 2022 in Istanbul (in a hybrid format). The event is organized by UNDP, the UN Working Group on BHR and other partners. This is the annual UN meeting which follows the 1st and 2nd Regional Forums on Business and Human Rights held in 2020 and 2021 and seeks to serve as the ECIS BHR regional platform that allows exchanges among the ECIS countries about their experiences and challenges in advancing the business and human rights agenda. The platform gathers representatives of national governments, multilaterals, civil society, NHRIs, trade unions, academia, and businesses (of all kinds, state-owned enterprises, extractive industry companies, transnational supply chains and SMEs). The 3rd UN Regional Forum will discuss the key challenges to the implementation of the UNGPs in the region, with a focus on the obstacles arising from the crises. These will include the development of laws and policies, the introduction and implementation of Human Rights Due Diligence (HRDD) by businesses, and the role of the State as an economic actor in crisis decision-making. In addition, it will address key regional trends, challenges and opportunities for the business and human rights agenda in the ECIS region, with particular attention to the implications brought by conflicts and other crises, including the war in Ukraine on the political, economic, and human rights situation in the region; upcoming EU's directive on HRDD, human rights protection in extractive industries, the role of trade unions, persistent discrimination and inequalities in business practices, and shrinking civic space for human rights defenders. The event will also explore views on the development of a regional roadmap for scaling up implementation of the UNGPs over the next decade. Permanent Forum of People of African Descent	The Office of the United Nations High Commissioner for Human Rights is pleased to announce that the first session of the Permanent Forum of People of African Descent will take place from 5 to 8 December 2022 in Palais des Nations of the United Nations Office in Geneva, Switzerland. In August 2021, the General Assembly adopted resolution 75/314, which operationalized the Permanent Forum of People of African Descent as "a consultative mechanism for people of African descent and other relevant stakeholders" and "as a platform for improving the safety and quality of life and livelihoods of people of African descent." The Permanent Forum also operates as an advisory body to the Human Rights Council, in line with the programme of activities for the implementation of the International Decade for People of African Descent and in coordination with existing UN mechanisms promoting action to combat racism against people of African descent. UN Biodiversity Conference (COP 15)	Despite on-going efforts, biodiversity is deteriorating worldwide and this decline is projected to worsen with business-as-usual scenarios. The UN Biodiversity Conference will convene governments from around the world to agree to a new set of goals for nature over the next decade through the Convention on Biological Diversity post-2020 framework process. The framework sets out an ambitious plan to implement broad-based action to bring about a transformation in society's relationship with biodiversity and to ensure that, by 2050, the shared vision of living in harmony with nature is fulfilled. The Conference will also look at the implementation of the protocols of the Convention on Biological Diversity (CBD) that deal with the fair and equitable sharing of benefits from the use of nature, and the safe transport, handling and labelling of Living Modified Organisms. The first part of COP-15 included the opening of the Meetings and addressed agenda items that were identified as essential for the continuation of the operations of the Convention and the Protocols by the Bureau. This included meetings about administrative matters and technical issues related to CBD programmes. There was also a high-level segment on 12 and 13 October 2021. Participants focused on the development of the post-2020 global biodiversity framework.
