She was an avid reader who loved travel, pansies, zebras, crows, the moon, pine trees and ferns. She led a very full, interesting and happy life.

She is survived by her husband of 56 years, Thomas L. Clark, Jr. A son, Thomas (Susan) Clark of Framingham, MA., two daughters, Stacey (Richard) Ruby of Glasco and Krista (Gordon) Clark of Schodack Landing, NY. Two brothers, William and Edward Johns both of Pennsylvania. Six grandchildren: Sarah and Rachel York, Clancy and Tommy Clark, Kelsey Reed and Max Autenrieth and several nieces and nephews also survive. She was predeceased by a sister, Eleanor Jodun.

## Dr. Jacques Rheaume awarded the Lester Ward Award by the Association of Applied and Clinical Sociology

I am very pleased to nominate Dr. Jacques Rheaume, for AACS's Lester F. Ward Award. I can't say enough about what a pleasure it has been to work with Dr. Rheaume over the last 30 years. Dr. Rheaume has made significant developments in the fields of applied and clinical sociology particularly in Quebec, Canada; France and several countries in South America. One of his five books (co-edited) has won the book award from the clinical sociology division of the International Sociological Association. When he was the Scientific Director at the Center for Health and Social Services (which focuses on immigration and refugee issues), he developed a new orientation for the social research program which put a clinical sociological approach in place as a regular policy and introduced a participatory action-research approach. This encouraged other research centers in Montreal and the whole province and was financially supported by the government and involved a partnership among universities, public services and the community. He has been President of the International Sociological Association's division on clinical sociology and is currently a Vice President of the organization. He has been a main reason that international practice meetings go so well; he tirelessly encourages participation and translates for those from different parts of the world.

Professor Emeritus at the University of Quebec in Montreal (UQAM) where he was head of the Department of Social and Public Communication. He is a member of the SHERPA Research Institute in Montreal Center-West Area, He was the Scientific Director of the Center for 12 years and currently is an associate member of the Research Center for Health and Communication at UQAM. He was President of the Clinical Sociology division of the International Sociological Association. He is a member of AACS also is an active member of the CAPACS board.


