Challenges of the 21st Century: Democracy, Environment, Inequalities, Intersectionality

RC52 will meet at the Fourth ISA Forum of Sociology in Porto Alegre, Brazil, 14-18 July 2020. The is Forum is designed as a mid-term meeting of Research Committees (RCs), Working Groups and Thematic Groups. The theme of the ISA Forum in Porto Alegre is *"Challenges of the 21st Century: Democracy, Environment, Inequalities, Intersectionality"*

The selection of abstracts has now been completed – everyone who submitted an abstract should have received an email regarding the status of their abstract. Researchers from all over the world will participate – a total of 8624 abstracts have been accepted. RC52 has 19 sessions comprising 122 papers. The RC52 sessions include a Board meeting; two invited sessions, one highlighting early career researchers and PhD students and the other focusing on 'Global Perspectives; with research contributions from Brazil, Mexico, Australia, and South Africa and a number of joint sessions. RC52 will host three joint sessions with RC17 (Sociology of Organisations), RC01 (Armed Forces and Conflict Resolution) and RC30 (Sociology of Work). RC52 also participates as a secondary RC in three other joint sessions with RC15 (Sociology of Health).

What's next? Registration for paper presenters must be completed by **19 March 2020 24:00 GMT.** Registration must be paid by the deadline and presenters who fail to register will be automatically deleted from the program. The final programme will be available (online) in 5 May 2020.

If any participants require a formal 'Letter of Acceptance' from a Session Organiser please will you email your request. Session Organisers should note that the ISA Secretariat has prepared a model letter for each RC which can be requested at <u>isa@isa-sociology.org</u>.

A limited number of registration grants are available to individual ISA members in good standing (ie paid-up ISA members) who are active participants in the conference programme. Applicants should send an email requesting a registration grant to the Programme Coordinators by 31 January 2020. Applications can only be submitted to one research committee.

- *Registration deadline for presenters:* 19 March 2020 24:00 GMT.
- Session organisers finalise sessions and assign chairs and discussants: 1-17 April 2020 24:00 GMT

Dynamics of Professions and Professionalism: Performance, Quality and Trust 25-28 August 2020, Utrecht University

Call for papers

Ongoing societal changes strongly influence professions and professionalism. For instance, the internet has an impact on the availability of information and on the way in which people communicate; the pace of technological development – including artificial intelligence – is leading to the automation of a growing number of professional tasks. Meanwhile, globalisation, migration and changing geopolitical relationships are affecting the organisation of global production processes. In addition, professionals are becoming more connected across organisational, sectoral and national boundaries.

These changes have far-reaching consequences for the society in which professionals operate and for the organisations in which professionals work, in addition, they change the relationships between them and professional groups. Furthermore, the change occurs in the nature of the tasks that professionals perform; roles in which they work; and, what is expected and required of them in general.

During this conference, we want to emphasise the changing tasks and roles of professionals, the expectations and requirements they face, and the implications for the development of expertise during their working life. Issues concerning the connection between work, development and lifelong learning are highly important in such a context.

In taking this stance, we also offer space to different disciplinary perspectives on these issues, especially, but not only, disciplines that have their focus on specific professions (such as the life sciences, law, psychology, educational sciences, and veterinary sciences). Furthermore, with a few round tables and/or forum debates, we also want to engage in dialogue together with representatives of professional organisations.

The following broad questions will guide the discussion:

- 1. How do changing social demands and social contexts influence the professions and professional organisations as well as the dynamics of developing/changing professions?
- 2. What factors are central in organising professional quality and trust, in different domains?
- 3. How does socialisation take place, how do professionals learn, how do they acquire relevant expertise, and how do they adapt to changing contexts?
- 4. We invite papers, both empirical and theoretical, on established and emerging professions, concerning these and /or other related issues.

XXXII International Congress of the Latin American Association of Sociology (ALAS) and the IX Congress of the Latin American Association of Work Studies (ALAST)

The biannual edition of the *International Congress of the Latin American Association of Sociology (ALAS)* was held from 1–6 December in Peru, Lima. It brought together sociologists from all over Latin America, as well as, sociologists from other parts of the world who are working on issues in the region.

There were a total of 25 working groups, focusing on different topics (equivalent to the ISA Research Committees and Working Groups), and more than 3000 speakers present in the Peruvian capital.

GT17 Work and Productive Restructuring, is the working group that brings together issues that are relevant to RC30, RC44 and RC52 of ISA. A variety of round tables and panels were organsied. There we participated with several colleagues who integrate this RC52, with different presentations, among them who subscribe.

Furthermore the *IX Congress of the Latin American Association of Work Studies (ALAST)* was held in Bogota, Colombia, from 10-12 July of this year. Here topics related to the RC30, RC44 and RC52 of ISA are also addressed. There were also many colleagues from RC52 present.
