Towards an Understanding of Complex Phenomenon: Applying Partial Order Theory to Multi-Indicator Systems

University of Neuchâtel, Department of Sociology, 26-27 October 2018

Briefing Report

The description of complex phenomena in different scientific fields (such as poverty, well-being, sustainable development, social progress, quality of life, social cohesion, vulnerability, environment risk assessment) by a set of indicators has become increasingly important. When a decision is to be based on this set of indicators then ranking is one of the possible applications. Although indicator systems are widely applied and statistically investigated, there are still many questions open, when partial order is to be applied:

- How could we find latent indicators?
- Can indicator systems be partitioned into a main part and parts considered as “fine tuning”? More generally: Can we define a hierarchy of indicator systems, when a certain complex phenomenon is to be studied?
- Can we explore the indicators, for example can we state that one set of indicators implies another set of indicators?
- Sometimes indicators are built of real data, what then is the advantage of partial order and how could we find a set of implications?
- If indicators are measured ones, then how to deal with data uncertainties?
- How can we include the qualitative knowledge, which cannot be expressed by indicators-for example with respect to simple aggregation schemes: how to include weights within the framework of partial orders?

In this framework, the 12th International Partial Order Conference on Partial Orders in

Applied Sciences hosted by the Department of Sociology of University of Neuchâtel on October 26-27, 2018, has addressed various multi-indicator systems questions both at methodological and application levels. More specifically, twenty-three papers from different disciplines are presented through seven workshop sessions which have focused on the general role of multi-indicator systems, indicator systems and their analysis, methodological issues in posets (*partial order sets*), application of posets in different areas such as social sciences, environmental systems, biology and technical systems.

In general role of multi-indicator systems session, Jochen Wittmann (University of Applied Sciences HTW Berlin) has explained the demands on and specification of indicators for modelling and simulation environmental systems, Filomena Maggino (Sapienza University of Rome) has emphasized the role of indicators in the framework of partial order, and Fabio Sartori and Gemma Asero (European Commission-Eurostat) have addressed complex information system in the area of contemporary statistics with a specific focus on conceptualization and evaluation of dominance in sports. The indicator systems and the analysis session has included presentations on building rankings from hierarchical systems of ordinal indicators by Marco Fattore and Alberto Arcagni (University of Milano-Bicocca), assessing inhomogeneous indicator-based typologies through the reverse clustering approach by Jan W. Owsinski (Polish Academy of Sciences), a partial ordering approach in aggregating dimensions of subjective well-being by Paola Conigliaro (Sapienza University of Rome). In two posets methodological sessions, performance of Hasse Diagrams, sampling and weighting process are discussed by six different papers: Tournaments tables, power-weakness ratio and Hasse diagrams (an informative combination for multi-criteria decision-making) by Roberto Todeschini (University of Milano-Bicocca), evaluations as sets over lattices (mathematical basis) by Adalbert Kerber (University of Bayreuth), evaluations as sets over lattices (application point of view) by Rainer Bruggemann (Leibniz Institute of Freshwater Ecology and Inland Fisheries), some efficient sampling designs based on partial order sets by Bardia Panahbehagh (Kharazmi University), introduction of weights in poset-based synthetic indicators by Giulio Caperna (Joint Research Center of the European Commission), towards an understanding of weightings by partial order theory by Rainer Bruggemann (Leibniz Institute of Freshwater Ecology and Inland Fisheries). Moreover, various papers focusing on application of posets have brought both methodological and application process debates on measuring and understanding complex phenomena in different areas. Lars Carlsen (Awareness Center Denmark) has presented the role of posets

in happiness analysis, Tugce Beycan (University of Neuchâtel) has underlined how the posets analysis can be useful for testing the robustness of Multidimensional Poverty Index ranking with a case study in Karnataka, Enrico di Bella (Università degli Studi di Genova) has showed a comparison of different techniques to build synthetic indicators for measuring gender equality, Stefan Markus Giebel (Criminological department of Thuringia) has presented the application of posets within a fear and punitivity study in the prison population of Thuringia. Concerning environmental systems, the studies of dependent indicators for environmental evaluation of desalination plants in Kuwait by Ghanima Al-Sharrah (College of Engineering and Petroleum Kuwait), alternatives assessment frameworks (split-shots as an exemplary) by Lars Carlsen (Awareness Center Denmark), implementation of Hasse Diagram technique in environmental risk assessment by Stefan Tsakovski (University of Sofia), identifying drivers of land degradation in Xilingol in China (from 1975-2015) by Batunacun and Ralf Wieland (Leibniz Centre for Agricultural Landscape Research-ZALF) are presented. In addition, Nora Pankow (Technische Universität Berlin) has showed the role of indicators for sustainability assessment in the procurement of civil engineering services, and Ulfia Lenfers (Hamburg University of Applied Sciences) has explained the exploration of survival strategies of African trees and bushes in two different landscape by posets. The 2018 conference on „Social Monitoring and Reporting in Europe“, which addressed the theme „Inequalities, Fairness and Solidarity Across Generations – Measurement and Analysis“, was the 13th in a series of annual meetings of the European Social Reporting Network, organized by Heinz-Herbert Noll, who is supported by a conference committee. The series that started in 2006 with an Italian-German dialogue about similarities and particularities in social reporting within the two countries compared, developed progressively into a pan-European event. Each conference addresses a special theme as for example “Resilience: An Asset in Difficult Times?” or “Measuring and Monitoring Social Progress in European Societies”, but also informs about recent developments in social monitoring and reporting. Since the beginning, all the conferences were hosted and supported by the Villa Vigoni (www.villavigoni.eu), a German-Italian centre for European excellence. 5. Call for papers for The Social Structure of Subjective Well-Being: Education, Status and Social Mobility 2019



The Social Structure of Subjective Well-Being: Education, Status and Social Mobility

3rd to 4th of October 2019

An international conference hosted by the University of Luxembourg
Institute of Education and Society & Institute for Research on Generations and Family
University of Luxembourg (Campus Belval), Esch-sur-Alzette, Luxembourg

Theme

Subjective well-being (SWB) is a major goal of human actions. For a long time, SWB has been mainly studied by psychologists. Fuelled by an interest in how social structures and (material) conditions shape subjective perceptions, attitudes, and values, sociologists have successfully entered the field of SWB research in the last two decades. A main objective has been to show how socio-economic characteristics such as class, status, prestige, education as well as gender or migration background, cultural variables such as ethnicity and religion and critical life events shape SWB. Furthermore, the association of GDP, unemployment rates, welfare policies, migration policies, and value climates with SWB have been high on the research agenda. While the state-of-research has provided many valuable insights and helped advance sociological research, it also generated mixed findings and mixed interpretations.

Against this backdrop, this international conference aims to shed light on how socio-economic characteristics such as class, status, and education as well as other ascriptive factors such as gender and migration background structure SWB. We hope to induce debates on past and current research regarding several questions from a social science perspective: Which conceptual and empirical mechanisms explain the link between structural indicators and subjective well-being? What is the impact of absolute and relative social positions on subjective well-being? How does the distinction between hedonic and eudemonic add to the current measurement practices in the social sciences? How do new ways of social interaction affect SWB, e.g., through social comparison via social networks? What makes a liveable society?
