From the Secretary

I apologise for the lateness of this newsletter; I had hoped to send it out in September, but it has been delayed as I waited for the full details of Amsterdam conference plans.

It had also been expected that this issue would include plans for the election of a new Executive Council. However, members may not have realised that we had accidentally reached a position where our last elections were out of phase with the requirement of our statutes, which is that officers should change at the World Congress. That means that we can now *either* observe the 4-year interval between elections, *or* hold them for the next World Congress, but not both. Prof. Immanuel Wallerstein, the President of ISA, was consulted about how we should deal with this situation, and your Executive Council has agreed to follow his advice. This is that we should delay the elections until the period before the World Congress, *unless members object. Any members who do object to this should, therefore, let the Secretary know before the end of the year.* If there are sufficient objections, there will be just enough time to start the process for a handover at Amsterdam, which would be to an EC whose term of office would be only 2 years. (On a personal note, I am prepared to continue for another 2 years as Secretary if it is in the best interests of RCHS, but I would be very happy if a willing successor were to emerge.)

Once again we owe special thanks to Martin Bulmer, and to Miriam Chall of Sociological Abstracts, for their valued help in sending out some copies of this newsletter, thus saving us some money and the Secretary some work, and also to Dirk Käsler for his assistance in our financial affairs.

1996 Conference

Intellectual plans

Conference plans are now well forward, with modifications to earlier proposals in the light of the papers actually offered. A provisional list of sessions is given below; this may be further modified later if paper-givers' plans change. The order in which sessions and presenters appear below, and the division of papers between sessions for those topics which have more than one, has no significance; the precise timetable will be decided later. At present, it appears that we shall need to run some parallel sessions in order to accommodate all the papers offered. It is not easy to guess which clashes would cause most problems to members in deciding between them. You are, therefore, invited to send to the Secretary by the end of the year a list of the sessions (using the numbers below) which you are most interested in attending; if sufficient members do this, that will give guidance on the timing of sessions and the choice of rooms. If sufficient do not, intuition will replace democracy. The registration slip can be used for this. Final plans, in the light of response, will be in the spring newsletter.

Practical arrangements

The conference is to be held at SISWO (to whom we are most grateful for their support.) Sessions will start at 1.30 p.m. on Thursday May 16, with welcome drinks in the early evening, and will finish at lunchtime on Saturday May 18; Thursday and Friday evenings will be free. Saturday afternoon will be free for sightseeing, and that evening there will be a conference dinner at an Indonesian restaurant (with wide choice of dishes), maybe preceded by a sociological boat trip. Registration

Advance registration is not essential, but it will be very helpful in ensuring that appropriate arrangements are made to give advance notification of your intention of coming. Places at the conference dinner require advance booking. For your convenience, a slip to send is provided on the front page of this newsletter. For RCHS members there is no conference fee. For non-members (which of course includes old members who have failed to renew their membership) the fee is \$30, or \$15 for students or people from non-OECD countries; it should be paid to RCHS (not Dick Pels) in advance by the same means as RCHS dues (see dues instructions at the back) or, if that is difficult, in cash on arrival.

News and Notes

Recent correspondence in the British Times Literary Supplement has raised an issue which might be of interest to all of us. An enquirer found that parts of the institutional records of the London School of Economics from as long ago as the 1930s were not open. He suggests that public bodies such as universities should not operate rules about access which are even more restrictive than those applied to government records, which in Britain are normally open after 30 years. Are there significantly different conventions in these matters in other countries? Do universities normally keep their records, or at least important parts of them, so that future access will be possible? Do they have policies about access by researchers? Should we be enquiring about what happens in our own institutions, and perhaps pressing for the development of suitable policies? Comments and suggestions on this issue are invited for future newsletters.

Klaus Lichtblau has completed his work on the history of the German tradition of cultural sociology. His Habilitationsschrift, Kulturkrise und Soziologie um die Jahrhundertwende - zur Genealogie der Kultursoziologie in Deutschland, will probably be published in the second half of 1996.

Abstracts project

The Research Coordinating Committee of the ISA has started a project to disseminate more widely sociological work not abstracted in the major data bases, and so often not drawn to the attention of the international community. The plan is to make regular English-language abstracts of suitable articles, to be published in Sociological Abstracts (SA); each Research Committee has been asked to contribute articles from its field.

The proposed plan of action is this. We should identify some journals, publishing work in the history of sociology, which are not part of the current data bases of SA or the Social Science Citation Index, and preferably in languages other than English, French or German. Articles in them which have been published in the previous 9 months, and are likely to be of interest to the international sociological community, should be selected, and English abstracts provided in SA format. (Perhaps abstracts already available could be translated, or the author asked to provide one? Members would need to arrange this.)

I do not know how many members would wish to play an active role in this, but it would be a good idea for the work to be shared and for the widest possible range of journals to be covered. Members are asked, therefore, to let the Secretary know if they would be prepared to be involved, and to send her the names of suitable journals with which they are familiar. She will then follow the matter up in the light of the response. In the meantime, since a swift first response is asked for, she has written individually to a few members in likely countries to ask if they can make an initial contribution.

The European Union's Framework 4 programme 'Training and Mobility of Researchers' (formerly 'Human Capital and Mobility') provides attractive conditions for doctoral or postdoctoral students or researchers to go to another EU country to advance their training and take part in a project there. Applications have to be made by the person who would move, but in consultation with the institution that they would visit. Obviously one of the difficulties of establishing such arrangements is that the prospective partners need to know of each other's interests before an application can be considered. If any RCHS members would like to invite such visitors, or to make such a visit, it could help to make appropriate contacts if colleagues elsewhere were informed. You are, therefore, invited to send in very brief details of your interest and possible projects, to appear in this newsletter, so that other colleagues may get in touch.

Trudy Dehue, Changing the Rules (Cambridge University Press, 1995), is an interesting case study of psychology in the Netherlands; it argues that changes in methodological ideas respond to the social context rather than purely to internal disciplinary growth.

We now have a facility for paying to the central ISA, which will enable those who wish to use a credit card; a copy of their form is attached to enable you to do this, and it can be used even if you are not at that time also paying the ISA subscription. *(If you do this, it would be very helpful if you could also send the form below to the Secretary so that you can give her any news items you have).* Here - with apologies for the complexity, which our need to avoid our account's high foreign-exchange charges makes necessary - is how to pay if *not* doing so via the ISA. **Only people using a British bank account should send their dues to the Secretary**; this can be done either by sending a cheque made out to "RCHS Platt", or by direct transfer to Girobank account 12 574 8302.
