CONSEIL DE RECHERCHE 1980

C'est à Varsovie, du 26 au 30 août prochain, que se tiendra la prochaine réunion du Conseil de Recherche. Les délégués sont attendus à la date du 25. L'hôte de la réunion est l'Institut de Philosophie et Sociologie de l'Académie des Sciences de Pologne. Magdalena Sokolowska, présidente du Conseil de recherche, est l'organisatrice de cette réunion.

L'ordre du jour provisoire comprend les points suivants:

A la demande de Céline St-Pierre, éditeur de l'AIS, la question des publications sera probablement portée à l'ordre du jour. Devront également être débattus deux autres points: les demandes de subvention des Comités de recherche auprès de l'AIS ainsi que les demandes auprès de l'UNESCO. (Les présidents et secrétaires des Comités de recherche ont déjà été invités à soumettre un projet.)

Le point original de cette réunion est ce qu'on appelle familièrement le "Projet Sokolowska". Sauf erreur, ce sera la première fois que le Conseil de recherche prend l'initiative d'éditer un livre. Plus exactement, les "papiers" soumis par les Comités de recherche permettront la publication d'un livre chez Sage et d'un numéro spécial de la revue trilingue de l'UNESCO "Revue internationale des Sciences sociales".

A noter que le Comité de coordination se réunira dans le cadre de cette semaine. Un rapport de ces deux réunions paraîtra dans le prochain Bulletin.

EXECUTIVE COMMITTEE 1980

Last year, the Executive Committee accepted the invitation tendered by Alexander Szalai on behalf of the Hungarian Sociological Association and the Hungarian Academy of Sciences to meet in Budapest. However, local priorities dictated that the timing of these meetings had to be changed. Thus, these meetings will this year take place during the first week of September in Budapest.

In addition to the Hungarian hospitality, we have also been fortunate in obtaining several travel grants which lighten the burden on our so very limited budget.

The agenda for these meetings will contain the usual administrative items that always have to be dealt with in order to keep the Association going. But the most important items will deal with the preparations for the next World Congress in Mexico. For this reason, Julio LaBastida who is in charge of the Mexican Local Arrangements Committee has also been invited to attend. Thus, we hope to be able to publish in the Fall Bulletin such matters as the preliminary program, arrangements for the submission of papers, machinery of handling the applications for ad hoc sessions, details of local arrangements, etc.

THE TRAINING PROJECT

Last year, Kurt Jonassohn drew up a proposal designed to increase familiarity with the work of the ISA in regions where our work is relatively little known. The proposal envisaged a training period of one year for a junior scholar interested in comparative and international research; such a person would be invited to work in the secretariat, visit a few selected research committees, and take a few relevant courses in one of the four universities located in Montreal. The proposal envisaged that such persons would return to their region of origin, pass on to their colleagues relevant information on the work of the ISA, and remain a key contact in their region.

After having been discussed by the Executive Committee, this proposal was submitted to the Canadian Commission for UNESCO and to the Canadian International Development Agency for funding. We are happy to report that both agencies found the proposal original and innovative enough to deserve their financial support. Modest funds were granted for a two-year trial period.

Thus, since April, we have in the secretariat Daniel Dos Santos: a young man from Angola, very bright, speaking several languages, and very keen on becoming more familiar with the work of the ISA.

The ISA BULLETIN is the official publication of the ISA Secretariat, edited by Kurt Jonassohn and Marcel Rafie. Three issues per year appear in Spring, Summer and Autumn with an average printing of 6,000 copies. The ISA BULLETIN is distributed free of charge to members of the ISA.

Current activities

- A. The first official meeting of the Research Committee was a conference on The Social and Political Challenges of the New Economic Order in Comparative Perspective, held at The Study and Conference Center of the Rockefeller Foundation at Villa Serbelloni, Bellagio (Como), Italy, April 24-29, 1979. The conference was also supported by grants from the International Division of the Ford Foundation (N.Y.) and from the International Sociological Association. It concerned four main topics:
 - the transnational corporations and their social impact in the formation of the new world economic system;
 - 2. the reorganization of the capitalist system and new patterns of dependency;
 - 3. the transnational financial institutions, and
 - 4. politics, the state and the new world economic system.

- B. The papers presented at the conference are being revised by the authors and will be edited by Harry M. Makler, Alberto Martinelli and Neil J. Smelser for publication by Sage Publications in 1981. Four of these papers have already been published in French under the title of "Développement National et Economie Mondialisée", in a special issue edited by Arnaud Sales of Sociologie et Sociétés, Presses de l'Université de Montréal, Vol. XI, No. 2, Octobre 1979.
- C. As each Research Committee will ultimately submit a statement on their own special area, concerning the executive committee survey initiated by Magdalena Sokolowska (Vice-President and Chairperson of the Research Council of the ISA)on the theoretical and methodological orientations in sociology, our executive committee has agreed to undertake the responsibility of writing a primary draft.
- D. The first issue of the Newsletter has been published.

Report of activities

- A. Concerning the X. World Congress, which will be held in Mexico City in August 1982, our Research Committee plans to meet soon to define a preliminary program. Report of activities

Our Research Committee is searching possibilities to publish the Uppsala papers. As to date no success has been reached in finding a specific outlet, a number of persons are publishing their papers separately. There is a concern that a substantial portion of the membership remains North Americans. The Research Committee has undertaken a variety of efforts to alter the balance in the past: sending material to all persons present at the Uppsala meetings - not all persons were members of our Research Committee; to ask all Research Committee members to list younger persons, particularly Europeans, who they might know and who were not involved in the Research Committee but might be; Bill Hanna and Ken Newton are conducting a review of these lists and those they have put together in order to organize a mailing to these persons and finally, they are in the process of developing a system of country representatives to inform the Research Committee about persons who are involved in community activities in their respective countries and who can channel information to Bill Hanna to be published in Comparative Urban Research.

Our Research Committee is pursuing the possibility of a special conference on migration patterns, sources, causes and changes. Financial support for this conference is being searched by our German members Guenther Schafer and Gerd-Michael Hellstern. Such a conference would probably be held in Europe and we might not be able to fund travel. This project is being undertaken in conjunction with the Research Committee on Social Ecology.

Report of activities

After the elections, a meeting of the new Board was held in October 1979 to define the new lines and program of the Research Committee.

A list of members is now available and Bjorn Gustavsen is in charge of updating it. Without establishing a rigorous restriction, the Research Committee would primarily expect its members to be academics and generally involved in research in the area. Being of considerable importance for the well-functioning of our Research Committee, the communication with the members will be done by means of a Newsletter containing the decisions and ideas of the Board.

It is also the intention of this Research Committee to start a campaign to recruit new members and to widen their origin. So, Akihiro Ishikawa is to investigate the possibility of developing a regional committee covering Asia and the Pacific; Steve Deutsch is to investigate similar possibilities for Latin America and more tentatively Eric Batstone is to search the extent of any interest in Africa.

In what concerns the Mexico City Congress, our Research Committee is searching possibilities of some form of co-operation with other Research Committees working on areas that might be related to ours, i.e. organizations, sociology of work. This co-operation is saught not only at that level, but also for future joint conferences or workshops.

For a start, the Board decided to organize two workshops per year, each on a selected theme, and under the responsability of a specific Board member. A workshop was already programmed before the Board election by Veljko Rus on "Participation at work and Political Participation" to be held at Dubrovnik, April 1980, during the second meeting of the new Board.

Three other workshops are under planning:

- September 1980, Oslo under the responsability of Bjorn Gustavsen and will focus on the public sector and participation;
- March 1981, Tokyo Akihiro Ishikawa should be in charge of arranging this workshop after further consultation with his colleagues. Preference, without being definitive, was expressed for the theme "The Labour market and participation";
- September 1981, Bled Veljko Rus would arrange this one. If the Tokyo theme is maintained, the main issue of this workshop should be "Professionalization and Industrial Democracy".

Our Research Committee has also decided to publish the papers from a conference/workshop when they should be of sufficient interest and quality, either through journals such as Economics and Industrial Democracy, Organizational Studies, or in book form. Report of activities

- 1. Our Research Committee had its business meeting on the 21st of April, at Trois-Rivières, Québec, Canada. At the same time and place (April 22-25) an International Colloquium was held on "Popular Culture", at the Université du Québec à Trois-Rivières, organized by the Research Committee on Leisure and the cooperation of the Research Committee on Communication, Knowledge and Culture of the ISA and the financial support of several institutions, in particular the University mentioned above (see last page).
- 2. During this year, the Committee will prepare its contribution to the World Congress on the Science of Physical Education, prior to the Moscow Olympic Games. The theme "Sports and Leisure" is being investigated by the Research Committee in cooperation with the Research Committee of Sociology of Sports of the ISA.
- 3. A tentative calendar for the Committee next meetings is being finalized: Manchester (September 1980), Prague (1981), Warsaw (1982) and Mexico City (August 1982 during the X. World Congress of ISA). Some other possibilities are being studied for a meeting in Soviet Union or in one of the developing countries.
- 4. Our Research Committee cooperates with the European Centre for Leisure and Education (ECLE) in Prague and plans are made for widening the contacts of the Committee with the World Leisure and Recreation Association (WLRA), U.S.A.

5. The Committee has been engaged in comparative studies on "Leisure in industrialized countries". The research included the team work of seven countries supervised by Prof. Dumazedier. The findings were published in Society and Leisure. For reasons beyond the control of the researchers, it was not possible to finish these studies. So, new conceptions of international studies are being prepared, and were discussed at the Committee meeting in Brussells, April 1979, and gave rise to the planning of international seminars. The first two were held in Trois-Rivières, Québec, Canada, April 1980, and dealt with "The Study of the Social Times" and "The Relevance of Sociological Research for Leisure Policy and Planning".

6. In order to widen the membership and diversify the international studies of the Research Committee on Leisure, we are sending some of our members to contact researchers in European and underdeveloping countries. Nevertheless, it is a difficult task to realize considering the high costs and expenses of such operation.

Report of activities

1. The Committee has distributed a questionnaire to all members concerning his/her current research activities. The answers are being analysed to prepare a report aimed to facilitate international exchange in the field through the distribution of the findings to all Committee members and research institutions in various countries.

2. A major international conference was prepared by the Committee on the Topic "Economic Crisis and Urban Austerity: Policies and Politics into the 1980s", and it took place at the School of Archi-tecture and Planning, Columbia University, N.Y., 21-24 May 1980 under the official sponsorship and direct responsability of the ISA Research Commit-tee. More than 100 continuents from fifteen tee. More than 100 participants from fifteen different countries have participated to the con-ference. Proceedings of the meetings will be published later.

The Committee is contributing to the project "Present Theoretical and Methodological Trends in Contemporary Sociology" by preparing two essays:

 Urban Sociology in the 1980s: Prospects, Problems and Issues, by Manuel Castells and (2) Urban Socio-logy: the State of the Art, by Elizabeth Le Bas. Both papers should be completed by Spring 1980.

- 4. The Committee is sponsoring a Regional Conference on Urban Sociology organized jointly by the Polish and Yugoslav Sociological Associations. The Conference will meet in Ljubljana, Yugoslavia, in September 1980. Professor Minar, Vice-President of the Research Committee, is in charge of the organization of the Conference.
- 5. The Board of the Committee has formally convened Professor Ivan Szelenyi of Flinders University of South Australia to prepare a project for the program of the Committee meetings in the X.World Congress of Sociology in 1982. Preliminary work to prepare the program and to convene rapporteurs has already started.
- 6. The International Journal of Urban & Regional Research, initiated under the auspices of the Committee in 1977, and published by Edward Arnold Press, is rapidly expanding. In 1979, it became a quarterly and the number of subscriptions rose dramatically, particularly in the United States. The Journal is a major vehicle to publish research produced by most of the Committee's members, although it follows the traditional rules of anonymous review of all submitted articles.
- 7. The Committee has agreed in being open to participate, collectively or individually, in professional expertise for international institutions, although the occasion for such an activity has not yet been provided.
- 8. The Committee has published a Newsletter in December 1978 to report its activities to all members, and is preparing a second Newsletter with the results of our survey on research activities in the field.

Report of activities

The Committee planned, after previous meetings in England, Poland, Canada, Holland and Sweden to have its VI Conference in November 1979 in Augsburg, West Germany, focusing on POLITICIANS - EXPERTS - PUBLIC. Its aim was to discuss and to work out new definitions of the roles of politicians, experts, and the public, thus to provide a theoretical framework for a higher thus to provide a theoretical framework for a higher degree of democratic life in various societies. Due to financial difficulties however, it became necessary to delay the conference. Neither private foundations (e.g. WW, Thyssen, Stifterverband fur die Deutsche Wissenschaft), nor the Federal Government of West Ger-many have been willing to subsidize the meeting. Several interested scholars raise the question if the Board chose the right country for the organization of Board chose the right country for the organization of a conference with such a topic.

The unorthodox activities of the Committee are often not understood - as sociotechnics itself is a source of lots of misunderstandings. Many of its members are interdisciplinary trained. They come from various disciplines. As a rule, every sociotechnician has to be at home in more than just one discipline. Not only for this reason we speak of a new paradigm of social sciences established by sociotechnics. Since the sociotechnical approach is multidimensional, scholars in the Social Sciences Department around the world do not easily grasp its specificity. Sociotechnicians are supposed to remodel old institutions as well as design and implement new ones; its expertise is not just a piece of paper, an airy recommendation, but includes a whole set of activities - is also the practice.

Sociotechnicians additionally assume responsibility Sociotechnicians additionally assume responsibility for their designs and programs. Traditional social engineers usually serve for the "gangs" in power, making them more efficient. Sociotechnical expertise deals with the questions of how to go and where to go, and answers them in a broad perspective based on knowledge available at a given time, drawn from the various disciplines involved.

- Among recent major activities of our Committee are:1) the project to establish a research institute for sociotechnics (IRIS) and2) an initiative for the ISA Research Council to find out the potentialities of the ISA to provide social expertise.

The Newsletter of the Committee issued on a regular basis, reports continuously and in detail on the problems of the committees' interdisciplinary approach, on its prospects, projects and literature. The Newsletter is issued by the Secretariat of the Committee in Cologne (edition: 400 copies).

1979:

1. The most outstanding activity of the Research Committee in 1979 was the conference on "Social Mobility and Processes of Class Formation" held in Berlin (GDR) on October 30 - November 1. The conference was organized by Manfred Lötsch and supported by the Nationalkomitee für Soziologische Forschung bei der Akademie der Wissenschaften der Deutschen Demokratischen Republik. The papers discussed at the Conference related on the one hand to developments in occupational mobility in the succession of generations and in the course of individual's worklife, the relations of mobility processes to the national and inter-national division of labour and to changes in educational, occupational, and industrial struc-tures. On the other hand particular attention was given to the subjective perceptions as well as to the norms and beliefs of individuals regarding inequality and mobility processes in their societies.

1. In August 1978, the Research Committee sponsored a symposium on special criminological topics in Stockholm. The conference concentrated on four major issues: Cohort Studies, Crime and Environ-mental Design, Alternative Sanctioning, and Crime Trends. Report of activities

The Ad Hoc Group on Alienation Theory and Research, founded in 1972, with active sessions in Toronto (1974) and Uppsala (1978), where over 100 papers were presented, was recognized this summer as a Research Committee, and now has over 80 registered members.

Membership:

Those who are active in the field and are interested in joining the Research Committee can do so by writing to R.F. Geyer (see address above), or by phoning (31)20 240075. Exemptions of the membership fee can be granted. After recognition as an ISA Research Committee in Summer 1979, our members were asked to give their preferences for candidates for Board functions. Elections were being held, after having ascertained that the 25 persons on the ballot are indeed available for a Board function; election results for the 12-person Board will be known by early 1980 and will be announced in the next ISA Bulletin (see the results above).

Publications:

Co-organizer David Schweitzer and the undersigned are editing a selection of 13 Uppsala papers at the moment, to be published by early 1981 in London by Routledge & Kegan Paul, entitled "Alienation - problems of Meaning, Theory and Method". A previous selection of Toronto papers, made by the same editors, was published in 1976 by Martinus Nijhoff, the Hague: "Theories of Alienation critical perspectives in philosophy and the social sciences".

A 400-page, 6000-item bibliography on alienation and related subjects, compiles on-line in the Netherlands from some 30 different computerized data files in the US and Europe, with an extended thesaurus to facilitate searches, will be published in March 1980. It can be ordered from the above address: price app. \$35. for non-members, \$25. for members, excl. postage.

An International Journal:

Finally, the Research Committee will have its own international journal on alienation theory and research. Definitive arrangements have been made with Gordon & Breach in London to start publication, as a quarterly, from early 1981 onward. An editorial structure is being organized at the moment.

European Regional Meeting:

The Research Committee has tentative plans to organize a European Regional Meeting, late August 1980, probably in Warsaw, in conjunction with the ISA Research Coordinating Council meeting, where Professor Schweitzer and the undersigned, R.F. Geyer will present a paper on the state of the field, especially from a methodological viewpoint. The realization of these plans will depend on the number of members interested; invitations have gone out already. (Reported by RC 36 Secretary R.F. Geyer.)

Du 22 au 25 avril 1980, s'est tenu, à l'Université du Ouébec à Trois-Rivières, un Colloque international sur la culture populaire. Ce colloque était organisé en partie par le comité de recherche sur le loisir, de l'Association internationale de sociologie. X World Congress of Sociology: Information will be published in future issues of the ISA Bulletin as it becomes available.

Cost: The membership dues are remaining unchanged in spite of the effects of continuing inflation. This means that our membership dues remain one of the lowest among professional associations.

Three-year payment: In order to protect yourself against increases in dues, the Executive Committee has authorized us to accept prepayment of individual membership up to a maximum of three years at current rates. Thus, you will not be subject to increases in dues that may occur if you have already paid your dues.

Life membership: The Executive Committee introduced a life membership which would facilitate the continued participation of individuals after their retirement when their income is reduced. This life membership is now available at a cost of ten times the annual dues; however, it is available only from age 60 onwards.

ISA Bulletin: All members receive the ISA BULLETIN three times per year - in Spring, Summer, and Autumn. This is our major vehicle for publicizing the activities of the ISA. It contains information on individual and collective members, on the activities of our 36 Research Committees, on the meetings of all our administrative bodies, on the progress of our publications of interest to our members. Current Sociology: is the official journal of the ISA and also appears three times a year. It is unique in that each number contains a trend report on some special topic, together with a carefully researched and annotated bibliography. Needless to add, it is available to ISA members at a discount. During 1979, we published two volumes of Current Sociology in order to bring its publication schedule up-to-date. To allow you to complete your set, we are offering this second volume (Vol. 27) to our members at half price. This will mean that from now on Current Sociology will actually appear in the year marked on the cover. Our older members will appreciate this achievement because for many years they suffered under a continuing series of excuses for delays in publication. We shall make every effort to maintain the new publication schedule.

Sage Series in International Sociology (SSIS): has since 1970 replaced the Transactions of the World Congresses. Their publication had to be discontinued because the World Congresses had become too large and because our meager budget was unable to finance the losses. This new series (SSIS) published four to six topical volumes per year, based on work presented in sessions of the World Congresses. These volumes appear in both hard cover and in paperback; the paperback volumes are also available to ISA members at a discount.

Finally, we distribute occasional materials that we think will be of interest to our members, such as our "List of individual members", special publication announcements from our Research Committees, and sometimes a special issue of the "Vienna Centre Newsletter". Thus, we think that an individual membership in the ISA remains one of the good bargains in these inflationary times. We trust that you will continue to maintain an active interest in your Association.
