SOCIOLOGY OF HEALTH

A Report on the Research Committee's relationship with the World Health Organization by Ray H. Elling, RC15 Chairperson (Published in RC15 Newsletter 19).

For some two years our official affiliation with WHO has been under review. This topic was thoroughly discussed at our business meeting at the XI World Congress of Sociology in New Delhi. As the person who initiated this relationship while serving with WHO as Chief. Behavioural Science Unit in the then active Research Division (later this division and the unit were disbanded), I have been more than a mildly interested observer of its development. Frankly, after close to 15 years, the results are disappointing. Nothing more than invitations to send observers to meetings and the exchange of occasional letters has occured. No down-to-earth joint research and/or action project has developed, though we have made various proposals, one of which had been agreed as to several next steps by several WHO staff. This concerned a high priority of ours, namely the development of socio-health researchers for work on primary health care implementation in LDCs. But it went no further in spite of repeated inquiries to the senior staff person assigned as our contact.

Since RC15 serves as the point of liaison and coordination on the ISA side of this relationship, I arranged through the good offices of Dr J. Cohen, Adviser on Health Policy in the Director General's Office, and long time senior staff member of WHO, to visit the headquarters. To put it as clearly as I can, it seemed time to either "make it or break it". I was not optimistic.

Dr Cohen was very forthcoming and supportive in our two-hour opening discussions. Because of WHO's poor budget position and because the ISA and RC15 have only very small funds from membership dues, there are few realistic chances to move toward joint research and/or action projects in the near future. One possible way such could develop would be for one or more of our members with a particular interest to link up with WHO staff who share that interest and are in a program which could receive a proposal, suggest improvements and, once agreed, forward it to a foundation or some government aid agency for possible funding. In this connection, I will identify briefly some possibilities below as the rest of my visit was spent in discussion with WHO staff responsible in certain program areas in which the social sciences either are or might be vitally involved. It is my net impression that WHO, at least in some spheres of concern, is finally moving beyond the window-dressing, lip-service type of social science involvement to a realization that these disciplines offer conceptual, methodological and experiential content vital to the success of the organization's work. "Social forces" or "factors", usually seen as on the fringes or in the context of some supposedly primarily bio-technical process or project, almost always become the determining elements in the success or failure of the effort. This is beginning to sink in at the highest levels of the organization. Thus an enlarged, more correct and adequate understanding is gradually replacing previous narrow views of a "medical mafia" (both inside WHO

and in Ministries of Health I might observe) which has been quite unschooled in social science theory, methods and practice. Thus, in the long run at least, we should be hopeful.

In the meantime, it was agreed with Dr Cohen and each of the other staff that a lot can be done to improve the information exchange. Thus, along these lines, one minor but useful step was taken. Several WHO staff were invited to contribute on a rotating basis short statements on some social science issues of problem in their sphere of concern to RC15's newsletter. In the other direction, any of our members who may be attrected to propose some joint work with WHO staff, once they have read these statements or what follows here or otherwise learned of social science research and/or action opportunities through WHO, should feel entirely free, indeed are encouraged, to put themselves directly in touch with the staff members involved.

WHO programs with obvious social science content:

1. An urgent, high priority program has been established for AIDS prevention and treatment. It is not able to meet with the staff person responsible for social science involvement in the AIDS program, Dr Manuel Carballo, a social-science-trained physician well known to many of us. But Philippe Lehmann, a sociologist in Lausanne who is doing work on AIDS for the Swiss government attended a recent WHO meeting on AIDS as the ISA-RC15 representative. Also, Robert Broadhead (University of Connecticut, USA) has agreed to organize a session on AIDS research for RC 15 sessions at the XII World Congress of Sociology, Madrid, Spain, 1990.

- 2. Dr Igbal Shah, a sociologist with the Special Programme of Research, Development and Research Training in Human Reproduction (Population-Family Planning) told me of their grants program which has provided between \$2,000 and \$200,000 over a three year period with the average grant ranging between \$40,000 and \$60,000. They also occasionally bring experts together for consultations. He also told me of other agencies doing related work: a survey of contraceptive practices being carried out with USAID funding by the Institute for Resource Development: a study of fertility and breast feeding on the PRC, which involves sociology, funded by Canada's Formulation, and the Rockefellers Foundation's program on Wom.
- 3. The Special Programme for Research and Training in Tropical Diseases has supported a number of projects and provided a number of fellowships for students to pursue a Ph.D. in health sociology or one of the other social sciences. This program also receives grant proposals if the PI is in a recognized institution in a developing country. There is movement beyond purely bio-technical solutions to individual and community participation in control of parasitic and infectious diseases ranging from malaria (though WHO has another special program for this) through schistosomiasis to leprosy.
- 4. Dr S. Khana, a public-health trained physician, told me of an exciting program to identify new leadership for the massive job of reorienting health systems toward the PHC approach to health for all. I had the privilege of participating in a meeting on nursing leadership in Tokyo in April of 1986, in fact, I served as the Recording Secretary of the Recommendations Committee. If this program should unlock secrets of leadership development as they hope, the "medical mafia" as used above won't stand a chance. In any case, sociology and the other social sciences have much to contribute. Among other things, one should encourage comparative case studies of contextual, situational and personal-socialization

variables related 'to successful and unsuccessful leadership development instances.

5. The Division for Strengthening of Health Services (SHS) directed by Dr E. Tarimo, a public healthtrained physician, has settled on an exciting new strategy of focusing on district level support to the periphery of health systems. This support must include intersectoral efforts, moves to encourage community participation in determining health conditions and services, as well as all other aspects of a broad PHC approach. In 17 countries, one district has been chosen to have a research component attached to observe and evaluate the process of support to the periphery. Nine of these countries (Ethiopia, Kenya, Tanzania, Guatemala, Mexico. Sudan, Bangladesh. Indonesia, and the People's Republic of China) have already got some part of the support process and research underway. There will not only be room for social science as a part of this action research, it will be an essential component of the research, Any of our members in any of the named countries who have an interest in this research might put themselves in time with Dr Tarimo and/or the WHO country re-esentative and/or Ministry of Health to learn how you might become involved.

Also in SHS, I had a very good talk with Mr Andrew Creese, a health economist who looks after national health systems amd policies. Dr Yvo Nuyens, a health sociologist and former member of the RC15 Steering Board looks after health services research. Formally speaking, Yvo has been our point of contact with WHO for the last two years or so.

- 6. I met with two staff members in the Action Programme on Essential Drugs - Mrs P. Brudon-Japobowicz, a pharmacist with some social science training, and Mrs Ann V. Reeler, a health anthropologist. Both were very encouraging of our joining effort - even at the concrete project level if we can spell out details and obtain support. The exciting thing is that the work has moved beyond the physical means of getting legitimate essential drugs to the local level where they are to be used (usually "essential" means modern pharmaceuticals but there is an open curiosity about the adequacy of this conception for every situation and about the effects on society of "overmedicalization"). Beyond problems of apply networks, packaging, distribution, etc. the sc logical, economic, cultural, and social psychological factors involved in "rational use" of drugs have come to the fore as areas of research.
- 7. The mental health sphere of concern in WHO has had a long term interest in involving social scientists. Dr Norman Sartoius was away during my visit but I am sure would be glad to hear from our members doing research in this field.

 The above brief survey does not cover WHO regional

The above brief survey does not cover WHO regional offices. In some, especially EURO, very exciting work has been going on involving sociology. The work on social inequalities, health and health care with Raymond Ilsley and Per Gunnar Svensson and others is worth special note. While this has not involved the ISA or RC15 per se, the work is no less important or admirable for that. In any case, EURO is one of the WHO regions with plenty of able, well trained, wellorganized health sociologists at hand. Perhaps the ISA-RC15 connection would be best called into play in other WHO regions. In SEARO, Dr Soon Young Yoon, a health anthropologist, is working with us to develop a network of health social scientists who could contribute to WHO's work and be country focal persons for RC15 to aid in the development of health sociology or health social science. Dr Tudor Silva (University of Paradynia) has agreed to serve in Sri Lanka and Dr Misra (Centre for Nepalese Studies) has agreed to serve in Nepal. This idea has already spread to AFRO with our appointment and the acceptance by Dr T.

Akwasi Aidoo, health sociologist (University of Dar es Salaam), to serve for Tanzania. We will be looking for suggestions and volunteeres from other countries.

As one can see from the above, there is not much yet in the ISA-RC15 relationship which is worked out in detail with practical research and/or action resulting. Also, there is no clear response, though we look forward to one, regarding our priority proposal to see to the development of well and relevantly trained socio-health researchers in LDCs. Nevertheless, there appears to be great potential in a number of spheres of mutual interest. I recommend that we give the relationship more time and that we devote more effort to it.

P.S. An encouraging development has been reported recently by Ray Elling: RC15 is likely to serve as a focalpoint for networking for leadership for the WHO Programme "Health for All".

LERSCO a été fondé en 1972 à l'Université de Nantes. à l'initiative commune de Jean Claude Passeron et Michel Verret dans le propos: (1) de spécialiser un laboratoire français dans l'étude sociologique de la classe ouvrière. (2) de contribuer à la décentralisation de la recherche, en l'implantant en province, (3) d'asumer cette localisation périphérique dominante, sans pour autant renoncer aux avantages intellectuels de la fréquentation du centre, en prenant dès l'origine le parti d'une bilocalisation: Paris et Nantes.

Le LERSCO a été reconnu en 1974 comme ERS-CNRS no.502. Cette ERA a ensuite constitué l'argument et la base d'appui d'une habilitation de 3ème cycle spécialisée sur la classe ouvrière, obtenue en 1976.

Les années 1985 à 1987 ont été marquées, pour LERSCO, laboratoire universitaire constitué presque exclusivement d'enseignants-chercheurs, par la

production d'un grand nombre de thèses d'Etat, de Troisième Cycle et de Nouveau Régime (16 soutenances entre le 1er Janvier 1985 et le 1er Juillet 1987).

Ces thèses, ainsi que les travaux et publications

qui leur sont associés attestent:

- la poursuite et l'aboutissement d'un grand nombre de recherches consacrées à la classe ouvrière, française et internationale, recherches qui sont les fruits d'une programmation de long terme remontant souvent à dix ans et plus.

The Groupe de Sociologie du Travail is a research center whose main activity is state funded research into work. It belongs to the National Research Institute (Centre National de la Recherche Scientifique) and provides also training in research for post-graduate students of Université Paris VII. Directed by Claude Durand since its foundation in 1970, the Group is composed of 17 full time researchers and 4 professors.

Main areas of research are:

- technology, work and labour
- professions
- state and industry
- labour training and skills
- law, work and social integration
- industrialisation and workers' organization
- work and housing

In recent years the traditional industrial sociology topics (division of labour, work organization and industrial conflicts) that were fully treated during the seventies have been replaced by new themes of inquiry such as industrial policy, new technologies. labour market and the professions. This theoretical reorientation was the central question treated during the conferences organized by the Group and published in France: "La Division du Travail" (1976), "l'Emploi" (1980), "Le Travail et sa Sociologie" (1985) also published in English as "Industrial Sociology: Work in the French Tradition" by M. Rose, Sage Publications, 1987.

Current research projects include an important comparative effort. French industrial policy concerning some industries (steel, textiles, electronics) is being compared to State-industry relationship in Germany, Hungary, Bulgaria and Mexico. A comparative survey is also being conducted in the building industry in Latin America (Chile and Argentina). International comparative research has intensified exchange with foreign centers, and the Group welcomes visitors interested in common research projects.

The Group is in charge of a post graduate program in Sociology of Work at two levels: masters and doctoral formation qualifying for a national degree in sociology (Université Paris VII).

The German Institute of Youth Studies (DIJ) is an extramural research institute engaged in social science research. It is a registered association and has thirty members, fifteen of whom come from private and public institutions, associations and other organizations engaged in the youth services, from expert bodies advising on policies and from the Arbeitsgemeinschaft Sozialwissenschaftlicher Institute (ASI). The other fifteen members are coopted to insure an adequate representation of the range of activities and scientific disciplines addressed by DJI.

DJI functions as a center for the documentation of research, information, and literature of the situation of children, adolescents and families in the Federal Republic of Germany. It initiates and monitors pilot programs and undertakes practice-oriented basic research.

DIJ's scope of activities spans the tension-field of politics, praxis, the sciences and the public. In this, it has a twofold function: the transfer of knowledge to the social praxis and advising policymakers, on the one hand, and a feedback of parctical experience to the current state of research, on the other.

DJI personnel in 1987 numbers about 140, of whom 91 are scientists. Most of the annual budget of approximately DM 12 million is financed by the Federal Ministry for Youth, Family. Women and Health, which draws on research funds made available by the Federal Ministry of Education and Science. Additional resources come from the federal states and institutions for the promotion of science.

Current research topics

- (1) The impact of ongoing structural changes on the living conditions of youth, on the social organization of the adolescent phase and on the youth serves. Section I. Youth Services/Youth Policy, focuses of the socio-cultural changes affecting adolescence and the institutions of the youth services. Section II. Youth and Employment, concentrates on the integration of young people into the working sphere, both in theoretical and empirical terms.
- (2) Family research. Section III, Family/Family Policy, focuses on intensive studies and the monitoring of pilot projects in progress, some of them conducted on an international comparative level. Section V, Social Science Reports, is engaged in the preparation of repeated surveys of families and the setting-up of a regionally differentiated data bank storing information and knowledge relevant to family and youth policies. These projects are intended to provide empirically sound, structural data and evidence on the changing life situations of children, adolescents and parents.
- (3) Research into childhood at DJI provided valuable scientific and pedagogical impulses to the reform of primary education in the 70s. The curriculum of "Social Learning" developed by DJI, and the situational approach implicit in it, have been welly adopted by kindergartens. Research conducted by Section VII, Primary Education, is at present engaged in empirical studies of the changes that have occurred in children's lives and, parallel with ongoing pilot projects, analyzes the development of new facilities for children within existing regional infrastructures.
- (4) Media research at DJI is an interdisciplinary activity concerned with the significance and the implications of the media for children, adolescents and families. Section IV, Media and New Information Technologies, is currently developing a research program designed to study the use of the media by way of quantitative and qualitative multivariate and process analyses as well as longitudinal and field studies. Four projects are at present under way: i. a documentation is being prepared which will analyze the process relevant publications used in the field of media research and media-related pedagogy; ii. a study of children's experiences with media equipment; iii. a study of adolescents' use of the media; iv. the computer activities of children and the effects on socialization.
- (5) The task of Section IV. Documentation /Information, is to process and disseminate information on the scientific literature and ongoing research to scientists, administrators, politicians and practitioners. To this end, monographs, newspaper articles as well as "gray" materials are

systematically collected, analyzed and classified for storage in data bank.

Publications

The Bibliography "Sozialisation und Sozialpädagogik" is published four times a year and lists about 3,500 titles annually. A biannual research supplement contains numerous descriptions of relevant projects conducted by other institutions and researchers.

"DJI Bulletin" is published four times a year and is available free of charge on request.

DJI Verlag Deutsches Jugendinstitut publishes DJI's own research results as well as those of external authors. At present, approximately 160 titles are available.

Objective and Organization

The Centre for Hong Kong Studies (CHKS) of the Chinese University of Hong Kong was established in 1982, with the responsibility of developing, coordinating and facilitating multi-disciplinary research on the social, political and economic development of Hong Kong.

Research projects are mainly undertaken by regular academic staff members of the Chinese University of Hong Kong. Individuals outside the University who have genuine research interest in Hong Kong studies may participate in the CHKS as honorary Research Fellows or Associates.

Funding for research activities comes from both the Chinese University and grants and donations.

Research Activities

Apart from providing advisory services researchers, the CHKS regularly organizes and sponsors public lectures, workshops, symposia and forums for professionals and academics both inside and outside the Chinese University to promote dialogue between the academic community on the one hand, and the government, the business community and other public bodies on the other.

Background

The Sociological Research Unit (SRU) of the Indian Statistical Institute has an on-going program of research in sociology and in areas of sociological relevance. In addition, SRU provides training and teaching in sociology and sociological research methodology. In addition to Calcutta, SRU has a station at Giridih in the state of Bihar. SRU employs 8 scientists who are helped by 11 technical assistants and a team of 11 providing administrative services.

Briefly speaking, the central thrust of SRU is to undertake explanatory studies and explore critical areas related to frontiers of social transformation in India. The underlying objective behind SRU's approach is, no doubt, ambitious. This is that its work should not only enrich the potential for dialectical interactions between a newly emerging empirical reality, as in India, and the given body of sociological theories, but also effectively contribute to intervention in matters of policy-making related to social planning and welfare in our own society. During the first two decades of SRU's existence since 1957, the scientists in SRU were concerned mainly with the state of sociological data mass available in India and with formulating an appropriate methodology for retrieving additional data necessary for the purpose of inference and theory-projection.

Subsequently, few distinct areas of interest have now emerged in which SRU's scientists are engaged. Without going into details about various research projects currently undertaken in these areas, their

underlying themes can be stated as follws.

Programs of on-going research

 Anti-colonial uprising in Bengal during the period of British rule in India and variation in perceptions of peasant insurgents.

Principal researcher: Dr Atis Dasgupta
This project has special reference to 'inherent'
components of ideology as projected by myths and
folklores, system of beliefs
study, thus, becomes deeper than subaltern approach,
rather it encapsulates the latter as one of its
categories.

Social tradition, attitudinal pattern and cultural behaviour emerging under the impact of modern economy upon a traditional society.

Principal researcher: Dr Prafulla K. Chakrabarti Indicating that this impact is differential in nature according to what dimension of traditional society is under consideration, this study goes further to explore the nature of commonality as well behind this differential pattern.

3. Dimensions of social role of the aged.
Principal researcher: Suhas Kr. Biswas
This study is concerned with the elderly population
(male and female) of unorganised sectors in small
towns and rural areas since the problems arising are
of lack of security and necessary financial support
for the aged. These are quite severe in these parts
of country.

Ecology as a factor of variation of structure and organization of rural communities. Principal researcher: Kumarananda Chattopadhyay
This study purposively looks at the coastal villages
by the side of the Bay of Bengal as well as the
villages in the dense tropical forests in Simlipal
region of Orissa and in Palamau of Bihar. As there
are members of the same ethnic group inhabiting these
diverse ecological niches, the role of ecology upon
communities can be compared meaningfully.

 In-depth study of the impact of legislations Principal researchers: Ajoy Kr. Ghosh, Tejendra Nath Ghosh, Salil Kr. Chatterjee

This research project examines whether legislations which seek to induce changes in organisation and functioning of traditional social institutions (like, for example, child labour, bonded labour, marriage, caste and schools) in the society are really working in that direction and also examines the conditions which create barriers and gaps in achieving the desired goals. One of the objectives of this project is to explore the differential response of various sections of people in the society and factors responsible for this differential response.

 Differentiation, identity, alienation and mobilisation: a study of the major processes of uneven transformation in a rice producing region Principal researchers: Dr Suraj Bandyopadhyay jointly with Dr Donald von Eschen of McGill University, Montreal, Canada.

This piece of research is part of a program of longitudinal study on the conditions of rural development in central West Bengal since 1971. By 'conditions' we mean both endogenous and exogenous factors relevant for this study. The former include factors like environmental potential for a prosperous agriculture, demographic growth, social network, caste and kinship ties, ethnic and class identity, system of inheritance and partitioning of land, etc., which are endogenous to the region. The latter refer to factors like, for example, social networks, integration with urban-market centers, migration, government policies and institutions, political parties.

Methodologically this study combines current crosssectional survey data with longitudinal processual data collected by using genaeological and case history methods as well as documented information gathered from official records.

 Exploratory studies in quantitative methods in sociological research.

Principal researchers: Dr Suraj Bandyopadhyay jointly with Professors A. Ramachandra Rao, Bikas Sinha and S.B. Rao of the Statistics-Mathematics Division (Indian Statistical Institute), Donald von Eschen (McGill University, Montreal, Canada), and Barry Wellman (International Network of Social Network Analysis, Toronto, Canada).

In the course of the research undertaken by SRU distinctly new types of problems related to statistical methods of data collection and analysis have arisen. Special mention may be made of the sociometric study of various aspects of social networks arising out of different types of social relations. Graph-theoretic methods are found to be more appropriate in analysing such flow-data. Using such methods sociologists can examine not only patterns of over-lapping of different types of social relations, but also look at to what extent social relations actually cut across the boundaries of social structure. With these methods an attempt can be made to answer questions which often puzzle us. For example, which boundary - kinship, ethnic affiliation, or class position - contributes more to build up solidarity?.

Program of training and teaching in sociology
- SRU provides guidance and consultancy services for sociological researchers. For this purpose it has

Centro Nazionale di Prevenzione e Difesa Sociale (CNPDS) was founded in Milan in 1948. Through its studies and debates (conducted with a multidisciplinary methodology and with the support of every political component of the Italian Constitutional spectrum and increasingly involving international meetings), Centro has contributed to the civil and cultural development of Italy in the last fourty years confronting the most acute problems arising from the current phase of social transformation. Indeed, by virtue of its standing as an "organ for the production of reserach", and without ignoring the original objectives of prevention and social defence, the CNPDS has consistently widened its range of study, so as to represent a forum of

research on the processes of social transformation and the issues which they present to the social and political conscience of Italy.

The basic aim of the Centro, as laid down by Article 2 of its By-Laws, is to "promote the study and realization of a system of prevention and social defence": such a goal, so broadly stated, can aptly embrace every possible activity of research and promotion in the field of the oragnization of a society. The Department of Sociology was established in 1965 under the Faculty of Arts and Social Sciences. The Department conducts courses leading to the degrees of B.A. and B.Soc.Sci. (Honours). Postgraduate programmes are also available for M.Soc.Sci. and Ph.D. degrees which are not structured around rigid course requirements.

There are about 900 students reading Sociology as their major subject for the Bachelor's degree and more than 20 students each year continue to work on their Honours (Fourth-year) programme with the Department. Altogether there are at present eleven graduate students studying for their Master's or Doctoral degree in the Department.

Research facilities in the University are given excellent ratings by visiting scholars in the region as well as overseas. For example, the University's Computing Centre is equipped with powerful IBM 4341 Gp II and IBM 3081 KX computers. Computing work can also be carried out at the interactive terminals located in the Faculty of Arts and Social Sciences. Of the Faculty's 12 interactive terminals, four are reserved for staff use while the remaining for teaching purposes. A number of word processors and micro-computers are also made accessible to staff in the Faculty. In addition to the University computer services, the Department provides its own computer facilities for staff and students.

Library holdings of the University are adequate with good coverage in the social sciences and complete volumes of most established journals in the fields of sociology and social anthropology. A special Singapore and Malaysia Collection contains valuable and unique research materials. In addition, the library at the Institute of Southeast Asian Studies which is located near the campus, has excellent holdings on Southeast Asia and this is accessible to graduate students and staff

Singapore society offers unique opportunities for sociological and social anthropological research and there has been considerable interest in expanding such research. Several international and local organizations such as WHO, UNESCO, ILO, the Ford Foundation, the Asia Foundation, the IDRC, the Population Council. the East-West Center, the Volkswagen Foundation, Harvard-Yenching Institute, the Wenner-Gren Foundation, the Royal Anthropological Institute, AMIC, the Friedrich-Ebert Foundation and the Lee Foundation have financed research projects carried out in Singapore and elsewhere in Southeast Asia by members of the Department.

Research conducted by members of the Department covers wide and varied subfields of sociology and anthropology and may be classified into four main areas: (a) social change including adaptation to industrial work and changing work patterns, demographic changes and family planning, high-rise living, urban networks and resettlement; (b) problems of pluralistic society such as ethnic relations, multilingualism, national identity, religion, social class and social mobility patterns; (c) social policy involving social issues such as crime prevention and delinquency patterns, education, family, health, mass communications and population growth; and (d) sociology and ethnology of Southeast Asia.

Besides teaching and basic academic research, staff members of the Department have also been very active in providing consultancy services to government bodies and private organizations. The Department publishes periodically the Southeast Asian Journal of Social Sciences and the Sociology Working Paper Series. Weekly seminars are also conducted with speakers from within and outside the Department.

The Centre for Intergroup Studies was established in 1968. It is situated on the Campus of the University of Cape Town, but is not part of the University and receives no government subsidy. The primary purpose of the Centre is to promote and conduct research on intergroup relations in South Africa.

The Centre conducts academic and applied research motivated by the need to promote greater knowledge and better understanding between the various groups and communities in South Africa. In this process it brings together individuals and organisations with different and often conflicting ideological points of view. Owing to the constructive and balanced manner the Centre has adopted in handling sensitive issues and its objective treatment of diverse views, it has established a basis for consultation and mediation in a highly stratified and polarised society.

The Centre is concerned with the process of communication between parties and not goals or blueprints for the future. This means that the Centre is not affiliated or committed to any party or political group or movement. Since its inception in 1968 the Centre has been involved in many controversial issues as an impartial third party. In 1984 the Director initiated contacts between people from South Africa (including government supporters) and the African National Congress in exile and in 1986 was invited to mediate in the conflict in Natal.

The Centre's major programme is in the field of Conflict and Peace Studies (CAPS). The Conflict and Peace Studies programme comprises applied research, the facilitation of communication between conflicting groups, the development of negotiation and mediation skills, consultation, co-ordination of a national network, and the building and maintenance of a Resource Centre.

A major focus of the Conflict and Peace Studies programme is the development of communication skills for facilitators in conflict situations. This is seen as an important task in the promotion of conflict accommodation in South Africa. Following a national seminar held at the Centre in 1984, a series of national training courses in conflict management, negotiation and mediation were held to provide training for facilitators, negotiators and mediators in community and political relations.

During 1986 and 1987 a training syllabus oriented to South African participants was developed, a national training programme in negotiation skills was established. The national co-ordintaor of this programme is Azikhwelwa Zikalala who is based in Soweto.

Training in nonviolence usually constitutes an integral part of any training course in negotiation and mediation. The Centre has launched a separate project developing a directory containing examples and illustrations of nonviolent action in South Africa.

The Centre for Intergroup Studies is also participating in an inter-organisational initiative to establish an autonomous body for mediation services in community and political conflict in South Africa.

The Sociology Department has 30 regular faculty members and 25 part-time or affiliate faculty members. There are over 100 students in the Graduate Program, half of whom are from countries other than the United States.

The Graduate Program in Sociology at Michigan State University offers both M.A. and Ph.D. degrees. The M.A. degree may be in either General Sociology or in Applied Sociology. For the Ph.D. degree, students major in one of six speciality areas: Conflict and Change, Rural and Community Studies, Population and Ecology, Occupations and Organizations, Social Psychology, or Urban Studies. Both degrees also involve training in sociological theory and in research methods and data analysis.

The major themes of the Sociology Graduate Program, which pervade much of the research and teaching of the faculty, are International and Comparative Studies, Social Change and Development, and Social Policy Applications.

Many members of the faculty are currently engaged in international research projects in several different countries. For example, Ruth Harris has a large grant from the Ford Foundation to study the African diaspora in Latin America; Daniel Clay is conducting an Agricultural Survey and Policy Analysis Project in Rwanda; Richard Hill is studying industrial policy in Japan; Peter Manning is examining medical/health economics and policies in Great Britain; Bo Anderson is presently in Sweden as a members of the Swedish Collegium for Advanced Study in the Social Sciences.
