# Letter from the President, No. 2, June 1995

### Sociology and History

The Executive Committee of the ISA has instructed the Program Committee that the 1998 Congress in Montreal should construct its theme around a look backward and a look forward, as we move into the third millennium: a look backward at the sociological heritage, and a look forward at the future of sociology and the social sciences in general in the twenty-first century.

This may be the moment therefore when we should look again at the shaky and uncertain relations of sociology and history, both as heritage and as prospect. In 1898, precisely one century before our Congress in Montreal, Emile Durkheim published the first issue of the Année Sociologique. In the Préface he wrote for this issue, Durkheim explained the need to have a publication in which sociologists might be informed of research throughout the social sciences. And then he added:

But our enterprise may also be useful in another way: it may serve to bring nearer to sociolog y some sciences which has kept themselves too separate, to their great loss and ours.

It is especially of history that we are thinking in speaking in this way. Even today, it is rare for historians to be interested in the work of sociologists and feel that it is of interest to them. The overgeneral character of our theories, their insufficient documentation has meant that they are considered of negligible significance: they are not considered to be philosophically important. And nonetheless, history can be a science only to the degree that it can explain things, and one cannot explain without comparing. Even simple description is scarcely possible otherwise; we can't describe a unique fact very adequately, nor something about which we possess only a few examples, because we cannot envisage it very well.( ... ) Thus we serve the

cause of history when we persuade the historian to go beyond his usual perspective, to look beyond the particular country or time period he proposes to study. and concern himself with the general questions that are raised by the particular facts he observes. But, as soon as history compares, it becomes indistinguishable from sociology. Conversely, not only can sociology not dispense with history, but it needs in fact historians who are also sociologists. As long as the sociologist is a stranger who intrudes in the domain of the historian in order to help himself, so to speak, to the data that interest him, he will never do much more than skim the surface rather superficially. Ill at ease in an unaccustomed environment, it is virtually inevitable that the sociologist will not pay attention to, or will only consider as disturbing, the data most worth noticing. Only the historian is familiar enough with history to be able to use historical data. Hence, far from being antagonistic, these two disciplines tend naturally to converge, and everything seems to indicate that they are destined to blend together (se confondre) into a common discipline in which elements from each will be combined and unified. It seems just as unthinkable that the one whose role is to uncover the data is unaware of the kinds of comparisons for which such data may be relevant as it is for the one who compares data to be unaware of how they have been uncovered. Developing historians who know to look at historical data as sociologists, or what amounts to the same thing developing sociologists who possess all that techniques of the historians, is the objective we must pursue on both sides.(1)

When one reads this text today, nearly a hundred years later, two things cannot fail to strike our attention. First, one of the acknowledged fathers of modern sociology, in the very opening pages of this principal organizational contribution to the discipline, the creation of a major journal, looked forward to the inevitable merger of sociology and history into a single discipline. Secondly, one hundred years later, this has not yet happened. Was Durkheim wrong in suggesting that the "destiny" of sociology and history was to unite? Or did we make some mistakes en route to fulfilling this destiny?

In 1992, the correspondence Marc Bloch addressed over a period of twenty years (1924-1943) concerning the writing of Feudal Society to Henri Berr, the editor of the series in which it was to appear, was published. I have long considered Marc Bloch's Feudal Society one of the great sociological works of the twentieth century. It is also a book that hardly ever appears on a reading list of a course in sociology. The reason is simple: Marc Bloch was a medieval historian, and medieval Europe seems a topic remote from the immediate concerns of most sociologists. Yet, reading Bloch, one realizes that his self-image was very "sociological". For example, he says of this book: "I have tried, for the first time no doubt, to analyze a type of social structure in all its interconnections. I have probably not succeeded. But the effort was worth making, I believe; and this is what is interesting about the book\* (2). Indeed, Bloch was so "sociological" that, when Henri Berr proposed a blurb for the book, Bloch insisted on adding that the book was "au service d'une science très sûre" (3). This is not easy to translate. It seems to me that what Bloch meant was that he intended the book to have high scientific validity.

I tell this story about Bloch not to sing his praises nor even to urge you to read him (which of course I do, if you have not) but to note the comment he makes, in the course of these letters, on the relation between history and sociology as disciplines. In 1928, he wrote Berr a letter in which he deplored the narrow conception of history held by so many historians and shared by so many sociologists. He then says of the sociologists: "their great error, in my view, was to seek to construct their 'science' alongside and over history rather than reforming

history from within.\*(4). This indeed is food for reflection on the heritage of sociology. Did we make a great error by not trying to reform history from within? Should Durkheim have been collaborating with, rather than working separately from, his younger French contemporary and historian, Henri Berr? What would have been the consequences today had the two joined forces?

I am not a great fan of counterfactual questions. They are at best provocations. What matters most is to explain the things that actually occurred. And what happened, as we know, is that, in the period between 1850 and 1945, history established itself as a primarily idiographic discipline devoted to the "past" while sociology (alongside economic and political science) established itself as a largely nomothetic discipline, utilizing almost exclusively data from the "present". Since 1945, there have been numerous voices within both disciplines favoring a rapprochement, usually under the rubric of "multidisciplinarity". The very term, multidisciplinarity, however, presumes two intellectually separate disciplines, whose combination may produce useful knowledge. It does not presume what Durkheim wrote in 1898: "As soon as history compares, it becomes indistinguishable from sociology."

I personally agree with Durkheim. Just as I cannot imagine that any sociological analysis is valid without placing the data fully within their historical context, so I cannot imagine that it is possible to do historical analysis without using the conceptual apparatus we have come to call sociology. But if this is so, is there any place for two separate disciplines? This seems to me one of the primary questions before us, as we are discussing the future of sociology and the social sciences as a whole in the twenty-first century.

## Lettre du President, No. 2, Juin 1995 par Immanuel Wallerstein

### Sociologie et Histoire

Le Comité Exécutif de l'AIS a fait savoir au Comité de Programme que le thème du Congrès de 1998 à Montréal, au nmoment où nous entrons dans le troisième millénaire, devrait être structurés autour d'un regard sur le passé, et d'un regard vers le futur : c'est à dire autour d'un regard sur l'héritage de la sociologie et d'une réflexion sur l'avenir de celle-ci et des sciences sociales en général.

Cela pourrait donc être le moment opportun pour nous intéresser de nouveau aux relations fragiles et incertaines entre la sociologie et l'histoire, aussi bien en tant qu'héritage que dans leurs perspectives d'avenir. En 1898, exactement un siècle avant notre congrès de Montréal, Emile Durkheim publiait le premier numéro de L'Année sociologique. Dans la Préface ce numéro, Durkheim de expliquait la nécessité d'une publication permettant aux sociologues d'être informés de la recherche dans l'ensemble des sciences sociales. Il ajoutait ensuite :

Mais notre entreprise peut être encore utile d'une autre manière: elle peut servir à rapprocher de la sociologie certaines sciences spéciales qui s'en tiennent trop éloignées pour leur plus grand dommage et pour le nôtre.

C'est surtout à l'histoire que nous pensons en parlant ainsi. Ils sont rares, même aujourd'hui, les historiens qui s'intéressent aux recherches des sociologues et sentent qu'elles les concernent. Le caractère trop général de nos théories, leur insuffisante documentation fait qu'on les considère comme négligeables: on ne leur reconnaît guère qu'une importance philosophique. Et cependant, l'histoire ne peut être une science que dans la mesure où elle explique, et on ne peut expliquer qu'en comparant. Même la simple

description n'est guère possible autrement. On ne décrit pas bien un fait unique ou dont on ne possède que de rares exemplaires parce qu'on ne le voit pas bien.(...)

C'est donc servir la cause de l'histoire que d'amener l'historien à dépasser son point de vue ordinaire, à étendre son regard au-delà du pays et de la période qu'il se propose plus spécialenment d'étudier, à se préoccuper des questions générales que soulèvent les faits particuliers qu'il observe. Or, dès qu'elle compare, l'histoire devient indistincte de la sociologie. D'un autre côté, non seulement la sociologie ne peut se passer de l'histoire, mais elle a même besoin d'historiens qui soient en même temps des sociologues. Tant qu'elle devra s'introduire comme une étrangère dans le domaine historique pour y dérober, en quelque sorte, les faits qui l'intéressent, elle ne pourra y faire que d'assez maigres provisions. Dépaysée dans un milieu auquel elle n'est pas accoutumée, il est presque inévitable qu'elle ne remarque pas, ou qu'elle n'aperçoive que d'une vue assez trouble, les choses qu'elle aurait le plus d'intérêt à bien observer. Seul, l'historien est assez familier avec l'histoire pour s'en servir avec assurance. Ainsi, bien loin qu'elles soient en antagonisme, ces deux disciplines tendent naturellement l'une vers l'autre, et tout fait prévoir qu'elles sont appelées à se confondre en une discipline commune où les éléments de l'une et de l'autre se retrouveront combinés et unifiés. Il paraît également impossible et que celui dont le rôle est de découvrir les faits ignore dans quelles comparaisons ils doivent rentrer, et que celui qui les compare ignore comment ils ont été découverts. Susciter des historiens qui sachent voir les faits historiques en sociologues, ou, ce qui revient au même, des sociologues qui possèdent toute la technique de l'histoire, voilà le but qu'il faut poursuivre de part et d'autre."(1)

A la lecture de ce texte, près de cent ans plus tard, deux choses ne peuvent manquer d'attirer notre attention. Premièrement, l'un des pères reconnus de la sociologie moderne, dans les toutes premières pages de cette contribution majeure à l'organisation de la discipline qu'est la création d'une revue de référence, se réjouissait d'avance de l'inévitable fusion de la sociologie et de l'histoire en un discipline unique. Deuxièmement, cent ans plus tard, ce souhait ne s'est pas encore réalisé. Durkheim se trompait-il en insinuant que le "destin" de la sociologie et de l'histoire était de s'unir? Ou avons-nous commis des erreurs sur le chemin conduisant à la réalisation de ce destin?

En 1992, on a publié la correspondance à propos de La Société Féodale, adressée par Marc Bloch, au cours d'une période de vingt ans (1924-1943), à Henri Berr, l'éditeur de la collection dans laquelle l'ouvrage devait paraître. Je considère depuis longtemps La Société Féodale de Marc Bloch comme l'un des grands travaux sociologiques du vingtième siècle. C'est aussi un ouvrage qui apparaît peu fréquemment dans la bibliographie des cours de sociologie. L'explication en est simple : Marc Bloch était un historien spécialiste du Moyen-Age, et l'Europe médiévale est considérée comme un sujet éloigné des préoccupaions immédiates de la plupart des sociologues. Cependant, à la lecture de Bloch, on se rend compte que l'image qu'il avait de lui-même était très "sociologique". Par exemple, il dit de son livre : "J'ai essayé, pour la première fois sans doute, d'analyser un type de structure sociale, avec toutes ses liaisons. Je n'ai probablement pas réussi. Mais l'effort valait, je crois, la peine d'être tenté ; et il fait l'intérêt du livre."(2) De fait, Bloch était tellement "sociologique" que, lorsque Henri Berr proposa une publicité pour le livre, Bloch s'obstina pour ajouter que le livre était "au service d'une science très sûre."(3) Cela n'est pas trop difficile à interpréter. Il me semble que ce que Marc Bloch voulait dire, c'était qu'il était soucieux que le livre ait une haute validité scientifique.

Je ne raconte pas cette histoire à propos de Marc Bloch pour chanter ses louanges, pas même pour vous en conseiller la lecture (ce que je fais évidemment si elle n'est pas déjà réalisée), mais pour souligner le commentaire qu'il fait, au cours de ces lettres, sur la relation entre histoire et sociologie en tant que disiplines. En 1928, il écrivit à Berr une lettre dans laquelle il déplorait l'étroite conception de l'histoire "que se la font tant d'historiens, et d'ailleurs également les sociologues". Il dit ensuite des sociologues : "la grande erreur,à mon sens, a été de vouloir constituer leur 'science' à côté et audessus de l'histoire, au lieu de réformer celle-ci par le dedans."(4) Cette remarque nourrit la réflexion sur l'héritage de la sociologie. Avons-nous fait une grande erreur en ne tentant pas de réformer l'histoire par le dedans? Durkheim aurait-il dû collaborer avec son plus jeune contemporain français et historien, Henri Berr, au lieu de travailler séparément de lui? Quelle auraient été les conséquences aujourd'hui si les deux forces s'étaient unies? Je ne suis pas un

grand amateur des spéculations historiques. Elles sont au mieux des provocations. Le plus important est d'expliquer les choses qui ont effectivement eu lieu. Et ce qui est arrivé, comme nous le savons, c'est que pendant la période s'étendant entre 1850 et 1945 l'histoire s'est établie comme une discipline principalement idiographique. se préoccupant du passé, alors que la sociologie (au côté des sciences économiques et politiques) s'est établie comme une discipline largement nomothétique, utilisant presque uniquement des données de "présent". Depuis 1945, de nombreuses voix se sont élevées à l'intérieur des deux disciplines en faveur d'un rappochement, habituellement

sous la rubrique de la "multidisciplinarité". Le terme même de multidisciplinarité, cependant, suppose deux disciplines intellectuellement séparées, dont la combinaison devrait produire un savoir utile. Il ne suppose pas ce que Durkheim écrivait en 1898 : "Dès qu'elle compare, l'histoire devient indistincte de la sociologie."

J e s u i s personnellement d'accord avec Durkheim. De même que je ne peux pas me figurer comme valide une analyse sociologique qui ne replace pas entièrement les données dans leur contexte historique, je n'imagine pas qu'il soit possible de faire une analyse historique sans utiliser l'appareil conceptuel que nous sommes arrivés à nommer sociologie. Mais si tel est le cas, y a-t-il la place pour deux disciplines séparées? Cette question me semble être l'une des principales qui se pose à nous, au moment où nous débattons sur l'avenir de la sociologie et des sciences sociales comme un tout au vingt-et-une siècle.

### Carta No. 2 del Presidente, Junio 1995 por Immanuel Wallerstein

### Sociología e Historia

La Junta Ejecutiva de la AIS ha dado instrucciones al Comité del Programa para elaborar el tema del próximo Congreso en 1998, en Montreal (Canadá), sobre una mirada hacia el futuro y otra hacia el pasado, en nuestro paso al tercer milenio: Una mirada al pasado sobre la herencia sociológica y otra al futuro de la sociología y las ciencias sociales en general en el siglo veintiuno.

Este podría ser el momento en el que debiéramos revisar otra vez, tanto desde la herencia como desde la perspectiva, las inestables e inciertas relaciones entre sociología e historia. En 1898. exactamente un siglo antes de nuestro Congreso en Montreal, Emile Durkheim publicó el primer número de L'Année Sociologique. En el Prefacio que escribió para este número, Durkheim explicó la necesidad de tener una publicación en la que los sociólogos pudieran ser informados sobre la investigación en todas las ciencias sociales. Y luego añadió:

Pero nuestra empresa puede ser todavía útil en otro sentido: puede servir para acercar a la sociología algunas ciencias que se encuentran demasiado separadas, para su desgracia y la nuestra.

Pensamos, sobretodo, en la historia. Es muy raro, todavía hoy, que los historiadores se interesen por las investigaciones sociológicas y las consideren de interés. El carácter demasiado general de nuestras teorías, su insuficiente documentación ha hecho que sean consideradas como irrelevantes: no se les reconoce ninguna importancia filosófica. Y sin embargo, la historia solo puede ser ciencia en cuanto que explica, y no se puede explicar sin comparar. Ni siquiera la simple descripción es posible: No podemos ni describir un hecho único, ni cuando no poseemos nada más que pocos ejemplos, porque no lo podemos enfocar. (...)

De esta forma, servimos a la causa de la historia al llevar al historiador a sobrepasar su habitual punto de vista, a extender su mirada mas allá del país y del período que se propone estudiar, a preocuparse de cuestiones generales que eleven los hechos particulares que observa. Pero, tan pronto como la historia compara, se vuelve indistinguible de la sociología. Por otro lado, no sólo la sociología no puede pasar sin la historia, sino que necesita de los historiadores que son, al mismo tiempo, sociólogos. Cuando la sociología se introduce como una extranjera en el campo de la historia para sustraer, por decirlo así, los hechos que la interesan, sólo consigue mediocres resultados. Perdida en un medio al que no está acostumbrada,

inevitablemente no va a observar, o le parecerán incómodos, los hechos del más gran interés. Solamente, el historiador está tan familiarizado con la historia para poder servirse de ella con seguridad. Entonces, lejos de ser antagonistas, estas dos disciplinas tienden, naturalmente, una hacia la otra, y todo hace prever que están llamadas a confundirse en una disciplina común donde los elementos de una y otra se reencuentran combinados y unificados. Parece igualmente imposible que aquél cuyo papel es descubrir los hechos ignore las comparaciones que aquellos proporcionan, y que éste que compara ignore cómo han sido descubiertos. Fomentar historiadores que sepan ver los hechos históricos como sociólogos, o lo que es lo mismo, sociólogos que posean todas las técnicas de la historia, debe ser el objetivo a perseguir por ambas partes (1).

Cuando uno lee este texto hoy, casi cien años más tarde, dos cosas no dejan de llamar nuestra atención. Primero, uno de los padres reconocidos de la sociología moderna, en las primeras páginas de su principal contribución a la organización de la disciplina, la creación de una revista importante, esperaba una inevitable fusión de la sociología y la historia en una única disciplina. Segundo, cien años más tarde, esto todavía no se ha producido. ¿Se equivocó Durkheim al sugerir que la "llamada" de la sociología y la historia era llegar a unirse? ¿O hemos cometido algunos errores en el camino hacia la realización de esta llamada?

En 1992 se publicó la correspondencia de Marc Bloch, en la que trata la preparación de su libro La sociedad feudal y que dirigió durante un período de 20 años (1924-1943) a Henri Berr, editor de la colección en la que iba a ser incluido. Desde hace mucho tiempo considero a La sociedad feudal de Marc Bloch como uno de los más importantes trabajos sociológicos del siglo veinte. Es además un libro que casi nunca aparece en la bibliografía de un curso de sociología. La razón es muy sencilla: Marc Bloch fue un historiador medieval y la Europa medieval parece un tema lejano para los intereses inmediatos de la mayoría de los sociólogos. Sin embargo, leyendo a Bloch, uno se da cuenta de que en si mismo fue muy "sociológica". Por ejemplo, dice de su libro: "He intentado, sin duda por primera vez, analizar un tipo de estructura social, con todas sus conexiones. Probablemente no lo he conseguido. Pero me parece que valía la pena intentar este esfuerzo; y eso es lo que hace al libro interesante"

(2). De verdad, Bloch fue tan "sociológico" que cuando Henri Berr propuso un anuncio publicitario para el libro, Bloch insistió en añadir que el libro estuvo "au service d'une science très sûre" (3). La traducción no es fácil. Me parece que Bloch quería decir que intentó dar al libro una alta validez científica.

No cuento esta historia sobre Bloch para halagarle ni siguiera para recomendar que se le lea (que sin embargo lo recomiendo, si todavía no se ha hecho) sino para subrayar los comentarios que Bloch hace en estas cartas sobre la relación entre historia y sociología como disciplinas. En 1928, escribió a Berr una carta en la que deploró la estrecha concepción de la historia mantenida por muchos historiadores y compartida por otros tantos sociólogos. Más adelante habla de los sociólogos: "El gran error, según mi opinión, a sido el deseo de constituir su ciencia al lado y sobre la historia, en lugar de reformarla desde dentro" (4). Es realmente un tema de reflexión sobre la herencia de la sociología. ¿Hemos cometido un gran error por no intentar reformar la historia desde dentro? Debería Durkheim haber colaborado con su joven contemporáneo historiador francés, Henri Berr, en vez de trabajar por separado? ¿Cuáles serían hoy las consecuencias si ellos dos hubieran trabajado juntos?

No soy un gran aficionado a las preguntas hipotéticas. En el mejor de los casos, son provocaciones. Lo más importante es explicar los hechos tales que realmente hayan ocurrido. Y lo que pasó, como sabemos, es que en el período entre 1850 y 1945 la historia se estableció, ante todo, como una disciplina idiográfica dedicada al

"pasado" mientras que la sociología (junto con la economía y las ciencias políticas) se estableció básicamente como una disciplina nomotética, utilizando casi exclusivamente los datos del "presente". Desde 1945, ha habido numerosas voces en ambas disciplinas a favor de un acercamiento, normalmente bajo la rúbrica de "multidisciplinaridad". El propio término multidisciplinaridad, sin embargo, presupone dos disciplinas intelectualmente separadas, cuya combinación puede producir un conocimiento útil. No presupone lo que Durkheim ha escrito en 1898: "Tan pronto como la historia compara, se vuelve indistinguible de la sociología."

Personalmente estoy de acuerdo con Durkheim. Solo que no me puedo imaginar que un análisis sociológico sea válido sin colocar todos los datos plenamente en su contexto histórico, por eso no puedo imaginar que sea posible hacer un análisis histórico sin utilizar el aparato conceptual que hemos llegado a llamar sociología. Pero si así es, ¿Hay algún lugar para dos disciplinas separadas? Esto me parece una de las principales cuestiones en la discusión sobre el futuro de la sociología y de las ciencias sociales como un todo en el siglo ventiuno.

# **ISA Publications**

For the first time in its existence the ISA now has a Vice-President whose main responsibility is for publications. This is evidence of the importance that the Association's journals and books have in furthering its aims. I would like to report briefly on the range of our current publishing activities and to encourage you to consider making greater use of these publications yourself.

**Current Sociology** is the ISA's longest-running publications. Since 1952 it has carried Trend Reports on particular themes and issues of interest to the international community of sociologists. The total number of subscriptions, via the ISA and via Sage Publications, was 1,859 in 1994. In addition, four issues of Current Sociology have been successfully marketed as books. This makes Current Sociology an ideal way of reaching a wide audience in 53 different countries. If your writing plans include normal-length articles on topics of cross-national or international interest, then you should consider International Sociology. This journal was launched by the ISA in 1986 as a vehicle for stimulating comparative research and publications. It had 2,625 subscribers in 1994 and is now firmly established as a premier source of articles on topics which go to the heart of the ISA's mission. The third dimension of the ISA's publications concerns the Sage Studies in International Sociology (SSIS), a series of edited books which began appearing in 1980. The ISA Publications Committee has plans to improve its services to individual members. The Abstracts will be added to the Sociological Abstracts database; and the details of a scheme are being finalised which will create an Email bulletin board for ISA members, thereby speeding up communications with the Secretariat and facilitating cross-national debate.

# In Memoriam

### JACQUES DOFNY Vice-président de l'AIS: 1982-1986

Jacques Dofny est décédé le 4 juillet dernier à Marseille. Né en Belgique, il a débuté sa carrière de sociologue en France où il a travaillé plusieurs années, notamment avec Georges Friedmann, Alain Touraine, Michel Crozier, Marc Maurice, Bernard Mottez, pour n'en nommer que quelquesuns. Il est venu au Québec en 1961 et il a été professeur au département de sociologie de l'Université de Montréal jusqu'en 1989, et son directeur pendant plusieurs années. Ses domaines de recherche privilégiés ont été la stratification sociale et les classes sociales, la sociologie du travail et du mouvement ouvrier. Il a formé des centaines de sociologues au Québec et plusieurs d'entre eux, il aura été un guide intellectuel jusqu'à sa mort. La question nationale le préoccupait beaucoup et le Québec doit beaucoup à Jacques Dofny, tant pour son engagement pour la cause des francophones que pour son soutien au projet de libération national du peuple québécois. Militant socialiste, il a oeuvré au sein du mouvement ouvrier et des organisations syndicales pour lesquelles il a effectué de nombreuses recherches et joué un rôle de conseiller de premier plan. Soucieux de consolider la place de la sociologie francophone au Québec et dans le monde, il fonde à la fin des années 60, la revue Sociologie et Sociétés et prend une part active dans le développement de l'Association des sociologues et des anthropologues de langue française (ACSALF).

Membre du bureau et de comités de. l'American Sociological Association pendant plusieurs années, il s'est aussi engagé activement dans l'Association internationale de

sociologie, et ce, dès la moitié des années 70. D'abord en présentant, au nom de l'ACSALF, et avec le professeur Hubert Guindon de l'Université de Concordia qui agissait au nom de la Société canadienne de sociologie et d'anthropologie, la candidature du Québec pour recevoir le secrétariat de l'AIS. Ce qui fut agréé et le secrétariat s'est établi à l'Université du Québec à Montréal, de 1974 à 1982. Jacques Dofny a été membre du comité exécutif de 1978 à 1982 et son vice-président de 1982 à 1986, assumant notamment la responsabilité du comité des publications. Grâce à son travail au sein de l'Association, le nombre de membres provenant du Québec et du Canada est très élevé et ceux-ci sont très actifs dans les divers comités de recherche et comités administratifs.

Il a édité deux livres dans la collection de l'AIS, "Sage Studies in International Sociology": d'abord, en 1977, avec Marie Haug "Work and Sociology"; et en 1980, avec Akinsolo Akiwowo "National and Ethnic Movements".

Grand humaniste, Jacques Dofny était reconnu pour sa disponibilité envers les autres et notamment, ses étudiants, pour sa générosité et son humilité, mais aussi pour sa ténacité à défendre les objectifs auxquels il adhérait. Ceux et celles qui ont travaillé avec lui à l'Association, reconnaîtront sa capacité d'animer les longues réunions du comité exécutif et d'y apporter la détente nécessaire par son sens de l'humour et sa bonne humeur.

Jacques Dofny, était un homme des projets, animé par le besoin d'intervention et de réalisations concrètes. Mais il avait aussi besoin de silence, de beauté, de belle musique, interprétée au piano notamment; il s'entourait de tableaux de peintres, mais aussi de tableaux naturels, et les montagnes constituant son décor favori, il avait choisi de vivre ses années de retraite au pied du Mont Ventoux, en Haute-Provence.

L'Association internationale de sociologie vient de perdre un de ses membres les plus engagés et chacun de nous devra de développer l'héritage qu'il nous laisse.

### VERONICA STOLTE-HEISKANEN Executive Committee member 1990-1994

In July 20, 1994, when the sociologists all over the world were participating in the XIII World Congress of Sociology in Bielefeld, Veronica Stolte-Heiskanen (1934-1994) died in Helsinki. Four years earlier she had been elected as a member of ISA Executive Committee.

Veronica was an influential scholar in Finnish and international sociology, although the experiences of her childhood and early youth did not selfevidently point to a brilliant scientific career. She was born in Budapest in 1934 where her father was a famous liberal politician. After World War II the family had to flee from Hungary, first to Germany and later to the USA. In the USA she started her studies in sociology, anthropology, and psychology after having no education at the secondary school level. She received her Bachelor of Science at the University of Columbia and her Master Degree at the University of Chicago.

In the middle of the 1960s, when Veronica moved to Finland, after having married Ilkka Heiskanen, a Finnish political scientist, her primary interest was in family sociology. She presented her dissertation \*Social Structure, Family Patterns and Interpersonal Influence\* at the University of Helsinki in 1967. In the following years she published several articles and edited a number of books on family issues, family planning, and the position of women. She was also the chair of the ISA Research Committee on the Family Sociology in 1978-1982.

As a cosmopolitan person Veronica had a great impact on the internationalization process of the Finnish sociology. In the 1970s she was one of the most eminent sociologist in the country by being the editor-inchief of the journal "Sosiologia" and the chair of the Finnish Sociological Association, the Westermarck Society. In 1982 she was appointed professor of sociology at the University of Tampere where she became also one of the deputy vice Chancellors in 1990.

Along with her interest in family sociology, Veronica belongs to the pioneers of the sociology of science in Finland. As a national leader of the international Unesco project on the "Efficiency and Effectiveness of Research Units" (1973-77) she in fact started empirical science studies in Finland. She also had an influence on the institutionalization of Finnish science studies. Veronica was a founding member and the second chair of the Finnish Society for Science Studies as well as the first editor-in-chief of the journal "Science Studies". By her initiative Research Unit for Science Studies was established at the University of Tampere.

In the 1980s Unesco organized new rounds of the international effectiveness project with participants from Western and Eastern Europe, Asia, Africa, and South America. As the consulting expert of Unesco Veronica traveled in these countries establishing contacts with scholars from large international area. From these days dated her guests for more global international contacts and feelings of solidarity within the international scientific community. She was also the editor-in-chief of the "Cooperative Newsletter on Science and Technology Studies".

As a sociologist of science Veronica was interested in a broad variety of research topics. She studied modern characteristics of research work, effectiveness and evaluation of research, utilization of research results, ethics of science, conditions of autonomy, problems of science systems in peripheral countries, and women's position in science.

Veronica belonged to the few sociologists in Finland who had an influential position in the ISA. She was a Delegate to the ISA Council in 1987-1990 and member of the Executive Committee in 1990-1994. She organized a meeting of the Executive Committee in June 1992 in Tampere combined with an international conference on "Social Transformation and Cultural Identity" hosted by the Department of Sociology and Social Psychology at the University of Tampere and the Westermarck Society. She was also active in the ISA Worldwide Competition for Young Sociologists by being a member of the selection jury of the first competition in 1990 and the organizer of the second competition in 1994.

Veronica was a fascinating combination of national and international orientations and personal independence. Her exceptional experiences strengthened the cosmopolitan view of life. She was a brilliant discussant in informal international scientific meetings and a high level representative of the Finnish sociology. She was born in Hungary and educated in the USA but after her move to Finland she always wanted to represent the Finnish scientific community. We, her Finnish friends and scholars were very proud of her and feel that we have lost her too early.

#### Conferences

1990: RCHS started this period with a full programme of activities at the World Congress in Madrid: 43 papers were presented in RCHS sessions, and a further 28 papers in sessions held jointly with other RCs. At the business meeting it was reported that the RC then had 188 members from 29 countries.

1992: Institute of Political Sciences of the Hungarian Academy of Sciences in Budapest; it was organised by Eva Karadi and Denes Nemedi. The choice of venue was particularly appropriate in view of the Mannheim centenary, which was marked by two sessions with 12 papers on Mannheim, his contemporaries and his

legacy. There were also 3 other sessions, with papers on "Global Issues in the History of Sociology", "History of Styles of Research and Empirical Research\*, and an Open Session. 1993 was spent in organising RCHS's contribution to the 1994 World Congress. Full advantage has been taken of the extra number of sessions now available to RCs, and several with our programme included 12 rubrics, four of them joint with other RCs, and several with enough papers to fill two sessions.

#### Newsletter

Over the whole period in question a newsletter has been produced two or three times a year; in addition to news of conference plans this also includes lists of members and their addresses, details of new members and their special interests, details of new publications by members, news and notes about such matters as archives, conferences of other bodies, book recommendations, members' work in progress, members' moves and promotions, and obituaries of members who have died. It is hoped to start a series of short accounts of work in the history of sociology in countries whose languages are less widely spoken among the membership, to encourage wider communication.

#### Membership

RCHS has 183 members, from 27 different countries; the largest contingents are from the USA, Germany and Canada, followed by the UK, Italy and France.

#### XIII World Congress of Sociology

Although Bielefeld University was not the most convenient place for a World Congress and RC 09 presented itself in smaller size than in Madrid, we had four good sessions. As in other research committees, the focus this time was clearly on economic, cultural, and political transformations in Eastern Europe. Session 1 dealt with the reconfigurations of nations and national identities in Western Europe and Eastern Europe in a comparative perspective; of special importance were the new Germany, several Central Eastern European countries, and Russia. Session 2 focussed on the most problematic case, russia, attempting to assess the rapid and uncertain transformations in its economy, technology, social structure, and its political system. Session 3 raised theoretical and empirical issues on gender. Session 4 presented several case studies (India, Turkey, European periphery, Canada) on social transformations of national economies and welfare states in the context of a globalizing world economy. One of the central

impressions from these sessions is that the interests of the RC 09 members are indeed questions of social transformation in its socioeconomic, political, and cultural dimensions, context-bound, experience-near, theoretically informed, historical-sociological, global-local, and comparative between developed and developing countries.

#### Elections

At our business meeting in Bielefeld we decided to carry through mandatory elections to the new RC 09 board for the coming 4-years-term until the next ISA world congress shortly after this World Congress. Therefore, by October 15, 1994, we call for nominations of candidates who will run for the 1994-98 board and will be elected no later than May 31, 1995

The CPS has a dual affiliation: it is recognised as RC 18 by the ISA and as RC06 by the International Political Science Association. Its membership is fairly evenly divided between "sociologists" and "political scientists", and its officials represent both disciplines. This interdisciplinary exchange is the very idea behind the CPS. **Conferences** 

At the 1990 ISA World Congress in Madrid the CPS organized eight sessions plus a business meeting;

In 1991, the IPSA World Congress included two CPS sessions plus a business meeting. The difference is due to diverging ISA and IPSA policies as to the allotment of time slots to RCs. These numbers do not include sessions organized by our Work Groups outside of the CPS time slots.

At the 1994 Bielefeld Congress the CPS organized 11 panels and 4 business meetings.

At the 1994 IPSA Congress in Berlin, two panels and two business meetings were organized under the auspices of the CPS.

#### Interim Activities

The three Work Groups that have been particularly active during the period are "Breakdown and Consolidation of Regimes" (led by Juan Linz, Yale), "Elections and Parties" (Kay Lawson, San Francisco) and "Fascism and Authoritarianism" (Stein Ugelvik Larsen, Bergen). All of them have organized several meetings between world congresses and have an impressive output in terms of books and publications. New Work Groups are presently being planned within the realm of the CPS.

#### Statutes

A proposal was prepared by President Braungart for Business Meeting in Bielefeld, discussed and approved; presented again for Business Meeting in Berlin, discussed and approved; final version will be put to vote in Spring 1995 Newsletter.

#### Membership

The CPS membership is currently 110, representing 25 different countries. Approximately sixty percent are members of the ISA. The dual affiliation (ISA/IPSA) creates special conditions for the CPS membership policy, meaning that especially younger scholars and new world regions will be brought into the CPS. Newsletter

#### Interim conferences

The Intercongress Meeting of RC31 was held in Lisbon, Portugal, April 1992. The conference's host was the Universidade Aberta, Lisbon, and the organizer was Professor Maria Beatriz Rocha Trinade. - held a pre-Congress research workshop on "Women's Movements and Feminist Ideas as Forces of Social Change: Designs for Comparative Research\*, Hameln July 1994. It was co-organised with the Forschungsinstitut Frau und Gesellschaft (Research Institute Women in Society), thanks to the work of Carol Hagemann-White. The workshop provided an occasion for discussing common research interests on social movements and beginning the collaborative, comparative analysis necessary for new scholary insights.

World Congress in Bielefeld RC32 planned a programme, "Feminist Visions of Alternative and Sustainable Future" for the 1994 World Congress of Sociology in Bielefeld, Germany, and the RC32 program in Bielefeld was the fullest ever, with 16 scholary sessions as well as two business meetings. On the last day, hundreds of researchers and students stayed to attend RC32 double afternoon session- - despite lack of food and drink - and after many research committees had ceased to meet. To some extent, the meetings were a culmination of four years effort. The membership priority of RC32 has been young sociologists from the economic "south". #### Membership & Finances

In the period 1990-1994, RC34 experienced a strong re-grouping of its membership. At the time when the nominations for the new Board were sent out (March 1994), it had 103 members of "good standing". The membership fee for one four-year period was USD 30 for individual members and USD 300 for institutional members. Israel) 4%, Latin America (3%), Oceania (2%); (black) Africa is still missing at all. This profile shows a heavy "euro-centric"

#### Interim Conference

Giv'at Haviva, Israel, April 1993: RC36 Vice-President Menachem Rosner organized a joint conference of his Institute for Research on the Kibbutz and the Cooperative Idea of the University of Haifa, RC10 and RC36, entitled: "International Conference on New Trends in Organizations: Their Impact on Participation, De-alienation and Performance". There were over 40 papers, with some 60 persons attending - for the first time a good many from Eastern Europe, where interest in alienation is understandably soaring now.

Due to lack of funds a symposium on Alienation Theory and Research planned for Fall 1992, in the Netherlands, had to be cancelled.

Research Committee 40 has been very active in the period since the 1990 World Congress of Sociology. A pattern of activity has emerged which focuses on holding conferences in conjunction with the meetings of various scholarly meetings such that there has been, in effect, one meeting every year since the previous World Congress.

Integral to these meetings have been a series of publications. Some have already been published and several are still in process. A listing of the meetings and publications will provide an accurate idea of the activity of RC40.

June 1991: a conference on The Globalization of the Agricultural and Food Order was held at the University of Missouri, Columbia, Two volumes were published of conference papers: Alessandro Bonnano (ed.), "The Agriculture and Food Sector in the New Global Era\*, New Delhi: Concept, 1992; and Alessandro Bonnano, Lawrence Busch, William H. In addition, a Spanish language version of the latter book, "La Globalización del sector agroalimentaria", Madrid: Edita, 1994, will be published shortly. Following a Workshop organized by Philip McMichael of Cornell University held in conjunction with the 1991 annual meeting of the US Rural Sociological Society, "The Global Restructuring of Agro-Food Systems\*, Philip McMichael (ed.), was published by Trent University Press.

May 1992: A Workshop on "The Globalization of the Agriculture and Food Sector" was held in Petersborough, Ontario (Canada) at Trent University. This Workshop drew a number of papers which are presently in the publication process. The volume, with the tentative title "Conceptualizing Globalization and Restructuring", is being edited by Mustafa Koc of Ryerson Polytechnic University (Toronto) and Terry Marsden, University of Hull (UK).

August 1993: Held in conjunction with the annual meeting of the European Sociological Association in Wageningen. The Netherlands, the Workshop on "Concepts of the State in a Changing Global Agro-Food System", was built around six papers, each of which examined particular aspects of agriculture as reflected by state changes and adaptations under the impact of globalization. ### Conferences

In 1994, RC43 organized two conferences which were well attended and attracted participants from around the world. The first was held in Nairobi. Kenya, in June, in association with Mazingira Institute and the UN Cantre for human Settlements. Its theme wes "Gender, Urbanization and Environment". The presentations and discussion by over 80 participants from more than 30 countries produced a document containing a research and policy agend, compiled by Diana Lee Smith, which is expected to be useful in preparations leading up to Habitat II in 1996. In addition, a selectionof the more than 50 papers is expected to be published in book form.

A second conference was held in Bejing, China, in September, in association with the Bejing Academy of Social Sciences and co-sponsored by the Bejing Municipal Government and the Ministry of Construction of the People's Republic of China. Nearly 100 participants from 30 countries joined 165 Chinese colleagues in the presentation and discussion of papers under the theme of Global Challenges - Local Challenges.

#### **Bielefeld World Congress**

RC 43 ran a full and interesting program over a total of 15 sessions. The topics discussed at these sessions centered in four main themes: Housing exclusion and homelessness; The role of the state in housing provision and how this has been changing with the demise of communism in Eastern Europe and the restructuring of state welfare regimes within western societies; The question of "quality of life"; Gender and urbanization.

#### Future plans

RC43 will hold a small conference in Paris, May, 1995. "Social Change, Societal Restructuring and the Failure of Urban Politics", while preparations are underway for a large conference to take place in Washington, DC, in the Spring of 1997. Further details will be included in the newsletter which is distributed to members three times a year. Plans for 1995 also include the publication of a new Directory of Members.

Inevitably, most of its efforts during the past four years have been devoted to building up membership and the organizational basis for international scientific work in the future. The Business Meeting in Bielefeld (1994) approved the Statutes, introduced a membership subscription, and agreed to attempt to increase membership, particularly in non-OECD countries.

At the business meeting a new Executive Board was elected, larger than before and from a wider spread of countries. Despite the fact that the officers were more than willing to hand over their responsibilities, no alternative nominations were forthcoming and so the "old gang" remains in post. Changes will be essential in 1998.

#### Interim conference

In November 1992 the RC was co-organizer of a conference in Dublin on the theme of "Changing Systems of Workplace Representation". The main activity took place in workshop sessions, though both the President and the Secretary participated in plenary presentations.

#### World Congress in Bielefeld

RC44 occupied 11 of the sessions available for RC meetings (one of these held jointly with RC10), with some 50 papers presented. Some free space in the programme was left deliberately to allow members to do other things with a clear conscience; given the temperatures in Bielefeld, nobody complained of being underworked! Session chairs also kept the numbers on each panel within resonable bounds. to allow time for serious discussion. Contributors came from all parts of the globe, and themes covered a broad canvas. It was a valuable opportunity for both intellectual and social interchange among scholars of the labour movement.

#### Membership

RC44 has succeeded in recruiting 111 ISA members from 22 different countries; in addition there are some 60 non-ISA members attached to the RC. Newsletter

To date RC44 has produced three Newsletters. In 1993 it was awarded a Newsletter grant, and that facilitated more regular Newsletter production. A separate Newsletter Editor will be elected, allowing greater concentration on effort in its production.

#### Future conference

RC44 plans to hold a meeting of members attending the 1995 Congress of the International Industrial Relations Association in Washington DC.

#### Conferences

Many members of RC47 participated in the Fifth International Conference of the Carl Polanyi Institute in Vienna, in November 1994. This conference was titled "Re-reading the Great Transformation: Freedom in a Complex Society".

#### **Bielefeld World Congress**

Seventeen different sessions had been planned, with an eighteenth serving as a business meeting, but in the end some sessions were merged and fifteen different thematic sessions were held, as well as a business meeting. RC47 global theoretical session. entitled "Collective Action and the Critique of Modernity: New Challenges, New Perspectives", with the participation of Jeffrey Alexander, Anthony Giddens, Alberto Malucci and Alain Touraine attracted many hundreds of participants and had to be held in the Grand Auditorium at Bielefeld University. ### The Oñati International Institute for the Sociology of Law

The IISL was founded in 1988 by the International Sociological Association's Research Committee on Sociology of Law, and the Basque Government. It is associated with many European and non-European universities as well as an international network of sociologists of law who use its facilities for seminars, workshops and sabbaticals.

The Institute is headed by a Scientific Director as the senior academic administrator, who is responsible for carrying out the scientific policies approved by the Governing Board. ### The European Sociological Association

At the end of the 1st European Conference of Sociology at Vienna in late summer, 1992, a group of sociologists made up of delegates to the Conference from the European national sociological associations and other interested parties met to discuss setting up a European sociological association. As a result of that meeting, a Steering Committee was established, charged with developing an agreed structure for an association, drawing up its Statutes, creating a financial groundwork and establishing

the basis of a European sociological association's activities. This Steering Committee met periodically over two years. At a meeting of national delegates from the European sociological associations held during the XIIIth World Congress of Sociology at Bielefeld, Germany, the Statutes that would govern a European Sociological Association were adopted formally after a unanimous vote of approval; and, on the 18th of July 1994, the European Sociological Association (ESA) came into existence.

The ESA publishes a newsletter European Sociologist. It carries news about the ESA, runs a number of ongoing series (such as reviews of sociology in various regions or countries in Europe - the first is on the Baltic states) and carries announcements and the like sent in by ESA members. The first number appeared in October 1994 and was a special "first edition": giving the background to the ESA; reproducing its Statutes in full; and giving information about planned activities of the ESA, including the main "upcoming" activity - a 2nd European Conference of Sociology which will take place in Budapest in late summer 1995 (see Calendar of Future Events for more details). Contributions in English may be sent to the Editor or Associate Editors, in other languages to the appropriate editor, as indicated above. Where there is no indication of editorial coverage of a language, advice should be sought from the Editor. Papers are refereed by an international panel whose names appear in the fourth issue of each year.

2. Contributions are considered for publication only on the understanding that they are not simultaneously under consideration elsewhere in English, that they are the original work of the author(s), and that any previous form of publication is disclosed. Copyright is retained by the author, but the Journal is licensed to reprint.

3. Standard length of papers is 6000 words, but shorter contributions are also welcomed. They should be typed, double spaced on one side of paper with margins of 3 cm.

 Title, author's name, full address and brief biographical note should be typed on a separate sheet.

5. An abstract of 100-200 words should also be typed on a separate sheet.

# SOCIOLOGICAL ABSTRACTS

Co-sponsored by the ISA, sociological abstracts (sa) includes nonevaluative abstracts of journal articles from more than 2,000 core and discipline-related serials, plus citations of relevant dissertation taken from Dissertation Abstracts International. Published six time a year, each issue of sa contains the following: a brief user's guide; a table of contents which lists the major sa classifications with their subcategories; an author index; a source index; a subject index; and a supplement International Review of Publications in Sociology consisting of extensive abstracts of selected books published worldwide and enhanced bibliographic citations of book reviews taken from the journals abstracted in the same issue. A Conference Abstracts Supplement (CAS), published annually, contains abstracts of papers presented at various conferences throughout the year.

Selection and coverage: three types of journals have been distinguished in the following order of priority:

Type 1 - journals published by sociological associations, groups, faculties and institutes, and periodicals containing the word 'sociology' in their titles. These are abstracted fully, irrespective of language of publication.

Type 2 - journals from such related areas as anthropology, economics, education, medicine, community development, philosophy, statistics, political science, etc. Such journals are abstracted selectively.

Type 3 - journals from the humanities and

journals of general circulation wherein scholars and laymen publish discussions or criticism of sociology and sociological topics. These journals are abstracted selectively.

Publishers and editors are urged to send copies of new publications for abstracting.

 Information entered into the database since 1963 is available online from the following commercial information services: BRS, DIALOG, Data-Star, DIMDI, and EPIC.

 A subset of sociological abstracts contains journals abstracts entered since 1974 and dissertation listing from 1986 onward, is available on the sociofile compact disc.

- Social Planning/Policy, and Development Abstracts (SOPODA), published biannually since 1980, offers practitioners and social problems researchers access to in-depth abstracts of the journal literature in their areas of vital concern. SOPODA is also available online and on CD-ROM as a subfile of the sa database.

- sa and SOPODA are also available for lease on magnetic tape to academic institutions worldwide.

- SOCIOLOGY\*Express provides rapid and efficient document delivery of articles cited in sa and SOPODA.

- The <u>Thesaurus of Sociological Indexing</u> <u>Terms</u>, used to index all **sa** and **SOPODA** records, contains more than 4,000 terms arranged hierarchically with cross-references and scope notes.

- The <u>User's Reference Manual</u> provides detailed information on article classification, editorial and indexing practices, host-system search guides to simplify online searching, and a listing of journals screened.

 sociosearch offers custom searches of the sa database in response to individual requests.

 <u>Note Us</u>, a free quarterly newsletter keeps users abreast of the latest changes and enhancements to sa.

- The Journal List, updated annually, is a comprehensive list of serials abstracted in sa. Information provided for each periodical includes CODEN, country of publication, and ISSN.
