# I.S.A. INTERNATIONAL SOCIOLOGICAL ASSOCIATION

A group of sociologists from various countries, having met in Oslo September 1949 under the auspices of UNESCO being convinced of the desirability and necessity of improving relations between sociologists of various countries, established the I.S.A. (Preamble of Statutes 1949 - 1970). The council of the I.S.A., having met in regular quadriennal session at Varna, September 1970, and having given due consideration to the many changes that have occured in the Association, as well as in the broader world community of sociologists, adopted amendments to the Statutes originally agreed in Oslo. (Preamble of Statutes 1970). The International Sociological Association is an organization for purely scientific purpose. (Statutes I). The object of the association is to advance sociological knowledge throughout the world. To this end the Association shall undertake measures:

- (a) To secure and to develop personal contacts between sociologists throughout the world.
- (b) To encourage the international dissemination and exchange of information on significant developments in sociological knowledge.
- (c) To facilitate and promote international sociological research. (Statutes II).

#### 1. ACTIVITIES OF THE INTERNATIONAL SOCIOLOGICAL ASSOCIATION

#### a) INFORMATION ON OFFICIAL MEETINGS THE I.S.A. SECRETARIAT AND **EXECUTIVE COMMITTEE**

On November 9-11th, 1971, I.S.A. Executive officer Guido Martinotti took part in the meeting of the Secretaries of the disciplinary associations at the International Social Science of new Statutes for ISSC. The proposed new by-laws would deeply change the present structure of this organization basically by making it a federation of the disciplinary associations which now have a parallel position to ISSC. These proposals are to be accepted by the Executive Committee of the I.S.A., as well as by the other associations.

Taking advantage of the presence in Paris of I.S.A. President Reuben Hill and other members of the Executive Committee, two additional administrative meetings were held in the same days, first a restricted meeting of the President with the Executive Officer and Deputy Enzo Mingione. The I.S.A. staff took this occasion to survey several problems especially in view of the forthcoming meeting of the Executive Committee in Milan. The President and Secretarial staff met then with Prof. Gene Lyons, director of the Social Science Department of UNESCO.

During the following two days, took place a meeting of the Research Co-ordination Committee with the participation of Vice-President Tom Bottomore, Stein Rokkan and Erwin Scheuch (Anouar Abdel-Malek was not in Paris at the time). The Standing Committee reviewed the situation of Research Committees and discussed the possibility of convening the Research Council before the World Congress. The meetings were organized with the help of Mrs. Elina Almasy at the ISSC and at Reid Hall.

On December 1st, 1971, the Executive Secretary of the I.S.A. visited Vice-President Tom Bottomore at the University of Sussex to discuss additional problems connected with the co-ordination of Research Committees and with Current Sociology.

The Executive Committee of the I.S.A. and the Program Task Force for the VIII World Congress of Sociology met in Milan on April 9th through 16th to examine the suggestions collected by the Secretariat for the VIII World Congress of Sociology and to discuss the routine problems of the Association.

Format of the Congress: The scheme so far discussed is still very preliminary. By and large the schedule of the sessions will carry plenary meetings, round tables and general seminars organized around the main theme in the mornings and Research Committees and Ad-Hoc Groups in the afternoons. Some special topics will be dealt with in evening sessions. Particular attention has been dedicated to the problems of communication both within each of the sessions and in the pro-cedures for the distribution of papers. More precise details on this point will be circulate with the next issue of the Newsletter.

Theme of the Congress: The main theme of the Congress will be Science and revolution in contemporary societies. The general theme will be analyzed through two major subtopics, one dealing with the scientific and technological revolution and the second dealing with the role of sociologists vis-à-vis the ling with the role of sociologists vis-à-vis the revolutionary changes in society.

Round tables and general seminars will exa-mine specific aspects of the main theme. These meetings will be arranged in two large groups, one dealing with sociological problems of theory and method and the other dealing with the most relevant social problems. Special topics bridging the two aspects and topics of other kind will be dealt with in separate sessions.

#### c) REPORTS ON RECENT RESEARCH ACTIVITIES

#### 1. SOCIOLOGY OF LAW

#### Report on Varese meeting

The second International Symposium of Sociology of Law took place from 17 to 19 September 1971, at Varese, where our Committee had the opportunity of discussing current problems of Sociology of Law. The Proceedings started with a report by R. Treves "The administration of Justice in Italy" and were concluded by a speech delivered by N. Bobbio.

The English version of Treves' report had been previously circulated among foreign participants.

Simultaneous translation was provided both in French and in English so that all participants could follow both the reports and the debates which followed. Some members of our Committee were thus able to make an oral contribution.

The three meetings of the Committee took place as planned:

place as planned:
the first, presided over by B. Kutschinsky,
was on "Recent findings in the area of the
research on Knowledge and Opinion about
Law"; the second one, presided over by P.
Vinke, was on "Sociology of Law for Legal
Education"; the third one, presided by B. M.
Persson Blegvad, was on "the Role of the
Jurist in Society". The work done by the
Committee was of great interest: if possible
they shall give more extensive information in
the next Information Circular.

Two business meetings were held on the evenings of Friday 17th and Saturday 18th with attendance of all Committee members present at Varese.

At the meeting of Friday September 17th, there was general agreement as to the engagement of the Committee in carrying out some important initiatives: for this purpose it was emphasized that the Board will have to be formed of active and committed members and - in line with the authorization expressed by the Executive Committee of the International Sociological Association (see letter of May 20th, 1971) - the decision was taken to elect three new members to the Board. In the election which followed, Mrs. Persson Blegvad, Mr. Versele and Mr. Vinke were unanimously elected, whereas Prof. Apthorpe was excluded from the committee owing to the heavy responsibilities he has recently assumed in the Far East, which prevent him from any effective collaboration and have interrupted our correspondence.

At the meeting held on Saturday evening, adopting the proposals made by the delegates, the following new members were elected, in

the hope that they will all confirm their acceptance:

II. Rumanian Activities. The President of the

Academy opened the meeting and stayed for the first session. The Academy held a reception for the participants so that we had an opportunity to meet many other Rumania social scientists.

A meeting was held at the University of Bucharest with sociology students and faculty (about 50 in all) where the conference was summarized and a discussion followed.

The chairman spoke to the regular and large weekly meeting of the Sociological Laboratory. A general outline of the structure of the ISA preceded his address; it was followed by Professor Taigar's comments on the implications of the conference.

- V. Plans:

Since the Bucharest meeting, President Reuben Hill of the International Sociological Association has inquired about the Committee holding a plenary session at the next World Congress of Sociology.

#### 3. SOCIOLOGY OF SPORT Report on Waterloo meeting (23rd - 28th August 1971)

The 3rd International Symposium on Sociology of Sport was organized by the University of Waterloo/Canada from August 23 to 28, 1971. The Departments of Physical Education and of Sociology were in charge, with the ISA-Committee for Sociology of Sport sponsoring the event. The major topic was «Sport and Socialization » with a number of additional papers on general theoretical problems of sport and games.

The keynote address was delivered by Stanton Wheeler (Yale University). In all, more than 30 papers were read. More than one hundred sociologists and scientists representing Canada, Finland, France, West Germany, East Germany, Great Britain, Ireland, Netherlands, Poland, Rumania, USA, USSR attended the conference. The report of the proceedings will be edited by Gerald S. Kenyon (University of Waterloo).

#### 4. SOCIOLOGY OF LEISURE

### Presentation of project CIDOL (International Center for Documentation on Leisure)

The CIDOL project (International Center for Documentation on Leisure) officially presented at the VII World Congress of Sociology, Varna, Bulgaria, September 1970, by the I.S.A. Leisure Research Committee, has aroused interest in different countries. Specialists on modern documentation, researchers and teachers of Leisure Social Sciences have expressed a wish to take part in this project.

#### First proposal: Cidol nature.

CIDOL is a project for the creation of an international center for research, analysis and diffusion of scientific documentation on Leisure Social Sciences for researchers, teachers and men of action interested in the application of the research results.

Remarks: a) CIDOL is a project which, if it is to be put into effect, will require the collaboration of a number of countries. COCIDOL (see proposal No. 2) has been created in order to provide co-ordination.

- b) The expression, scientific documentation, refers to all documents providing an account of theoretical, methodological or empirical research already carried out or in course. This kind of document will be given priority during the first years, but CIDOL may extend its field of action subsequently.
- c) Social sciences will have priority but documents on district, health, educational sciences and so on will be included among the scientific documentation.
- d) In offering CIDOL services to men of action, we hope to encourage every kind of decision makers to make use of scientific researchers in order to help their action.

#### Second proposal Direction

The CIDOL project has been worked out and introduced by the I.S.A. Leisure Research Committee. It is the extension and systematization of a scientific action initiated by the Committee 12 years ago. Leisure Research Committee members set up, at Varna on September 1970, a 4 member committee: COCIDOL, concerned with the documentation of Leisure.

COCIDOL, at present composed only of sociologists, will subsequently include representatives of the other scientific fields and specialists of modern documentation techniques. The aim of COCIDOL is to promote CIDOL by interesting as many countries as possible in this project, by encouraging theoretic, methodologic and technical studies on the relations between research and documentation and by developing services for the future CIDOL.

Remarks: a) I.S.A. Leisure R.C. presently consists of about 50 sociologists from 18 countries. Structural development will allow it in 6 months time to accept associated members representing all the human and social sciences. The Leisure R.C. permanent secretariat is in Montreal/Canada; administratively COCIDOL will work through this permanent secretariat.

#### Third proposal: Organization.

#### a) International level:

Until the foundation of CIDOL, the following tasks will be carried out by the Montreal secretariat under COCIDOL supervision:

- 1 Coordination of activities of national centers:
- 2 relations with international institutes;
- 3 secretariat and translation:
- 4 supervision of preparation and testing of the thesaurus;
- 5 organization of technical groups in applicant countries;
- 6 direction of an investigation into requirements of Leisure documentation, in collaboration with applicant countries;
- 7 organization of international meetings;
- 8 introduction of bibliographic references; preparation of bibliographic indexes, publication of a bulletin, creation of a documentation forwarding service for subscribers.

#### b) National level:

Each country taking part in CIDOL must undertake the following responsibilities as far as materially possible:

- 1 collection of national documentation;
- 2 summary and cataloguing of documentation in its own language;
- 3 translation of documents into English or French using the terms provided by the thesaurus;
- 4 to recruit subscribers for CIDOL documentation services, which will begin in September 1972;
- 5 to search for funds in order to develop a Leisure documentation service at national level and to provide financial aid to the coordination secretariat in Montreal. It is clear that until the necessary funds have been found the project cannot be put into effect.

#### 5. NOTES ON RELEVANT ACTIVITIES OF OTHER INTERNATIONAL RESEARCH COMMITTEES

The I.S.A. Research Committee 9, tentative title: «Innovative Process in Social Change», set up in 1971 for a trial period of two years, is planning a special issue of the Journal « Centro Sociale », dedicated to the subject of Modernization.

#### I.S.A. Research Committee on Sociology of Knowledge

With a letter dated 21st February 1972, Professor Kurt Wolff, Chairman of the Committee, resigned his charge. Prof. Wolff stated in his letter that "the job has been, especially since Varna, far more a source of frustration than a gratification" and that it proved very difficult for him to communicate with members and to raise a relevant project of international activity.

The Executive Committee of the I.S.A. on April 19th, considering the dimissions by Prof. Wolff and the fact that the International Research Committee on Sociology of Knowledge had been inactive during the last period, discontinued it.

The Bulgarian Sociological Association is Sociological Association by Prof. Stoyan Mikhailov and Dr. Velichko Dobrianov.

The Bulgarian Sociological Association has the following structure:

- I. Central organs
- a. Congress the supreme body, meets every four years
- Council-directs the activity of the Associa-tion between Congresses
- c. Executive Committee directs the activity of the Association in accordance with the Statutes and the Decisions of the Congress and the Council
- d. Revisory Committee
- II. Regional Organs

The Bulgarian Sociological Association is composed of thirty sociological societies, district and 2 town societies. These societies have a total of 806 members. Each society has the following administrative organs:

- a. General Assembly
- b. Administrative Council
- c. Revisory Committee
- Activities of the Bulgarian Sociological Association.

Representatives of the Bulgarian sociologists / Representatives of the Bulgarian sociologists / 8 delegates and 24 guests / took part in the work of the Sixth World Congress of Sociology in September 1966 in Evian - France. At the Congress were presented 9 papers and 17 communications in 7 scientific sections. Part of the papers and communications treated the methodology and the findings of the section. the methodology and the findings of the socio-logical research of religion and the international sociological budget-time research made in the town of Kasanlak.

Three scientific sessions were held by the Bulgarian Sociological Association. At these sessions the following basic themes were discussed:

- a. Basic findings of the sociological research of religion
- b. Sociological problems of management of the national economy
- Sociology and socialist social practice.

1968 the Bulgarian Sociological Association organized an international symposium « Methodological Problems of the Sociological Research » with 30 papers and 41 communi-

During that period two courses were organized a five-day and a six-day one attended respec-tively by 87 and 64 persons. Furthermore the Association helped to organize a six-month course in sociology which was attended by 61 persons. The lectures at these courses were given by members of our Association.

In 1968, on behalf of the Bulgarian Socioloin 1968, on behalf of the Bulgarian Sociolo-gical Association, a bulletin was published entitled "Sociological Research". Publication of this bulletin will be resumed this year, The activity of the Bulgarian Sociological Association during the last years, and espe-cially in 1969 and 1970, was directed towards the organization of the Seventh World Congress of Sociology at Varna (14-19, IX, 1970).
For this purpose a special Organizing Committee was created. The members of the Executive Committee and the Council and many members of the Association took an active part in different activities during the organization and meeting of the Congress.

At the Congress our country presented 81
papers and in the various groups and committees the Bulgarian sociologists made 60 bmmunications.

The Bulgarian Sociological Association is a collective member of the Union of Scientific Workers in Bulgaria and of the International Sociological Association. It is a union of

sociological societies which are voluntary public organizations of persons concerned with the problems of sociology.

The main purposes and tasks of the Bulgarian Sociological Association are to provide active assistance:

- a. in the development of sociology as a science
- b. in the carrying out of sociological research on a modern scientific level
- c. in the training of sociological workers and raising their qualification
- d. in bringing about scientific management in our country by utilizing the achievements of sociology
- e. in the international collaboration of sociologists
- f. in the distribution abroad of information about the achievements of sociology in the People's Republic of Bulgaria.

The Bulgarian Sociological Association and its societies and members in particular took an active part in carrying out the empirical sociological investigation of town and village (1968). Using the stochastic-representative method, 18,994 persons were sampled and tested from all districts of the country, which provides representative information on a national scale. The research programme comprises the basic components of the sociological structure of society, starting from the labour activity, social position and ending with the principal forms of consciousness and cultural interests of individuals. After computer processing, the information is now being analysed and summarized by a large team, which will publish the detailed results in a scientific paper on the integral sociological structure of contemporary Bulgarian society. The experience obtained from this primary analysis confirms the preliminary hypothesis that this kind of sociological research gives the greatest theoretical possibilities for revealing the concrete action and forms of manifestation of the general sociological laws, as well as for formula-ting new sociological laws.

In November 1971, in Sofia, the Bulgarian Sociological Association was convened for a general conference on the theme of « Sociological problems of the construction of the socialist developed country ». 160 Delegates and 120 invited Sociologists took part, 42 papers were presented in one plenary session

and two sections.

The conference approved a document capital importance on the main orientations of development of Bulgarian Sociology until the year 2000.

#### 2. The Mexican Sociological Association

The 17th National Congress of Sociology was celebrated in Mexico City by the Mexican Sociological Association, under the auspices of the Mexican Society for Geography and Statistics. Eminent native and foreign Sociologists attended. The report on the Congress was published in 1971 in two volumes under the title of «Estudios Sociologicos», the first consisting of 591 pages, the second of 567.

Among the many interesting papers included in this work, we mention: "Perspectives for a Sociology of Art" by Jean Duvignaud; "Aesthetics Sociology" by Jean Casou; "The Canvas Picture in the XIX Century, Conservation, Transformation and Disappearance. Sociological Implications" by Mrs Marie Cecile Riffault: "The Musical Thought by Max Weber" by Alphonse Silbermann; "About Investigations of the Literature as Sociological on Utilization of the Literature as Sociological Documents » by Emile Sicard; « Sociology and Movies' Representation » by France Govaerts; « Responsibility of Criticism on Art » by Angel Osvaldo Nesi; «Society, Law, State and Literature» by Dr. Luis Recasens Siches; «Art Experience and Sociological Circumstances» by Dr. Roberto D. Agramonte; « Aesthetic Values and Social Relations » by Henry Jane; " Symbols' Function in Art Creation " by Juan Roura Parella; " Democracy and Aristocracy in Modern Plastic Arts " by Prof. Arturo Juncosa Corbonelle.

The Mexican Sociological Association in 1972 achieved the resumption of publication of Revista interamericana de Sociologia interrupted after no. 5 for lack of financial resources under the auspices of Mexican Society of Geography and Statistics.

In January no. 6 was published with articles by Lucio Mendieta y Núñez (México) « Social Investigation in Toxicomanias »; Oscar Uribe Villegas (México): « About Statistics Methods Villegas (México): « About Statistics Methods and Linguistic Applications »; Francisco Villagrán Kramer (Guatemala): « Conflict among rightists in Latin-America »; Raúl Noriega (México): « Technical Market of Culture »; Roberto Agramonte (Cuba, expatriated): « Latest Theories on Leadership »; Lázaro Barbieri (Argentina): « The Structure of Power »; Juan Pablo García Alvarez (Spain, living in México): « The Teaching of Sociology in Escuela Nacional Preparatoria de México in the last 100 nal Preparatoria de México in the last 100 vears »
