I.S.A. INTERNATIONAL SOCIOLOGICAL ASSOCIATION

A group of sociologists from various countries, having met in Oslo September 1949 under the auspices of UNESCO being convinced of the desirability and necessity of improving relations between sociologists of various countries, established the I.S.A. (Preamble of Statutes 1949 - 1970). The council of the I.S.A., having met in regular quadriennal session at Varna, September 1970, and having given due consideration to the many changes that have occured in the Association, as well as in the broader world community of sociologists, adopted amendments to the Statutes originally agreed in Oslo. (Preamble of Statutes 1970). The International Sociological Association is an organization for purely scientific purpose. (Statutes I). The object of the association is to advance sociological knowledge throughout the world. To this end the Association shall undertake measures:

- (a) To secure and to develop personal contacts between sociologists throughout the world.
- (b) To encourage the international dissemination and exchange of information on significant developments in sociological knowledge.
- (c) To facilitate and promote international sociological research.

1. REPORT ON THE ACTIVITIES OF THE I.S.A. RESEARCH COUNCIL MEETING

The following are points discussed and agreed upon by the Research Council at the meeting held in Cologne in May 1973, as summarised by Prof. Tom Bottomore, chairman of the Research Council and Vice President of the ISA.

1. Membership of Research Committees

It was made clear that the membership of Research Committees may comprise: (i) individuals who have paid dues directly to the Research Committee concerned; (ii) individuals who are paid up members of national associations; and (iii) individuals regarded as « in good standing », who may not be able to join a national association or to transfer funds in payment of their dues. However, it is the responsibility of the Board of each RC (possibly through a membership sub-committee), in consultation with the ISA Secretariat, to establish the definitive membership of their Committee. In Cologne membership lists, as known to the ISA Secretariat at that time, were circulated; these lists should be revised and supplemented as soon as possible by the officers of each RC, and then returned to the Secretariat.

There are three important points to be made concerning membership. First, the membership of any RC should not be allowed to increase indefinitely, to a point where administration and communication become excessively difficult. The aim should be to include the most active research workers from a reasonably wide range of countries and regions. Secondly, while many RCs do, and should, include members who are not sociologists, it is important to ensure that each RC has a large and active group of sociologists in it. Thirdly, membership of a RC might occasionally be used by an individual as a means of acquiring status in his own country; and there was general agreement that RCs should make clear that membership is accorded to those who are actively engaged in research in a particular field, but does not in any way confer recognition of the general academic or scholarly standing of an individual.

At present, the Statutes of the ISA limit any individual to membership of not more than two RCs. A number of people have criticised this limitation, and the Research Co-ordinating Committee decided to recommend that it should be removed. This was approved by the Executive Committee; and a proposal will be sent to the ISA Council, for decision by a mail ballot, that the Statutes should be amended as follows: there should be no limitation on the number of RCs an individual may join, but no individual should be eligible to become a member of the Board of more than two Committees, or an officer (President, Vice-President, or Secretary) of more than one Committee.

2. Boards of Research Committees. Elections The composition of Boards should not be defined too inflexibly. At present, the Statutes do set out the precise composition of Boards, and the subject may need further discussion, and possible amendments. Concerning terms of office, it would be desiderable for the membership of Boards to change at regular intervals, and that a limit of two consecutive four-year terms of office might be set.

The Statutes provide that elections to the Board of a RC must be held every 4 years, but they need not coincide with the World Congress, and they could be conducted (and probably most conveniently conducted) by means of a postal ballot. Such a postal ballot, and especially the counting of votes, could be undertaken, if the members so wish, either by the ISA Secretariat, or by Prof. Bottomore in his capacity as Vice President responsible for research activities.

I shall be writing to the Presidents and Secretaries of RCs individually about the elections due to be held between now and the Toronto Congress, but in the meantime I would ask you to inform me if you are already making plans for elections. I would like to emphasize here the importance of establishing a *definitive list* of members of your RC (as mentioned earlier), since this list will determine who is eligible to vote in the elections.

3. Activities of Research Committees

On the basis of reports submitted by most of the RCs, and additional statements from delegates at the meeting, a wide range of activities was discussed: publication of newsletters, journals, symposia, etc.; organisation of sessions at World Congresses; regional and international seminars; organisation or sponsorship of comparative research. The discussion provided some criteria for judging whether a RC could be considered « active ». Contacts will be made with the few committees which have not shown much sign of life since the Varna Congress.

A number of problems have emerged, especially concerning the financing of seminars or of meetings to plan and develop comparative research. The difficulties of financing such international activities are not likely to be overcome easily, but some help, in specific areas, might be obtained through UNESCO projects and contracts, and the Research Co-ordinating Committee will be pursuing discussions on this subject. There was a useful discussion during the meeting, of the possibilities for co-operation between several RCs in, studying and advising on broader problems which are relevant to more than one committee and which concern international agencies; e.g. the environment.

4. Current Sociology

The new editor of *Current Sociology*, Dr. Margaret Archer, outlined her proposals (subsequently approved by the Publications Committee and the Executive Committee) for giving a different character and orientation to the journal. In particular, she suggested that *Current Sociology* should be more closely linked with the RCs, in the following ways:

(i) it should publicize RCs activities.
 (ii) the ISA Newsletter should be incorporated in *Current Sociology*.

(iii) a special Congress issue of Current Sociology should be published, containing reports on major fields of interest and research developments in the RCs. Dr. Archer will be writing to RCs about the preparation of this special issue. In addition, it was suggested and approved that the RCs should act in an advisory capacity to Current Sociology, and each RC will be asked to appoint a liaison officer for this purpose.

5. The Research Co-ordinating Committee

The role of the Research Co-ordinating Committee was briefly discussed. On one side it represents the RCs between meetings of the Research Council, deals with the establishment of new committees maintains relations between the RCs, and will also keep in contact with UNESCO and the International Social Science Council in order to aid, so far as possible, the development of research. On the other side it is a means through which the RCs can maintain a closer contact with, and influence more directly, the Executive Committee.

In order to strengthen these activities of the Research Co-ordinating Committee it was agreed to elect two additional members from the Research Council, and Professor Michel Crozier (France) and Professor Jiri Musil (Czechoslovakia) were elected (22 members of the Research Council voted). It was also necessary to hold an election to replace Professor Robert Merton, who had resigned from the Committee, and Professor Morris Janowitz was elected (23 members of the Research Council voted).

This past year witnessed a number of activities which spun off from members of our ISA Committee. Some of these were undertaken directly under the auspices of the Committee, while others were undertaken through connections with other organisations in which several. Committee members participated.

1. Compendium of Current Compendium of Current Community Research.
 A request was sent to all persons on several lists including members of our Committee requesting them to summarize in one page their current research.
 Abstracts of one page listing lines of current research. current research investigation, draft reports available, finished publications, data sets and related information were published and circulated to members of the Committee. The Compendium is also available for \$ 3.00 to other persons and almost 1.000 copies have been distributed in this manner. 2. In conjunction with other groups concerned with Community Research, the Newsletter which Terry Clark had edited as Chairman of the Research Committee for the past several years was replaced by a more ambitious publication. William Hanna at the City University of New York is serving as editor of the new publication, Comparative Urban Research. It is a quarterly publication, the first issue of which contained almost 100 pages of research and progress reports, brief articles, listings of conferences, recent publications and related material of interest to persons in the community research area. It promises to be a very important and useful vehicle and thoroughly justified collaboration of our Committee with other groups concerned with similar matters.

Another example of such inter-3. organisational cooperation took place this last year in conjunction with the American Sociological Association. A petition of members of the International Sociological Association and others led to the creation of a new Section as a permanent structural addition to the American Sociological Association. It is a Section on the Community. By-laws were prepared and a first set of officers elected. The first Chairman is Roland Warren of Brandeis University. The creation of the Section makes possible formally three sessions at each of the Annual Meetings of the American Sociological Association. Three panels were thus held at the New Orleans 1972 meetings of the ASA. As many of the American members of the ISA Committee were concerned with being able to meet in the context of the ASA, this new Section makes possible such continuing collaboration. Clark is serving as Chairman of the Committee on Institutional Coordination of the new ASA Committee.

Several active members of the Committee outside of the United States met with many American members at a special conference on urban studies which was held in Los Angeles in June, 1972. The conference was organised by the Council

for European Studies. About 80 persons were brought to Los Angeles for the conference. It has been summarised elsewhere in the Council for European Studies Newsletter. 5. Discussion among several persons active in the community area in Los Angeles led to the creation of a new Committee within the Council for European Studies : The Committee on Comparative Subnational Policy Outputs of which Terry N. Clark is the Chairman. Its goals are threefold: Immediately to bring together data sets on Subnational Policy Ouputs of interest to scholars throughout the world and to prepare these for storage in a special archive created in conjunction with the Inter-University Consortium for Political Research at the University of Michigan. Second, to hold focused conferences concerned with establishing comparability across different data sets. Third, to hold more general conferences concerned with research involving these and related data. The new committee met at the Council for European Studies conference in Los Angeles as well as in Washington in conjunction with the meetings of the American Political Science Association. 6. The major publication of the Committee which is soon to appear is the volume, Comparative Community Politics, edited

Comparative Community Politics, edited by Terry N. Clark, published by Sage Publications, Beverly Hills, California. It includes contributions from Ken Newton, Robert Alford, Michael Aiken, Mark Kesselman, Charles Tilly, Jurgen Westerstahl, Eugen Pusic, Delbert Miller, Thomas Anton, Henry Teune, Robert Fried and Peter Jambrek. Of some interest to persons concerned with comparative and international studies of the community are two additional volumes which appeared in the past year. volumes which appeared in the past year: Brian J. L. Berry, ed., City Classification Handbook, New York: John Wiley, 1972; and Philip E. Jacob, ed., Values and the Active Community, New York: The Free Press, 1972. A volume in Current Sociology has 7. A volume in Current Sociology has been completed by Terry N. Clark and Irving Leif. The Trend Report is entitled, Community Power and Decision-Making, and will follow the 'long format'. It appears that the complete bibliography will not be able to be included even in the long format. It will be available in mimeographed form from Professor Irving Leif, Department of Social Science, Drexel University, Philadelphia, Pennsylvania, It includes almost 1,000 entries. 8. As mentioned above, after several years of effort, a special data archive on subnational policy outputs has been created in conjunction with the Inter-University Consortiuum for Political Research at the University of Michigan and the Committe on Comparative Subnational Policy Research of the Council for European Studies. Approximately a dozen large data sets for various nations are currently being or will shortly be placed in the archive, and others have been promised in the near future. These data sets will be available to any requester, whether or not he is from a member institution of the Inter-University Consortium for Political Research for Political Research.

The Research Committe on Sociology of Education held its first meeting in Turin from the 10th to 12th April 1972; twenty five researchers took part in the meeting and discussed the following themes:

- questionnaires and of psychological experimentation

The next meeting of the Research Committee will take place in Warsaw from the 15th to the 18th of September 1973 and 25-30 participants will meet and discuss the theme: Schools and modern means of communication: are they factors of cultural reproduction or of cultural redistribution? » During this meeting, organised on the initiative of Mrs. Kloskowska, people will try either to define the main orientations and the themes of the meetings at the 1974 World Congress in TORONTO or to set up the activities and the objects of the Committee.

The main theme proposed for the Congress is: . Education and scientific and technical

development ... In order to favour either the exchange of scientifical information or the realisation of comparative researches, the Research Committee has undertaken.

- 1) the realisation of an investigation by questionnaires, conducted by all the researchers in sociology of education, which should a) allow the constitution of a Yearbook of researchers on educational sciences and b) serve as the basis for a study of the sociology of science on the history and constitution of sociology of education. The questionnaires will be sent to all the researchers during 1973.
- 2) the elaboration of a Statement of researches on education, which could be published by the journal « Current Sociology ».

The Research Committee also plans to favour, as far as it possibly can, the elaboration, the discussion and the realisation of comparative researches.

ACTIVITIES 1972-1973:

A . Newsletter » has been prepared. The first two numbers are ready, and will be issued (one of them at least) in the very near future. The first issue will deal with general information about the Committee, its origins, organisation, membership, etc... and the preparations to be made in view of the VIIIth World Congress; the second will, among other things, start giving information about existing research Institutes in various parts of the world and their current activities. The Chairman of the Committee, in his official capacity, took part in a Seminar organised by the University of Denver, Graduate School of International Studies on: « Regulating Racial Discrimination in employment », and held from October 2 to October 6, 1972, at Villa Serbelloni, Bellagio. This was regarded as an opportunity for contacts with major research institutions in the field of ethnic and race relations studies, which would help in developing membership and a research programme. Participation at the seminar has definitely proved useful in both respects.

Projected activities for 1973 are, for the time being:

1) to continue and strengthen the Newsletter preparation of the VIIIth World Congress 2)

in Toronto 3) elaboration of a research programme.

A future meeting of the Board still appears uncertain, for in view of the geographical dispersal of the Board Members (India, France, Great Britain, Singapore, U.S.S.R.), travel and subsistance costs U.S.A., appear to be prohibitive. It is very likely that the actual organisation of a Committee research and conference programme will have to be postponed until the Toronto meeting. In the meantime, active preparations can be made through correspondence and circulation of the Newsletter.

ACTIVITIES 1972-1973:

Regional Group Meetings. Held in 1971, October 19-22, but not previously reported, the first Regional Group Meeting of Family Sociologists from Socialist countries met in Warsaw, Poland. Some 30 sociologists attended from Bulgaria, Czechoslovakia, East Germany, Hungary, Poland and Yugoslavia. Dr. Jerzy Piotrowsi, (Waszawa, Filtrova 62/71) was chosen as convenor of this regional group, associated with the C.F.R. The group appointed representatives in each country to prepare an annual bibliography of family research. A full program of papers on the research findings during the past ten years or so by family sociologists in each country was presented at this first meeting. The Fifth Japanese Seminar on Family Sociology took place in Tokyo for three days from July 28 to 30, 1972 with the theme of « le and Modern Families in Japan », and had 72 participants. The Sixth Japanese Seminar on Family Sociology will be held in Osaka for three

days from July 23 to 25, 1973 with the theme of « The Japanese Family in Transition ». The papers presented at the Third (1970) and Fourth (1971) Seminars will be published in May or June 1973 in book form by Baifûkan in Tokyo, under the joint editorship of Professors Aoi and Masuda. We look forward to important contributions from this group at the Eighth World Congress, Toronto 1974.

The Regional Group for the Netherlands and Flanders (Chairman: C.D. Saal) met three times in Utrecht, the last time in April 1973. An extensive report on the commune in past and present was amply discussed during the most recent of these short conferences.

The C.F.R. donated \$ 300.00 to assist the translation into Russian for this purpose. M. Sussman, in close co-operation with A. Kharchev, is now editing an English version of the seminar report.

Sponsorship of Research 3

The cross-national study on theory for the study of family and modernisation led by Marvin Sussman, U.S.A. reports that most field work in 10 countries is complete. The first volume of the series of reports should be ready in 1973.

repeated above preliminary discussion As for a second cross-national study, probably focusing on leisure and the family, began in Moscow.

4. Main activities of Chairman and Secretary The President, Gerrit Kooy and the secretary, John Mogey met three times during the year. Two issues of the CFR Gazette and an information document for members of CFR were prepared and circulated to about 400 sociologists in 40 different countries. The new I.S.A. statutes on membership pose two problems for the CFR: (1) criteria for selection and (2) members in nontransferrable currency countries. With regard to selection, (1) it was decided to admit all applicants pending discussion at the 8th World Congress, Toronto, 1974. Currency problems, (2) were solved by compiling a list of applications with Jerzy Piotrowski, through the Regional Group of Family Sociologists and by keeping the membership fees in Poland, pending the outcome of negotiations on methods for their transfer to the I.S.A. Executive. 5

Constitution

Prepared by a committee led by Joan Aldous (USA) a new constitution was circulated for comments in the January, 1972 CFR Gazette. All comments received were favorable. Therefore, at their third meeting, G. Kooy and J. Mogey decided to operate by the rules laid down by this Constitution. will be proposed for formal adoption It at Toronto, 1974.

ACTIVITIES 1971-1973:

This Research Committee is now at the end of its second year. It grew out of an exchange of ideas at the Working Group on « Modernisation and Innovation » during the 7th World Congress at Varna, where many delegates expressed reservations on the ideological implications and current usage of the modernisation concept. Its report submitted to the final plenary session on the proceedings indicated there seemed to have been an overall implication that «Modernisation» should necessarily be an evolution toward the life patterns and techniques of dominant or advanced nations and that the papers presented tended to bypass the issues of modernisation goals and their supporting attitudes, the meaning of social processes, and the causes of conflict in modernisation. Consequently it was decided that the updated concept of social change process would avoid some of the biases and could cover the gamut from development to subversion. The report further stated that future diffusion research should consider the uses to which such research has been and will be put either by structures that want to maintain their position or in view of the transformation of such structures. It also seemed that research on innovations could be made more relevant to momentous social transformation and that particularly autonomous diffusion (where the innovation comes from within the system like, for instance, from subordinate and peasant groups rather than from external sources) should become the object of analysis. Proposed by sociologists from Mexico, Israel. Colombia, Italy, Great Britain, the United States and Sweden, the formation of this Committee was approved by I.S.A. Executive Council in May 1971. During the year 1971 the founding members of the Committee held meetings in their own countries and recruited fellow scientists interested in the topic. Membership grew to the present 55 including those who applied directly through the I.S.A. Secretariat from fourteen other countries. On January 27, 1972, the chairman ad interim called on a mail ballot to elect the officers of the Committee. The elections results are shown above. These officers have accepted their appointment. The formal announcement of these results came out in I.S.A. Newsletter Nº. 2. Following this basic action, the Committee officers have exchanged views on the organisation of national meetings. This has been contemplated for Belgium, Italy, and Colombia. Likewise, an informal debate through the mail was started on the title and contents of the Committee's sessions for the 8 th World Congress. A preliminary outline was prepared, which is now under further discussion. The first activity of the committee was the publication of an anthology on « Modernisation » thanks to the financial assistance of the Olivetti Foundation. It consists of a monograph in the journal Centro Sociale (n. 106-108, 1972) in Italian, while an English and Spanish version are still at the planning stage. The Preface, describing history and scope of the Research Committee, was written by Fals Borda as the Committee Chairman. The articles develop the theoretical and applied approaches to the concept of modernisation and present the reader with the classical views, the interdisciplinary aspects, and the recent criticism versus the prevailing methods and cultural stance. The applied studies were chosen particularly for their representativeness at this time; their authors had been participants of the original

working group.

Any field research under committee auspices,

obviously, would have required a membership meeting which in fact was to take place in 1972 at the Rockefeller Foundation Center in Bellagio but did not materialise as the Foundation after prolonged negotiations decided against letting us use their facilities. ACTIVITIES 1972-1973:

After the 7th Congress repeated attempts were made to hold committee meetings to discuss the key sociological problems of operation and development of the system of international relations today. This is shown by lively correspondence between members of the Research Committee. The Committee, however, encountered great difficulties in finding funds with which to prepare and hold a large conference of its members. Unfortunately, these difficulties precluded regular work of the Committee. Nevertheless, at present favourable opportunities for intensive activities have opened up before the Research Committee of Sociology of International Relations. A definite turn toward détente is in evidence on the international scene, which opens new horizons, gives rise to new hopes and, as a consequence, enhances the interest of the public, national and international organisations in sociological research in this field and in sociologists' opinion. It is expected that the favourable developments on the world scene will facilitate successful work of the Research

Committee of Sociology of International Relations. The Committee Chairman has recently received a number of letters from leading sociologists willing to take part in its

activities, in particular, in an open session of the forthcoming 8th World Congress of Sociologists.

A preliminary exchange of views between members of the Research Committee has

revealed the main items of the agenda to be proposed for the Committee's open session at the congress to be held in Toronto.

The agenda proposed will enable a useful and constructive discussion to be held by sociologists of different countries and various sociologists of different countries and various schools on problems of vital importance for all. Needless to say, this discussion may contribute to a successful search for ways to establish a lasting peace on earth. At the same time, it may contribute to the advance of sociology. Regarding preparation of an open session as its main objective at the forthcoming world congress, the Research Committee will cimultaneously seek a nossibility to hold simultaneously seek a possibility to hold one or two meetings of its members even before the Congress opens. Appropriate steps in this direction will be taken in the near future.

1) In October, in collaboration with the International Centre of Social Gerontology and with C.E.L.E. of Prague, the Committe organised a week of study dedicated to: — a comparative survey of the development of Leisure in seven societies, concentrating particularly on comparative methods and data analysis.

- Various experts in economy, history, and mathematics made contributions to this Seminar. For this occasion,

a special edition of the Prague Centre Journal was published: « Society and Leisure », on Secondary Analysis.

2) CIDOL (Centre International de Documentation du Loisir) Following a meeting of collaborators and researchers organised at the end of 1971 with the backing of the Council of Europe and at which organisations from ten different countries took part, work was continued in two directions:

- technical: completion of the first bi-lingual Thesaurus on Culture and Leisure carried out by an international team of sociologists.

administrative: financial support was obtained by the Universities of Hamburg and Lund. An initial network was established with five countries participating:

France, Sweden, West Germany, Czechoslovakia, Scuth Florida. Furthermore, definite contacts were made in February 1973 with the « Information Relieval System for the Sociology of Sport and Leisure (SIRSS) of the University of Waterloo (Canada), directed by G. Kenyon. This automatic information system for sport and leisure is very similar both for its content and its intended users to the CIDOL project, with the emphasis more on sport than on other leisure activities.

Compatibility of methods and results is still under study. Publications. Committee members take active part in the publishing of Society and Leisure, issued every three months by the C.E.L.E. of Prague which co-operates permanently with the Committee.

With reference to the comparative survey, two special editions were published dedicated to secondary analysis and comparative method. Committee members also contribute to the national bibliographic series on Leisure published by the same organism. (In 1972, Great Britain, by S. Parker). Forthcoming in 1973, France, Yugoslavia. **1973 PROJECTS**

1) Comparative Survey. The comparative survey will continue in 1973. A meeting fixed for October in Hamburg will be a culminating point for work done up till then. A special edition of

« Society and Leisure » will give the first results in the form of a comparative study in various societies on the development of working hours and on Spending for Leisure.

The Committee President will take part in the Methodological Seminar on Comparative Methods organised by professor Scheuch in Köln. During the same period he will also attend the I.S.A. Scientific Council meeting.

2) New Studies.

The Committee Director is, together with Professor D. Szabo, co-director of an international comparative study on the relationship between leisure and delinquent behaviour among young people. Professor Szabo directs the International Centre of Criminology of the University of Montreal Criminology of the University of Montreal, and is President of the International Committee for Criminology. The study was set up in collaboration with researchers on Leisure from various countries.

This study is in direct relationship with the comparative study on the Evolution of Leisure in advanced industrial and post industrial societies.

3) CIDOL

A project is foreseen to study SIRSS's methods. Experiments with the thesaurus and the analysis will be made from now until October 1973, at the concerned centres of Lund, Prague, Hamburg, Tampa and Paris. Comparisons and criticisms will be made at the meeting in October.

4) VIII World Congress of Sociology. A preliminary meeting regarding the Leisure Committee's participation at Toronto has already been held. Co-operation with the Sport Committee was established — a common session of the two Committees will be held on the theme « Sport as a Leisure Activity ».

Subsequent copies of the **Newsletter** will only be sent to regular Committee members.

2. 2. Types of Membership.

In order to obtain a closer involvement of members in the activities of the Committee and to secure wider geographical representation, it has been suggested (though not yet carried out) that the following three categories of membership be established:

- Six members to constitute the Steering Committee (no change from the present situation).
- (2) The formation of an Advisory Council of the Research Committee consisting of up to 40 members to provide wide representation and geographical distribution.
- (3) Members of the Research Committee in good standing with the ISA.
 3) BUDGET:

Several efforts to obtain overall fiscal program support (e.g., solicitation of philanthropic foundations) by members of the Committee have not been successful. As elsewhere indicated, support has been obtained for the sponsorship of specific conferences or meetings held under the general aegis of the Research Committee. The working sessions of the Steering Committee and the development of its membership roster have relied upon individual or affiliated institutional sources. 4. PUBLICATIONS:

4. 1. The Steering Committee proposed that a summary of the Varna papers (R.F. Badgley, Studies in Planning Health Manpower: The Varna Meeting, Journal of Health and Social Behaviour, 12:4-10, March, 1971) be sent to members of the Research Committee with the Committee's first issue of its Newsletter.

4. 2. Trend Report.

Prior to its constitution as a Research Committee in 1963, interested scholars had fostered several activities in the area of the sociology of health at previous ISA congresses. Significant among these were the review of the sociology of hospitals in 1959 (G.G. Reader and M.E.W. Goss, Medical Sociology with particular reference to the Study of Hospitals).

to the Study of Hospitals). **Transactions of the Fourth World Congress of Sociology**, Volume 2:139-152, 1959) and an internationally-focused bibliography for the field prepared by E. Freidson (E. Freidson, The Sociology of Medicine: A Trend Report and Bibliography, **Current Sociology**, Volume 10-11; No. 3, 1961-1962). As the state of the field has expanded, the Steering Committee has sought, with the concurrence of Professor Freidson, to prepare an up-dated selected international bibliography. Professor Manfred Pflanz has agreed to write this trend report and to have it completed by the summer of 1975. It is expected and hoped that it will be published in **Current Sociology.**

5) NEWSLETTER:

The first issue of the Medical Sociology Newsletter appeared in November, 1972, and was sent to more than 1,500 socio-medical scientists around the world. Professor Derek Gill of the MRC Medical Sociology Unit, Centre for Social Studies at Aberdeen. Scotland, is the current editor of the Newsletter. A special note of thanks is due to Professor Gill for serving in that capacity and to Professor Raymond Illsley and the Medical Sociology Unit of the Medical Research Council at Aberdeen for having accepted the heavy responsibility of serving as the home base of the Newsletter and providing the necessary logistic support for its publication and distribution.

6) CONFERENCES AND ALLIED ASSOCIATIONS:

6. 1. Sponsored Conferences. The Research Committee served as a sponsor of the Internationale Seminar für

Medizinsoziologie, under the chairmanship of Professor Kurt Winter, heid in Berlin, German Democratic Republic, in October, 1971. The proceedings of the Seminar were published in 1972 in Berlin. The Committee is also sponsoring the forthcoming Conference on Medical Sociology, to be held in Warsaw in August 1973, under the chairmanship of Professor Magdalena Sokolowska. The following topics will be examined: (1) Social Structure and Health; (2) Applicability of Utility of the Social Sciences for Solving Medical Problems: Theories, Indicators, Research; (3) Social Planning and Health; (4) The Health System as a Social System; (5) Teaching - a) Social Science and Medical Education, and b) Medical Sociology for Sociology Students; (6) Round Table: Socio-Therapeutic Processes.

Ten socio-medical scientists are being invited to participate from North America, 10 from Western Europe, and 10 from Eastern Europe. An additional 30 participants from Poland in the audience are expected. A variety of topics of interest to socio-medical scientists will be examined. The Committee will also sponsor a Seminar on the **Methodology of Cross-National Socio-Medical Research**, under the chairmanship of Professor Manfred Pflanz, to be held at the Akademie für Sozialmedizin in Hannover in March of 1974. The Seminar will focus upon: (1) Cross-Cultural Comparison of Diagnoses and Diagnostic Techniques; (2) Problems of Comparing Socio-Economic Indicators Across National Boundaries; (3) Problems of Definition in Cross-Cultural Research and Translation of Questionnaire Material. The number of participants will be limited to 60.

6. 2. Relations with Other Research Committees, Allied Associations. Through correspondence, and, on occasion, by joint membership, liaison has been maintained with the chairmen of other ISA Research Committees (e.g., Psychiatric Sociology) and other associations (e.g., Committee on International Medical Sociology of the Medical Sociology Section, American Sociological Association; Section Committee on Psychiatric Epidemiology and Community Psychiatry, World Psychiatric Association). An attempt will also be made to establish liaison with medical anthropologists and possibly to organise a joint session with them at the Toronto Congress.

6. 3. World Health Organisation. Through the efforts of the Committee, the International Sociological Association was admitted into official relations with the World Health Organisation as a Non-Governmental Organisation.

7) COMMITTEE ADMINISTRATION

1974 Nominating Committee. As the structure of the I.S.A. evolves, membership on the six-member Steering Committee will result from an election among dues-paying members. The composition of a Nominating Committee, who is eligible to vote, the election by mail procedures, and election dates are to be set.

ACTIVITIES 1972-1973: The group, informally organised by the late professor John Kosa (Harvard Medical school) and around the International Newsletter on Migration (edited at the University of

professor John Kosa (Harvard Medical school) and around the International Newsletter on Migration (edited at the University of Waterloo, Canada, by D. Kubat), was granted provisional Research Group status in the spring of 1972. The first official effort of the group was to elect a governing board pursuant I.S.A. Statutes Art XI, 5 and 6. The exchange of

Statutes Art XI, 5 and 6. The exchange of correspondence between Professor Kosa and other interested parties produced a slate of names on a ballot mailed out with the Vol. 2 No. 2 (May 1972) issue of the International Newsletter on Migration, specifying mailed ballots to be returned by August 31. The actual mailing of the Newsletter containing the ballot took place late June and early July during which time professor Kosa died. A follow-up ballot suggesting professor Anthony Richmond (York University, Canada) as president of the Research Committee in lieu of professor Kosa was mailed out in the middle of July to the addresses on the Newsletter mailing list, extending the return deadline for ballots to September 15. The nominating procedures were fairly standard. The original group as organised by Professor Kosa and as extended through the interest around the Newsletter was considered as a bona fide voting

was considered as a bona fide voting constituency. Standard procedures for nomination, in view of pro tempore nature of the first board to be elected were

followed, suggesting at least some choices for the posts of vice-presidents and members of the board. Normally, only one name is put forward for the office of the Secretary and this time only one name was put forward for the office of president of the Committee as well, due to the particular circumstances which gave cause to the formation of the group initially.

The past activities of scholarly nature were mostly those centered on the publication of the International Newsletter on Migration, now in its third year. The Newsletter has sought to serve mainly two functions: One, to identify research interests and preoccupations in the field of sociology of migration to those interested. The mailing list has increased from the initial one of about 50 to the present one of slightly under 300 addresses. Two, to publish occasional focused bibliographies on migrations; thus far, three bibliographies on migration have been published, one on migration in Canada, one on migration in Yugoslavia, and one on migration of talent.

The Research Committee expects to publish the Newsletter as part of the International Migration Review which reaches most of the Migration scholars in North America and as part of the International Migrations which reaches most of the migration scholars in Europe. The details are still being worked out to ensure that all members of the Research Committee will receive the Newsletter even though they may not be subscribing to either journal mentioned. As regards other activities, the Research Committee piggy-backed several national sociological meetings during the past year in order to promote an interest in migration. August, 1972, it sponsored a Roundtable on Migration during the meetings of the American Sociological Association in Denver. The Roundtable lucheon was chaired by D. Kubat. In April, 1973, several members of the RC met in New Orleans, during the Population Association of America meetings. In May, 1973, the RC sponsored a session on internal migration (chaired by D. Kubat) during the Canadian Sociological and Anthropological Association meetings in Kingston, Ontario.

A major international conference on migration, sponsored by the Research Committee on Migration and the University of Waterloo, will take place during the latter part of October, 1973. During that conference the board of the RC will meet and discuss the activities and plans of the RC in detail; this will constitute the first meeting of the board after the election. The details and the programme of the conference will be published in the May issue of the Newsletter.

The scientific program for our R.C. during the period 1970-74 has been broadly defined as the exploration of the following fields:

- National movements and social revolutions

One of the key areas is definitely the study of contemporary imperialism. However, and as from the specific history of our R.C, the stress is being laid upon the problematic of the national question in contemporary societies;

- Imperialism and national liberation struggles;

National and social revolutions;

- Liberation and revolution etc.

Our R.C. will hope to provide a suitable platform to help further research on such a broad field.

The R.C.'s Chairman has been engaged upon Ine H.C.'s Chairman has been engaged upon an extensive series of visits, notably in Asia (autumn 1971: Japan, Hong-Kong, Thailand, Malaysia, Singapore, India, Sri Lanka, etc.); in Latin America (November 1972: Venezuela); Lebanon (spring 1973); and he will be again going over to Asia (fall 1973). It is hoped that it will be possible to set up a regional sub-committee for East Asia (Tokyo), another regional sub-committee for another regional sub-committee for South-Asia (Delhi), a third sub-committee for the Middle East (Beyrouth), as well as other sub-committees in Latin America and sub-Saharan Africa, later on. The following activities are foreseen:

1. Ad hoc scientific meeting, to he held at the « Maison des Sciences de l'Homme » Paris, sometime between July 16-22 1973, with our colleague in Paris then, particularly as from the XXIXth Congress of Orientalists This will be an open meeting to consider plans, perspectives and problems.

2. Joint scientific conference with the Research Unit « Urbanisation and Urban problems in the Growing Nations » of the Institute of Developing Economies - Tokyo, mid-October 1973, parallel with the Tokyo symposium on « Sociology and Social Development in Asia ». Dr. Hayashi, our Vice-President, will be in charge of this meeting and will help us define its scientific contents.

3. Joint scientific conference in India, with the Centre for the Study of Developing Societies (Professor Rajni Kothari) and the Indian Statistical Institute (Professor Ramkrishna Mukherjee) in Delhi, late October 1973. Our Indian colleagues will be in charge of the final program of this meeting.

4. Joint symposium with the Centre Québécois des Relations Internationales (Québec) on: « Hegemony and independence in Contemporary Societies » (provisional title), end November 1973. Arrangements are now proceeding between the Bureau and members of our R.C. in Canada, jointly with Professor Paul Painchaud, Director of the C.Q.R.I.

5. Joint Symposium with the Institut des Sciences Sociales », Université Libanaise-Beyrouth, on: « National Culture and Social Transformaton », mid-December 1973. We will hope to be able to take a final decision by September.

6. Joint Symposium with Karl-Marx Universität Leipzig, on the « Radicalization of National Movements », spring/summer 1974. This symposium has been postponed owing to the fact that the Leipzig University is now moving to new premises. PUBLICATIONS

ACTIVITIES 1972-1973:

The provisional board appointed in Varna hold several informal partial meetings until it could meet formally in a plenary session in Berlin Sept. 72. It was then decided to conduct regular elections by mail ballot, the provisional board acting as nominating committee. Although lengthy, the procedure could be managed satisfactorily. The new board however has not been able to meet. The provisional board had decided to conserver two small international co-sponsor two small international workshops in 1973.

It holds an annual conference in Brac, Yugoslavia, and it has just published

"Yugoslav Opinion Leaders ». STUDENTS & INTELLECTUALS IN POLITICS: S. M. Lipset, William James Hall, Harvard University, Cambridge, Mass., USA. After several years of stimulating work on students in politics, the emphasis in this group is now turning to the more general role of intellectuals in post-industrial societies. BREAKDOWN & CONSOLIDATION OF REGIMES: Juan Linz, Sociology Department, Yale University, New Haven, Conn. 06520, USA. The rise and fall of regimes has been a marked characteristic of 20th century politics in industrial and pre-industrial nations. At origin, a new regime may either head toward consolidation or breakdown: this group is concerned with the dynamic influences upon changes in regimes. Juan Linz has a background paper on this subject, initially prepared for a session he organised, covering Latin-American as well as European regimes, at the 1970 ISA Congress.

1. Our mode of activity

The committee holds occasional meetings in Bucharest in 1972, in Budapest this summer. These formal meetings help to sustain informal exchange between members of the group, through vists and the circulation of papers. We think the most important contribution of the Committee is in promoting a community interest: an informal network of scholars who keep each other informed through post and personal contact, react to each others work, and think of themselves as a group.

Our principle interests 2

- i) The trends in the distribution of resources over time. We are interested, not only in economic resources, but the distribution of political influence, participation of opportunities for social mobility, and of status and respect.
- ii) The influences on these trends, especially the influence of policies We are likely, however, to turn more and more to structural reasons for persisting patterns of distribution and the weakness of redistributive interventions.
- iii) The analysis of effective policies. We want to integrate theory with practice, and relate our concerns to contemporary action, drawing on the experience of people involved in national and community action.
- iv) The goals of policy: how can egalitarian ideals be specified, defended, rationalised, and reconciled with other aims of government? 3. Some dilemmas

It may be useful to share some of the dilemmas we have come to recognise.

- i) How to keep our meetings small and How to keep our meetings small and intimate enough to promote discussion and continuing relationships, without being exclusive: how can we bring in new members, without breaking the continuity of our discussions, or making the group too large?
- ii) How to relate the concerns of sociologists from socialist and capitalist countries, who work within different governmental framework?
- Brown and a manework in the concerns of researchers from less developed countries? So far we have mostly been concerned with Europe and North America. Should there perhaps be a separate Committee for the Third World?
- iv) How far should we use the committee's meetings to develop systematic, comparative work, rather than a looser exchange of ideas? Some members would probably like to see a more structural approach than we have so far adopted.
- v) Similarly, there is a difference of emphasis within the group between those who would like to concentrate on the methodological issues of international comparative studies, and those who are more interested in broader questions of policy and analysis.

vi) Finally, some of us are more interested in policy, others in structural trends.
 Some of these are probably familiar

to other committees.

Our next meeting will be in Budapest in June, where we shall be partly concerned with planning for the 1974 meeting 4. of the I.S.A. then we shall have a plenary session and working meetings.

ACTIVITIES 1972-1973:

The Research Committee has continued to compile information on the current interests and recent publications of members of the Committee and have reported these to the membership in newsletters No. 2 and No. 3, sent out in the spring and late fall of 1972. It can be said that the primary activity of the Research Committee to date has been the exchange of information. The Conference was chaired by professor Walter Hirsch (USA). There were 32 members present, representing 13 countries. 30 papers were read in 7 sessions. Also present were professors J. Ochavkov and A. Abdel-

Malek as observers for the I.S.A. Professor Ochavkov as Vice-President of the I.S.A. delivered the opening address in which he stressed, among other points, the importance of this Conference for the I.S.A. as a whole, with an eye to the main theme of the coming World Congress in Toronto: Scientific and Technological Revolution. Scientific and Technological Revolution. The main themes of the conference were: Macro Theories of Science; Institutional Developments in Science; Studies of Scientific Communities; Meta - Physics and The Study of Science: Criticism of the Positivistic Conception of Science; The Science of Science; Studies of Research Areas; and Science in Society. The papers presented at the conference expressed among others the predict to tal expressed among others the needs: to take scientific change as sociologically problematic and to concentrate on the interaction between social and cognitive structures, involving both a detailed understanding of the subject matter of each science and a historical perspective; to move towards a comparative historical sociology of science, that is to study the basic assumptions and perspectives of different sciences in different cultures at different situation taking into account their work situation taking into account their modes of work and their products. A selection of the papers presented at the London conference will be published by Routledge and Kegan Paul in a volume entitled. Social Processes of Scientific Development, edited by Richard D. Whitley in the fall of 1973. During the conference a Business Meeting was held under the chairmanship of professor Adam Podgorecki, associate member of the Executive Committee of the I.S.A., in which administrative matters and future plans were discussed. Among other things it was decided to hold a meeting in Warsaw in April 1973 to prepare for the Toronto Congress. II was also decided to prepare and circulate a Newsletter, Mr. R. D. Whitley of the University of Manchester (U. K.) took The meeting in Warsaw was held on April 10th to 13th 1973. The Committee in 1972 held its general and business meetings in connection with the Olympic Games in Munich. In a public session the problem of « Sport and Conflict » was discussed with Profs. The Canada Council agreed to fund the central operation for a comparative research project, on « Sport and Leisure Role Socialisation ». The fieldwork of the project under the directorship of Gerald S. Kenyon (U. of Waterloo) will be conducted in 1973/4 in 10 countries around the world. The Polish Ministry of Sport and Touristics agreed to continue the support of the International Review of Sport Sociology. In the meantime additional support from the Belgian Government and the Federal Institute for Sport Science in West Germany enables the Committee to publish the journal from 1973 on as a quarterly. Editor-in-Chief is Andrzej Wohl (Warsaw). The Review will be run as a refereed journal. The membership of the Committee stood finally at about 140, when the new administration of the membership through ISA became effective.

At this time no firm evaluation of the present membership can be made.

Difficulties do arise over the problem of paying fees in convertible money; this is particularly true for individual members. For 1973 the Committee plans an international symposium on « The Sociology of Children's Games », to be held in Bucarest from August 20-25, 1973.
