*Furthermore, I have been working in close contact with the session organisers to produce a provisional programme for the Second ISA Forum, which will act as a bridge between the two World Congresses. The full schedule and list of participants have been drawn up and sent this very day to meet the required deadline. You will find below a copy of what is building up to be a very promising event indeed.*

*I would also like to say a few words about the elections and the replacement of the three board members who unfortunately left us in the past two years.*

## Statutes Revision and Elections

The RCC Subcommittee on Statutes Revision has sent guidelines for updating the existing statutory framework. Our current RC 20 statutes were established under the presidency of Mattei Dogan and have been amended at the occasion of the 2002 Brisbane World Congress. In conformity with ISA recommendations, we have expanded some sections and added a number of articles covering various areas of the RC's functioning that had not been provided for. You should find a copy of the new draft in the next newsletter (June 2012) once it has received approval from the Subcommittee. You will have a couple of months to go over the new statutes and possibly suggest modifications before final ratification in Argentina (August 2012).

One of the wishes expressed by ISA is to harmonise the practices and calendars of the various RCs. An important aspect of this is that elections should now coincide with World Congresses. Knowing that our last elections were organised four years ago, the board has decided to exceptionally extend current mandates until the 2014 Yokohama Congress in order to meet with the new organisational cycle.

As you know, there are three vacant positions. As it is customary for the editor-in-chief of *Comparative Sociology* to sit on the board of RC 20, I have asked Professor David Weakliem (University of Connecticut) to replace the late David Sciulli. Professor Weakliem has kindly accepted. The two remaining positions may be filled in an interim capacity until the next elections, should the need arise.

**In memory of Henry Teune**

Henry J. Teune (1936-2011) has been a longstanding and influential figure in the fields of comparative analysis, local politics and the dynamics of democracy. He has contributed a number of major publications throughout his distinguished career, including *The Logic of Comparative Social Inquiry* (with Adam Przeworski - 1970), *Values and the Active Community* (with Philip Jacob – 1971), *The Developmental Logic of Social Systems* (with Zdravko Mlinar – 1978), *Growth* (1988), *Democracy and Local Governance: Ten Empirical Studies* (with Betty Jacob & Krzysztof Ostrowski – 1993), *Local Governance Around the World* (1995).

His intellectual legacy must also be measured by the impact he has had on the study of these themes both as a professor of political science and project director during his 50-year tenure at the University of Pennsylvania (notably through the *Organizational Dynamics* and *Democracy and Local Governance* research programs), as an active and prominent member of a number of international associations (the *International Studies Association* – of which he was President in 1981-1982; the *International Sociological Association* – of which he had been a member of the Executive Committee and was still the Vice-President of our RC; the *International Political Science Association* – of which he was President of the RC on the Politics of Local-Global Relations), as an editorial board-member of *Comparative Political Studies* and of the *Journal of Theoretical Politics* and as an international scholar with strong academic ties to Holland, the ex-Yugoslavia, Japan and France.

Personally, I will remember him as a tireless academic globetrotter – whichever conference or congress I may have been attending, I would always find him there. With his deep and extensive knowledge of the field, Henry felt that new generations of scholars (myself included) overlooked – and sometimes unwittingly rediscovered – the wisdom of older literature. One of the last times we met was in July 2009 in Santiago de Chile at the IPSA World Congress. After months of treatment he was so happy to be back where he belonged, out

there on the academic circuit once again. I will miss our many interesting conversations.
