### From the President

#### Remembering John Rex

John Rex passed away in December 2011. Most of us know his very influential work on race, ethnicity and multiculturalism. With Michael Banton, he was a pioneer in ethnic and racial studies not only in the United Kingdom, but also worldwide. John was a real theoretician critically inspired amongst others by the work of Max Weber.

I first met John when I was a PhD student back in 1988. I visited CRER, the leading research center on ethnicity, race and migration in the UK at the time with scholars like Robin Cohen, John Solomos, John Wrench, Danièle Joly and many others. He was very supportive and we kept regularly in touch for more than 2 decades, meeting many times at conferences or simply for dinner when he was in Brussels.

Besides his wonderful intelligence and theoretical sophistication, John had a great sense of humour. But he was also a complex character, one of a kind. You were with him or against him and he would not accept "double allegiances". My mistake was precisely to do that and work with a scholar he deeply disliked for mysterious reasons. In his view, I had then ceased to be a follower. Even though he never did anything to harm me or to offend me, our relationship had clearly changed.

When I heard he had passed away, I felt very sad and bad. I will always remember a unique personality and a great mind with all his positive and negative sides. May he rest in peace forever.


## MEMBERS' NEW BOOKS

**Anna Amelina, Devrimsel D. Nergiz, Thomas Faist, and Nina Glick Schiller (eds): *Beyond Methodological Nationalism: Research Methodologies for Cross-Border Studies*, Routledge, 2012 ([link to publisher](#))**

Cross-border studies have become attractive for a number of fields, including international migration, studies of material and cultural globalization, and history. While cross-border studies have expanded, the critique on nation-centered research lens has also grown. This book revisits drawbacks of methodological nationalism in theory and methodological strategies. It summarizes research methodologies of the current studies on transnationalization and globalization, such as multi-scalar and transnational approaches, global and multi-sited ethnography, as well as the entangled history approach and the incorporating comparison approach. This collected volume goes beyond rhetorical criticism on methodological nationalism, which is mainly associated with the ignorance and naturalization of national categories. It proffers insights for the systematic implementation of novel research strategies within empirical studies deployed by young and senior scholars. The novelty lies in an interdisciplinary lens ranging from sociology, social anthropology and history.


**Shirley Hsiao-Li Sun, *Population Policy and Reproduction in Singapore: Making Future Citizens*, Routledge, 2011 ([link to publisher](#))**

This book examines the relationship between population policies and individual reproductive decisions in low-fertility contexts. Drawing on personal interviews and focus groups with more than 200 Singaporeans, it demonstrates that the effectiveness of population policy is a function of competing notions of citizenship, and the gap between seemingly neutral policy incentives and their perceived and experienced disparate effects. The need to take individuals' perceptions of state policies seriously gains greater urgency in the context of potential conflict of interest between the state and citizens regarding human reproduction. Should citizenship status confer rights independent of an individual's economic standing? Who is the idealized citizen and idealized by whom? What is the relationship between a particular conceptualization of citizenship and the nation-state's challenge of confronting the global order? This book answers these questions and offers a significant contribution to the literature on population studies, sociology of reproduction, citizenship and development, public and social policy, East Asian and Southeast Asian studies.



**Caroline Plüss and Kwok-bun Chan (eds.), *Living Intersections: Transnational Migrant Identifications in Asia*, Springer, 2012 ([link to publisher](#))**

This book presents ground-breaking theoretical, and empirical knowledge to produce a fine-grained and encompassing understanding of the costs and benefits that different groups of Asian migrants, moving between different countries in Asia and in the West, experience. The contributors—all specialist scholars in anthropology, geography, history, political science, social psychology, and sociology—present new approaches to intersectionality analysis, focusing on the migrants' performance of their identities as the core indicator to unravel the mutual constitutivity of cultural, social, political, and economic characteristics rooted in different places, which characterizes transnational lifestyles. The book answers one key question: What happens to people, communities, and societies under globalization, which is, among others, characterized by increasing cultural disidentification?

Longtemps associées au développement industriel des pays développés, les migrations humaines ont changé de visages au cours des trois dernières décennies. Tout d'abord les déplacements de population, subis ou désirés par les migrants, ne se font plus seulement dans le sens Sud-Nord, mais aussi Est-Ouest et Sud-Sud. Ils se sont mondialisés. Ensuite, l'allongement de la durée de la vie et le vieillissement démographique des pays développés entraînent un flux migratoire nouveau dont les impacts économiques et sociaux sont de plus en plus forts dans les pays d'origine des migrants. Ce numéro, coordonné par Catherine Wihtol de Wenden (CNRS-CERI), avec la collaboration de Martine Dorange (FNG), propose une double approche de ce phénomène. Dans une première partie, il analyse le « dévieillissement » des populations européennes et les défis auxquels l'allongement de la durée de la vie les confronte. Si le système migratoire du care répond aux besoins immédiats des personnes âgées, de leurs familles et des institutions spécialisées, il pose de manière renouvelée la question de la confrontation des « blancs » dépendants aux personnes immigrées dans la prise en charge et le soin. Ainsi que celle de leur intégration temporaire ou durable dans les pays d'accueil. Une seconde partie porte le regard sur les difficultés rencontrées par les immigrés venus en France au cours des Trente Glorieuses. Aujourd'hui âgés ou très âgés, ces hommes et ces femmes sont pris dans une oscillation souvent faite d'arrachements entre deux cultures. Comment ces personnes, leurs enfants mais aussi les professionnels qui les accompagnent composent-ils avec la réalité d'un double enracinement ? Chercheurs et acteurs de terrain apportent des réponses dont on voit les échos se prolonger jusque dans la vie de leurs enfants et petits-enfants. Des échos qui viennent interroger le poids du passé dans le vivre ensemble d'aujourd'hui, les expériences de la diversité et l'articulation possible, ou non, des choix personnels et des choix collectifs. Enfin, une dernière partie détrompe le fantasme du « vivre au sud » des retraités aisés des pays développés.




**Miloslav Bahna**, *Migration from Slovakia after Accession to the European Union (Migrácia zo Slovenska po vstupe do Európskej únie)*, VEDA Publishing House of the Slovak Academy of Sciences, 2011 (in Slovak with English summary; [link to publisher](#))

The book focuses on migration from Slovakia before and after its accession to the European Union in 2004. In the theoretical part a conceptualization of middle range migration theories within the systems theory of Niklas Luhmann is presented. The rich analytical work with many unanalysed data on migration from Slovakia and other new EU countries poses the question of whether the observed migration flows can be explained by theories of international migration.

The book offers answers to the following questions:


- How reliable are data used to describe the extent of migration from Slovakia?
- Can post 2004 migration from Slovakia and other new EU members to the UK and Ireland be explained by their income levels?
- Does regional income level have an influence on individual migration decision making?
- How does Slovak migration to the UK differ from migration to the Czech republic?
- Compared to other European countries, is there too much or too little internal migration in Slovakia?



Dylan Sutherland and **Jennifer YJ Hsu**, *HIV/AIDS in China - The Economic and Social Determinants*, Routledge, 2012 ([link to publisher](#))

South and East Asia may well become the epicentres of the global HIV/AIDS pandemic. More than three-quarters of a million people are now estimated to be living with HIV/AIDS in China. In 2009, AIDS had already become the leading cause of death by infectious disease. Yet, even despite China's recent economic and social progress, a number of development issues - not least the emergence of glaring inequalities - have also emerged. The expansion of the HIV/AIDS epidemic is also an important longer term development challenge.

This book analyses China's HIV/AIDS epidemic, with particular attention to the nature and impact of current economic and social changes and how these changes may be driving the epidemic. It examines aspects of income and gender inequality; rural-urban migration; commercial sex work; healthcare and civil society organizations. Health care reforms and the role of NGOs are also considered as well as general government policy. Overall, this book provides a full discussion of the most critical aspects of the current HIV/AIDS situation in China and its impact on Chinese society.



**Micheline Labelle, Jocelyne Couture and Frank W. Remiggi, *La Communauté Politique En Question: Regards croisés sur l'immigration, la citoyenneté, la diversité et le pouvoir*, Presses de l'Université du Québec, 2012 ([link to publisher](#))**

Avec l'accélération de la mondialisation, une opinion qui aurait, jusqu'il y a peu, été taxée d'incongruité semble avoir gagné le statut d'évidence : le système étatique mondial serait menacé et appellera à une profonde redéfinition des attributs, des structures et du rôle traditionnellement dévolus aux États. Malgré un échiquier géopolitique modifié, où les frontières s'évanouissent et où les cultures et les traditions nationales s'amalgament jusqu'à l'extinction, il faut cependant reconnaître que la mondialisation n'est pas (encore) venue à bout des États, des sociétés qui les composent et des divers problèmes que pose la cohabitation au sein de leurs institutions traditionnelles. Bien au contraire, la mondialisation a souvent contribué à enclencher en série des situations qui se répercutent sur les plans social et étatique. Dans toutes ces situations, c'est aux États, à leur gouvernement et à la société toute entière qu'il appartient de restaurer, voire de réinventer la trame des communautés politiques. Non pas en érigeant des barrages à la mondialisation, mais en contribuant à la création des institutions d'une gouvernance globale juste et efficace.



Rassemblant des collaborateurs de l'Europe, du Québec, du Canada anglais et des États-Unis, ce livre questionne, sous des angles différents, la pertinence théorique de la notion de communauté politique lorsqu'il s'agit de penser le pluralisme résultant de l'immigration internationale. Il pose aussi un regard critique sur le rôle que cette notion joue dans les approches courantes des phénomènes liés à la diversité. Car plusieurs questions se posent maintenant, dont celle, au premier chef, de la capacité des appareils d'États contemporains de cimenter des communautés politiques dans un contexte de mobilité spatiale accrue et de transnationalisme croissant.

It sounds like Wikipedia, but in fact there are important differences – mainly, it is not a “wiki” in the sense that anyone can make edits to the content – instead it is a peer-reviewed publications vehicle sponsored by ISA (launched at the World Congress in Gothenburg) with rapid turnaround/publication. The only real similarity to Wikipedia is that entries (consisting of review articles) will be regularly updated so that they do not become “dated” in the way a regular publication might.

The editors are specifically inviting articles on international migration; in a message received in November, the publisher (Sage) was also offering \$250 on acceptance of an article (you might want to verify that this offer still stands). **Alicia Girón** is conducting a research project entitled “**Entrepreneurial Experiences Beyond The Border: Capital Return For Development**” with colleagues Eugenia Correa, Ma. Luisa González Marín, Patricia Rodríguez. Alejandra Arroyo. An interdisciplinary group of researchers from the Economics Research Institute from the UNAM and the UAM- Iztapalapa are realizing a study on the entrepreneurial capacities and experience of Mexican migrants in Chicago, Houston and Los Angeles. This institutional project is financed and fostered by the National Council of Science and Technology (CONACYT, for its name is Spanish) aimed at analyzing the options for entrepreneurial development in their communities and regions of origin, as well as to know of financial services demand associated to investment-savings projects, and obstacles they face to realize them. It is also studied the environment to insert themselves into savings and investment processes to increase trans-border potential of their enterprises towards their regions of origin (remittances).
