RC46 is involved in organizing 20 sessions; two of which are joint sessions hosted by RC42 (Social Psychology). 

NEWS FROM CLINICAL SOCIOLOGISTS AROUND THE WORLD

Massimo Corsale (Naples, Italy) has just published (2017) *Perdersi o ritrovarsi? Navigare (serenamente) nella nostra angoscia quotidiana (Losing or Finding Yourself? Surviving (Serenely) our Daily Anxiety.* The publisher is Oedipus and the places of publication are Salerno/Milano. Massimo describes the book in the following way:

Anguish/anxiety is the topic we are dealing with here. I do not refer to a kind of strong pain affecting people at some definite time, but just to an uneasy feeling coming at any time from some danger that we do not know exactly whether or when it will occur. Starting from Kierkegaard (who was the first to note the concept), anguish is defined as a sort of 'giddiness' coming from the number of different possibilities among which we have to choose at any time, though remaining in some darkness about what should follow from each one of them. From such a point of view, anguish should be felt by everybody across all different ages in the history. But up to the middle of XXth century, people referred to basic ideas (such as fate, will of God, advancement of sciences, Enlightenment, revolution, socialism, economic development and welfare) in order to hold in check such anger. But in our present society (post- or hyper-modern, post-industrial, post-ideological, globalized and secularized), we cannot any longer rely upon any one of these ideas. How can we hold anguish in check in our everyday life? In the last chapter, some escapes are discussed, including the role of religion in a secularized society. We should bear in mind the breaking down of the most traditional social bodies - social class and status, political parties and trade-unions, neighborhood and village, as well as familial clan. Each one of us must take our own responsibility in building our personal but also the collective future. We can go on saying that private matters are influenced by social and political phenomena (macro upon micro), but we must also underline the role of private behavior (micro) in building macro-phenomena.

Marina Kevkhishvilli (Tbilisi State University, Georgia) finished all the Ministry of Education's training requirements to be able to train teachers. She recently trained 70 teachers in Communicative Language Learning.

Gianluca Piscitelli (Rome, Italy) works for the Italian government and for an association called "Metaconfini" as a Gestalt and Sociological Counsellor. Gianluca also is the editorial director of "Quaderni di Sociologia Clinica," the only Italian scientific editorial series specializing in Clinical and Applied Sociology.
