Conference Scope and Aim

The promise of globalization and Internet based technologies has always been the shrinking of the world into an interconnected global village. However, the achievement of this promise is dodged by an ever-expanding asymmetrical access to resources between regions, races and genders. Moreover, current political and socio-economic systems are deeply rooted in historical discourses of rejection and discrimination of the 'other' and the hoarding of resources for 'self'. Therefore, the institutionalized inequalities created by hegemonic colonial architecture in previous centuries are still

alive and well in the present. These have evolved into normative neocolonial systems that clearly do not serve the interests of the majority in the touted global village. Indeed, the COVID-19 pandemic has revealed just how easy it is to spread disease, conspiracy theories and misinformation globally, and, yet, how painfully slow it is to distribute life-saving technologies, cures and vaccines even when they are in surplus supply to some. This suggests that the term ‘global village’ is a misnomer.

At this crossroad between the promise of globalization and the threat posed to societies by the current model of globalization, this conference aims to foster multidisciplinary scholarly discourse by accepting submissions that **look at language** to reveal historical and modern asymmetries in society. It is hoped that the conference will be an opportunity for linguists, sociologists, historians, political scientists, anthropologists and other social scientists to reflect on the opportunities and threats that globalization, free market, migration and the Internet present to social institutions, and, by extension, to the identities of individuals and societies.

Subthemes

- a) Language and knowledge systems – traditional and modern (e.g. religion, medicine etc.)
- b) Language and the law
- c) Language and the new media
- d) Language and power
- e) Languages in contact
- f) Language and transnationalism
- g) Language and identity
- h) Language planning and policy
- i) Language and health issues (e.g. the COVID-19 pandemic)
- j) Language and gender
- k) Language and neocolonial realities
- l) Language and conflict

English is the official communication language for the conference. However, the conference will welcome presentations in Kiswahili on the above subthemes.

Submission process

We invite paper proposals that are tied to any of the aforementioned broad subthemes. The proposals should include the title of presentation and a short 250-300 words abstract, accompanied by 4-5 keywords. The submission should be made online at the following page:

Practical information

- a) Kenyatta University is located in Nairobi, Kenya, along Thika Road. The University is about 40 kilometers from Jomo Kenyatta International Airport and 20 kilometers from the Nairobi CBD.
- b) Taxi hailing apps such as Uber, Taxify, Bolt and others offer competitive and safe travel options. International participants are discouraged from using private taxis.
- c) The Kenyan shilling (KES) can be bought using any of the world major currencies at forex bureaus at the airport and border points. Major hotels accept card payments.
- d) Limited affordable accommodation (at own cost) is available at the University. Details on the reservation process will be shared as we get nearer the conference. In addition, there are many hotels within short distances from Kenyatta University. A comprehensive list will be made available after the abstract review process.
- e) Citizens from the East African Community, and several other countries, do not need visa to enter Kenya. Please visit <https://evisa.go.ke/evisa.html> to find out if you need a visa, the type of visa you need and how to make an online application.
