## Observing and Analyzing Community Change

### Urban Labs: Knowledge Hubs to Co-Produce Knowledge about Community Policies and Change

From a policy point of view, community and urban issues are conceived as complex problems because they cross different policy issues and sectors. Therefore, the integrated policy strategy across sectors combining their conceptions about problems and policy tools to solve them, as well as the institutional and non-institutional actors that are usually involved in their sectoral policy communities and networks, are conceived as an adequate approach to cope with the community and urban problems. This is a central topic in the raining meta-policy frame about local development promoted, for instance, by the United Nations through its *New Urban Agenda* or the urban dimension of the European Union cohesion policy. Besides, another central aspect of this new meta-policy frame for local development and community change involves providing policy evidence on the design, implementation and results of the integrated strategy in community policies and initiatives.

In this respect, the so-called *Urban Labs* appear as a potential tool to provide new analytical insights and policy evidence about initiatives aimed at coping with the complexity of community problems. These Labs support the collective work between involved or concerned actors with community issues and policies from different sectors. Therefore, Urban Labs mean the participation of institutional and noninstitutional actors (public administration, civic associations, business actors, research centres...) to study policies and their effects on communities.

An example is the **URBAN DUSI Lab** promoted by the **Jean Monnet Chair in European Urban Policies (EUrPol)** and the **Andalusian Federation of Muni-**

**icipalities and Provinces (FAMP)** in Spain to study the Integrated Urban Initiatives promoted by the EU Cohesion Policy. Since 2020 this Lab has developed a collaborative process to foster mutual learning among researchers and staff in charge of specific initiatives implemented in different municipalities under the support of this European Union policy.

The Urban Lab tries to combine the 'academic knowledge' provided by the comparative research about the design, implementation, and impact evaluation of EU-integrated strategies with the 'world of practice', the knowledge of staff in charge of these initiatives at the local level. The main idea is to co-produce analytical knowledge and practical tools to improve the design, implementation and impact of policies aimed to promote community change at different geographical scales and different types of socio-spatial contexts (for instance, rural communities, urban neighbourhoods, or functional urban areas, ...). Therefore, researchers have not developed an external consultancy work to design and evaluate initiatives promoted by municipalities. During workshops – held online due to the COVID-19 pandemic – researchers and staff have co-produced ideas and instruments to analyse and improve the design, implementation and impacts of urban policies that apply the policy integration strategy.

In each workshop, ideas and instruments have been presented and discussed; and then applied and validated in each specific project. The EUrPol team has delivered and proposed some ideas, tools, and examples based on comparative research projects that have been discussed and improved to define some analytical ideas and tools. Then, these ideas and tools were applied to each project by their respective staff with the help of the EUrPol research team. They were then discussed, validated and improved together, summing up 'academic' and 'practical' knowledge.

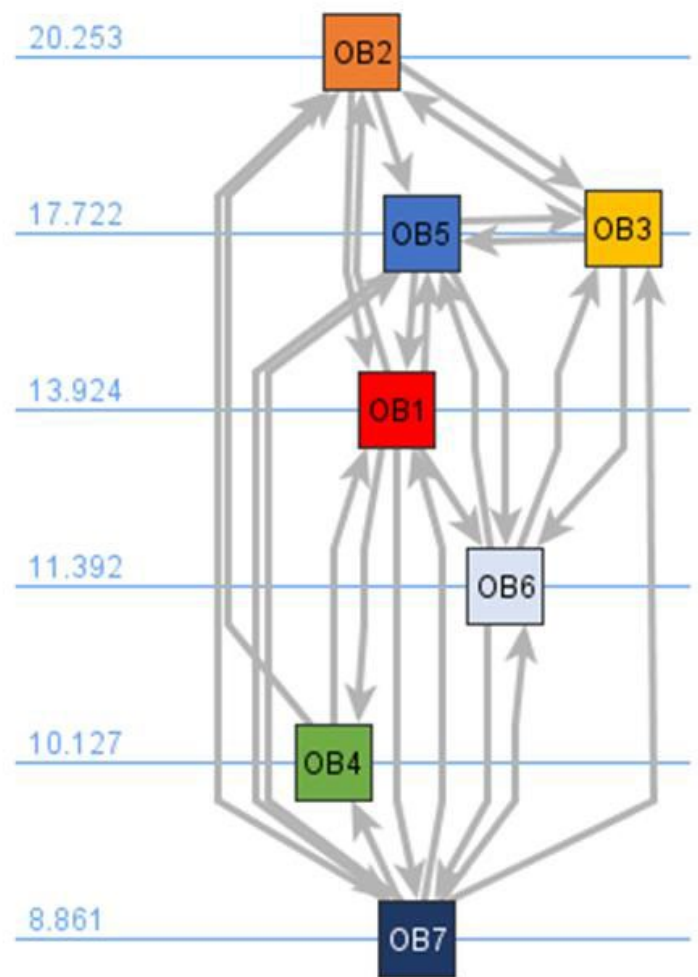

## Urban Labs (Continued)

The ideas and instruments discussed represent some of the aspects integrated into the comparative urban policy portfolio analysis (CUPPA) developed by the Centre for Sociology and Local Policies-The Urban Governance Lab (Pablo de Olavide University). This perspective is developed in line with the analytical proposal of urban policies as multi-level policy mixes applied to analyse the added value of integrated urban strategies promoted by the EU within the framework of EUPol, as an example of this type of territorial policies promoted by supra-municipal agencies and applied at the local level. However, they can also be used by agents involved in designing, implementing, and evaluating specific local strategies or those responsible for the policies in which they are developed.

One of the leading Urban DUSI Lab goals has been to improve analytical ideas and tools regarding the integrated strategy in local policies. Therefore, this integrated strategy has been thought of not as a rhetorical instrument to show some alignment as regards proposals made by international organisations, but as a research issue of knowing whether it is actually applied and what its difficulties, advantages, and results may be. It considers questions such as, is this project a proposal for sustainable, local development? Also, in addition to including a plurality of objectives, actions, and stakeholders, is the integrated strategy being applied from design to evaluation? Does this strategy produce the expected effects? Does it create added value in local policies and citizens' quality of life?

The Urban DUSI Lab has worked on tools to study the quality of integrated strategies design, the analysis of implementation networks or theory-driven evaluation to try to avoid the common attribution gap in impact evaluation. The ideas and instruments discussed can be applied at the corresponding points of the public policy cycle (policy planning, implementation and evaluation), as well as planning tools from the very beginning of the project (as pointed out by the staff of the participant projects during the workshops held). The quality of the policy design can be analysed after planning is complete,

either by municipal technicians or by an external agent, or the proposed instrument can be used at the same time the project is being planned to monitor the planning itself and its outcome. Implementation networks can be used to see if the project is being developed as intended and planned, to see the potential consequences of something not being done as intended, and also to ascertain the complexity of the strategy designed and how it is genuinely integrated or the extent to which it should be, both as a whole and for processes or objectives. Some of the evaluative models reviewed in workshops can be used to analyse impacts at the end of implementation and to examine the possible effects of what is being planned to choose between different options.

## ISA XX World Congress of Sociology

The RC03 has organised 14 sessions in the World Congress of Sociology. Around a total of 90 presentations (an average of 6 for each session), although some sessions have concreted more proposals (for instance, Community Influences in Lifestyles and Health, Comunidades Resilientes or Uses and Misuses of Arts and Culture in Community and Urban Development). The final number of presentations will be known after the registration deadline on March 22th.

The format of sessions will be decided after final registration in March 2023. Nevertheless, the schedule for sessions is already done, as you can see in the following link:
