

# **Priorities if elected President**

- From the pandemic to climate change, from rising authoritarianism and populism to global inequalities, sociology has a major role to play in improving our understanding of global challenges and contributing to concrete solutions. The ISA is our best tool to fulfil this mission by learning from sociologists from all continents. My guidelines to maintain and strengthen our association will be the following ones.
- 1. The crucial challenge of the next president will be to ensure the continuity and efficient functioning of our association after the retirement of our Executive Secretary. Izabela Barlinska has played a crucial role for almost four decades and built the association as we know it. As ISA Vice-President and former RC president, I have intimately engaged with most activities of the ISA, including preparing and presiding over the 2021 Forum, hosting an EC meeting, and taking part in the conference of national associations and a PhD Lab. I have assumed an active role in the Executive Committee and the committee that selected the new Executive Secretary.
- 2. I believe in collective decision-making. As VP for Research, I initiated the Research Council's regular online meetings, during which 50 to 80 RC presidents and delegates discuss the main issues in the ISA, make proposals and share good practices. They have demonstrated how insightful collaborative processes may be in the ISA. Thematic groups, such as the task forces on "equality, diversity, and inclusion" and the RC social media managers, will provide new ideas and concrete support.
- **3.** Similar online meetings will be organized with National Associations to discuss the ISA agenda and share good practices. Twenty panels will be allocated to NAs in our Forum and Congress. I will incentivize new collaborations between NAs and RCs.
- **4.** I would like to better connect ISA journals with the RCs, NAs and ISA congresses.
- **5.** My main project will be to set up a new platform to publish articles on a widely read

website and in national newspapers. It will make sociology accessible to a broader audience of citizens and policymakers and complement *Global Dialogue*, which primarily addresses sociologists. This project will build on the experience of the public sociology platform "openMovements", which I founded with Breno Bringel. In 5 years, we published over 300 articles by sociologists from all continents.

- **6.** Strengthening the ISA as the representative of the global community of sociologists:
- We must actively include sociologists from the Global South and ensure a gender balance in our projects.
- Creative social media (for the ISA, RCs, NAs & journals) and the new publication platform will make sociology and ISA more visible in public debates.
- Increasing our membership is crucial to being a legitimate representative of sociologists. In a time of multiple crises, decreasing ISA membership and forum registration fees is imperative.
- Being the voice of the community of sociologists requires an active human rights committee and concrete support for sociologists who are victims of repressive regimes.

# **Priorities if elected President**

I am a political sociologist trained in sociology and political science in Brazil, Chile, and the US. My academic career has been dedicated to the investigation of social and political structures, institutions, and behavior. In the last decade I have been intensively involved in international scientific cooperation on science policy and issues of social progress and equality.

I teach at the Federal University of Rio de Janeiro, where I chair the Interdisciplinary Research Lab on Inequality (<a href="www.niedifcs.net">www.niedifcs.net</a>). As visiting professor, I taught at UCSD, Columbia, MIT, and LMU Munich, collaborated with Brazilian and foreign colleagues on theoretical and empirical work, and published extensively in Brazil and elsewhere.

Long involved in ISA activities, I integrated the Program Committee of the 2020 World Congress, and the Executive Committee (2006-

10), chaired RCs 16 (2002-06) and 07 (2014-18), was board member of several RCs, and presently of RC56.

As member of the Brazilian Academy of Sciences, and of the World Academy for the Development of Science in the Developing World (TWAS), I have integrated several international committees and task forces. I should also mention my involvement in the International Panel on Social **Progress** (www.ipsp.org), which united over 300 social scientists from all continents to assess positive and negative societal developments in recent history, aiming to contribute to a better future (Rethinking Society for the 21st Century, Report of the IPSP, Cambridge: CUP, 2018, 3 vs). As part of the steering committee of the Panel and co-author of the Report, I could engage in close dialogues about challenges and aspirations of colleagues from around the world.

Although our Association has in many ways significantly demonstrated the actual relevance of social diversity and honored its ethical value, the records show that only two women, and three sociologists from the Global South have occupied ISA's presidency to this day. If elected, I will use my experience in science policy, and my firm commitment to diversity and plurality pursuing the following priority objectives:

- To strengthen the Council of National Associations taking into account the different traditions of national sociologies.
- To stimulate the dialogue between ISA's RCs, WGs, and TGs with pertinent programs of other international science organizations.
- To strengthen the ties between sociological associations and research groups in the Global South, without neglecting that sociology, as all sciences, must aim at a global knowledge production whose ultimate value is the public good.
- To search for the concrete engagement of young sociologists in our diverse activities.
- To seek ways to assist sociologists in exile.
- To promote the dialogue with other social, natural, and health sciences aiming to maximize knowledge resources to address ongoing existential risks.

Hoping to be chosen by our community members, I look forward to work with you doing theory, research, exerting criticism, or providing evidence-based knowledge for policy. Sociology is about understanding social life, but also about furthering fundamental values of human society – equality, dignity, justice, and freedom.

# Priorities if elected Vice-President of the Research Council

The 57 research committees (RCs), four working groups (WGs) and six thematic groups (TGs) of the ISA demonstrate that we, as sociologists, constantly confronting are theoretical and empirical domains in a quest to advance how societies and societal dynamics are understood. I have great respect for the work of the ISA Research Committees and their active collaborations thematic scientific societies national/regional sociological associations. My core priority for the 2023-2027 mandate of the ISA Executive Committee is thus to build on the current dynamic of the Research Council, in order to strengthen the exchanges among RC/WG/TGs and between them and the ISA Executive Committee (EC) and Secretariat. I also seek to support them to increase interaction with sister societies around the world. I thus commit to working towards the following results during my mandate.

 A strong collective voice of the Research Council in ISA governance. Under the leadership of Geoffrey Pleyers, the Research Council has consolidated a collective voice in ISA governance. I will further foster this dynamic by holding quarterly meetings of the representatives of the RCs that are elected to serve on the EC (i.e., the RCC) and I will maintain bi-annual meetings with the entire Research Council so to prepare for EC meetings and reinforce our accountability to our members.

 Consequential cross-RC/WG/TG collaborations through voluntary initiatives.

The Research Council has begun a number of voluntary initiatives to explore emerging issues within the ISA. RC/WG/TG presidents have proposed numerous transversal topics that are of interest to many RC/WG/TG s and I plan to ensure that the RCC is active in working with the leadership of RC/WG/TGs SO to offer more opportunities within ISA for crossfertilization of ideas and initiatives that emerge from within the RC/WG/TGs and their external networks.

- Recognition and communication for RC journals and activities. As a current member of ISA's Publications Committee and as the Chief Editor of a RC-sponsored journal, I am particularly sensitive to the need for recognition of the excellent work of the RCs in developing and maintaining topicspecific journals within Sociology subfields. The work that we initiated on social media management offers a first entry into building the networks between the official ISA journals and the RC journals. I will actively explore, with the ISA Secretariat, more opportunities to render the RC journals more visible in the digital environment so that this aspect of the RCs efforts are recognized.
- A vibrant and participatory Forum with increased B/C country participation.

Following the work that I conducted to co-develop the concept of a Virtual Forum 2.0, I have understood that we must integrate this work into the planning of a Hybrid Forum 2.0 in 2025. One important aspect of this is to ensure that the next ISA Forum be accessible to members from B/C countries. We will pay special

attention to the challenges that the different time zones, knowledge infrastructures and travel needs pose to our mission of diversity and inclusion at the ISA.

# Priorities if elected Vice-President of the Research Council

I would like to promote the following vision and agenda in ISA, 2023-2027:

We maximize input, output, outcomes and impacts of the ISA formations (RCs, TWGs, committees and task forces, etc.) and their activities to the following sociological enterprise:

1. To create opportunities for collaborative research engagements/partnerships between the Global North and Global South researchers through their respective universities and local sociological formations (national associations, research councils, sociological publications).

a. The Asia Pacific Sociological Association (APSA) with ISA RC46 (Clinical Sociology) and ISA RC15 (Sociology of Health) organized APSA 2020, APSA 2021 and APSA 2022 in partnership with Asian universities and national

sociological associations.

- 2. To encourage/support South-to-South Cooperation among ISA research committees, TWGs, NALC, etc. in bridging science-policy-sociological practice nexus through knowledge production and mobilization in several learning and action spaces.

- 3. Most of all, we/ISA must actively promote a culture of unity amidst diversity and conflict, inclusivity amidst widening social inequality by providing support towards resilient and sustainable research communities and practices. We start by supporting our own ISA research committees and task forces in their collaborative endeavors towards increasing the dynamism of their global-local initiatives of knowledge production and mobilization. We
- can develop this culture of collaboration by doing the following integrated set of program activities:
- a. Conduct regular consultation/dialogues / conversations with RCs presidents/officers and delegates;
- b. Increase visibility of RC's programs and activities through social media, in coordination with the ISA social media manager.

# Priorities if elected Vice-President of National Associations

Our world is struggling in 2023 in a deep and serious way, marked by three features: a) an unprecedented level of human confusion and ignorance; b) an alarmingly high level of human suffering (war, dislocation, oppression, inequality, racism, discrimination, and environmental disasters); and c) the global

nature of these problems. Despite all the information available to us, we are witnessing what Jean-Jacques Rousseau famously said, that having more information does not make one more informed. Human suffering calls for our engagement and activism, human confusion our sociological insights, and the global nature of the problems our collective effort. I view the ISA's National Associations as deep repositories of global knowledge; and my role, if elected, as a leader of this global sociological effort for production, dissemination and activating knowledge. My leadership as President of the Canadian Sociological Association and my engagement with Iranian sociology have shown me that the thirst for sociological insights is not limited to the Global South or the Global North. My work as VP-NA, if elected, would be guided by three principles: 1) to promote activism through scholarship, as our unique responsibility in addition to our engaged citizen duties; 2) to encourage the adventure of leaving our intellectual comfort zones in order to learn about peoples, the worlds, and the problems that are different from our own; and 3) to encourage comparative work and global dialogue, with the belief that, as Lipset had once said, "a person who knows only one country basically knows no country well".

My life and career as a sociologist have particularly prepared me to take on the VP-NA role. It has been said that three experiences are particularly conducive to the development of what C. Wright Mills called the 'sociological imagination': witnessing a major social change, going through international migration, and living as a minority. I experienced all three, and each has affected my sociological journey in a special way.

My sociological journey began with two major historical events: the Iranian Revolution in 1979, and the Iran-Iraq war (1980-88). As a teenage political activist, I participated in the Revolution against the dictatorship of the prerevolutionary regime; and then continued with activism against the dictatorship of the postrevolutionary regime. During mv undergraduate sociology studies, Saddam Hussain invaded Iran, and I rushed to the war fronts as a volunteer fighter. After finishing my BA and MA in sociology at University of Tehran, Iran, I moved to Canada for doctoral

studies. As a migrant, I was alerted to the experiences and lives of international migrants, a second trigger for my sociological interests. After the events of September 11, 2001, and the rise of the anti-Muslim sentiments in the West, I experienced my third sociological imagination trigger, living as a minority in the West. All my research projects and publications have hovered around the issues related to these three major experiences. I continue research in both Iran and Canada, and write about them in both English and Persian.

# Priorities if elected Vice-President of National Associations

My vision for this position draws upon experiences in two countries, in one, as a child of refugees, and in another, as a female academic of a marginalized racial group in the US, but with privileges of the Global North. I have devoted years to working respectfully with peers across Africa, Asia, Europe, North, Central, and South Americas to develop scholarship that challenge North-South knowledge hierarchies. Within the US, as the President of SWS, I brought scholars from Africa and Asia as the plenary speakers to our conferences, a first. Within the ISA, working with colleagues on the National Associations (NA) committee under VP Filomin Gutierrez, and the Finance and Membership committee under VP Sawako Shirahase, I learned about ISA rules, good practices, and aspirations, including acting for collective and individual members and doing so in fiscally responsible ways for the long-term health of ISA.

If I am elected, NAs will be the conduit through which we *collectively* keep sociology and the social sciences relevant in the world.

- Keep the NAs and their contributions visible to all members and committees in the ISA, including through website and social media representation. Consistent with ISA horizons, I will continue to act as an advocate, amplify NA visions and causes within all constituencies of the ISA and beyond. NA visibility is an important goal for me.
- Continue to strengthen individual NA and ISA synergies and partnerships.

Each NA is situated with a set of distinctive social-political-historical circumstances, so they are unique in who they are and what they are trying to achieve. Nor are all of the NAs the same in terms of their resources or memberships or their accountability to their groups. But they are equal members within ISA. I will listen to NA representatives, recognize their uniqueness and vision, and ensure each NA member is able to fully access the benefits of ISA's resources, networks, and support. My leadership as the NAs Vice-President will be based on what NA representatives tell me, while balancing unique needs and collective strategies.

- Strengthen collectivities. We are collectively facing some common challenges, because sociology is a discipline that creates and trains people in critical ideas. These challenges are fast paced and powerful. I will do everything I can to foster and sustain NAs collectively, in regional groups and/or groups based on shared concerns, depending on the needs of the NAs, as civil society and professional organizations. NA leaders and ISA can deal with emerging challenges through sharing ideas, strategies, and supporting one another.
- Continue to dismantle knowledge hierarchies in partnerships with the NAs, moving beyond the North-South binary model, transparently and continually. We have many platforms for scholarly output and conversation. I want to lead by strengthening NAs access to these platforms. Our

gatherings - in person and via technological platforms - will act as nuclei to expand NAs efforts to dismantle hierarchies. I seek your support to foster our collective bonds, energy, and commitment to sociology and the social sciences.

# Priorities if elected Vice-President of Publications

The past seven years (2016-23) I have served as editor of *Current Sociology Monographs* and *SAGE Studies in International Sociology Books*. In this capacity, I gained experience of ISA publication system and its many stakeholders. I have learned a lot from my fellow editors of the different publications, from the two ISA Vice-presidents of Publications, Vineeta Sinha and Eloísa Martín, whom I have worked with, as well as from the

presidencies of Margaret Abraham and Sari Hanafi. From these experiences and engagement with members of ISA, I believe I can bring my working capacity to address three priorities:

- First, to maintain the good practices and quality standards achieved in ISA publications. We all know the perverse effects of impact rankings and the hegemonic doctrine of "publish or perish". It is possible to think and look for alternative ways that take us out of the "hamster syndrome".
- Second, imagine and to cooperatively promote a publication system capable of responding to open access and the changes in funding that it represents. The academic publishing industry has a life of its own. It is a marketplace where science and interest compete, but also a place to care for knowledge and to take better care of ourselves. Publications need to be financially sustainable to continue. That is an issue that needs to be addressed globally and locally before it is thrown out from under our feet. Our future is riding on it.
- Third, to enhance and explore the spaces of cooperation produced by digitalization, thus permitting greater access to global and local sociological knowledge and increased linguistic diversity, regardless of income level or country.

Furthermore, I believe that this must be done in close cooperation with the Research Committees and National Associations. We know that there is no one overarching view, nor only a single perspective on the issues. Therefore, it is essential to devise mechanisms for learning, sharing and mutual support, especially at a time like the present, and for envisioning and working toward a better future for our association, the ISA, and for our planet.

If elected, I will devote my time and efforts to working towards these goals and making them a reality. I hope you will support our endeayour.

# Priorities if elected Vice-President of Publications

If elected as VP Publications my three priorities will be:

- to develop a plan to strengthen the links between ISA publications and its research committees and national associations
- to ensure that rapid changes in publishing, technology and information circulation serve the needs of ISA members and are a key benefit of membership
- in overseeing the core business priorities of ISA publications, to ensure the vitality of the ISA and its capacity to serve members and the wider sociological community.

These priorities entail both change as well as a degree of continuity. The latter may not be the most glamorous thing to do but any serious candidate for this role must provide a case more than just sustaining ISA publications but also enhancing them. As someone with more than a decade of experience of editing top level ISA and BSA (British Sociological Association) journals, and current member of the ISA Publications Committee and a Publications Director of the BSA I have unparalleled experience here. The next VP's tasks will include contract negotiations for International Sociology and Current Sociology, our two core and income raising journals, that must provide sufficient resources to the ISA. This is a vital concern and in a current role with the BSA I have just been through a contract negotiation with SAGE, so have inside knowledge of what the process entails.

I will initiate a consultation process with members, RC and NA about the long-term future of all ISA publications. This is one way in which I will aim to strengthen the role of RCs and NAs in ISA publications.

As VP I will ensure that social media for ISA publications continues to progress and adapts to changes in the external environment. I will consult NAs and RCs for new ways to progress the writing workshops aimed at colleagues from the Global South, with a focus on the needs of early career sociologists. This will provide a further way for national associations to be more central in working with publications.

All ISA members will be aware the landscape for publications has been and will continue to change rapidly. Open Access and the mushrooming of online and sometimes predatory journals sit along with information overload that seems to lead to increased silos in sociological research. These are a concern for all sociologists and the ISA needs a strategy to deal with it and to help members to sustain the vitality of sociological research. To this end I propose that the ISA urgently aims to show value to members by delivering on what was the promise of ISA Online - an open and personalised feed of information and resources to every member. There are already apps and websites that do this, some free and some paid for. If we do not provide this service, we may find ourselves overtaken by commercial providers.

# Priorities if elected Vice-President of Publications

I have been editor of *International Sociology* from 2015 to 2022 and therefore engaged with the Publications Committee of the ISA for the last seven years. I have also been President of the European Sociological Association from 2019 to 2021, and involved in the relevant publication matters that large scientific associations like ours face today. This, added to my previous experience in the field of academic publishing leads me to wanting to contribute further to making publications in the ISA grow stronger. During my term as editor, I have been able to improve the outreach of *International* Sociology, by rising significatively the impact factor (from 1.033 to 2.535) while increasing the presence of authors' diversity from all over the world. I would like to continue supporting the improvement in outreach and readership of the journals, so that they really mirror the international membership of the ISA. Along these lines, I will also work to increase

publication opportunities for sociologists at all career stages, both young and senior scholars.

The publications landscape has been changing a great deal in the last years and will be still more in the years to come. A main priority is to prepare ISA publications for these changes, making them complementary and expanding current online platform. I consider crucial to be at the avant-garde of future transformations. I was the first researcher from the social sciences to be at the Board of Directors of ORCID (2014-2016), before it reached the international expansion we know today. My task there helped social science scholars worldwide to get an ORCID ID, engage with new ways of disseminating our knowledge and to avoid becoming "the forgotten member" of the "Science family". I plan to bring this experience to ISA publications.

We have in the ISA diverse and distinguished publications. On the one hand, two very well positioned scientific journals (International Sociology and Current Sociology) and a collection of books with excellent contributions (SS/S). But we also have a multilingual thought-provoking magazine (Global Dialogue), an online symposium with interview highlights and sociological briefings (e-Symposium), and an online community to share resources and practices (Social Justice and Democratization). This wonderful array of important sociological productions has the potential for greater outreach, beyond our ISA community, to other social sciences, to professionals and to society. One of my priorities will be to develop strategies towards this potential, for instance, moving sociologists who are very active in the social media to promote all ISA publications, expanding in this way readership and interest for sociological knowledges, beyond the walls of academia, to broader society.

Finally, my gratitude to two wonderful colleagues, Vineeta Sinha and Eloísa Martin, with whom I worked during my years in ISA publications. I will be eager to build on their excellent legacy as Vice-Presidents for Publications.

# Priorities if elected Vice-President of Finance and Membership

Vice-President for Finance Membership serves the global sociological community and the ISA as an organisation, not alone but in close collaboration with the President, the office, the VPs, the EC and importantly, the research councils and national associations. This VP needs to communicate and co-operate with all to guarantee that the organization stands on a firm and sound ground, and has the resources to develop into new directions. Thus, the position requires skills to listen, facilitate dialogue and together seek sustainable balance, for both reform and continuity. As VP I would prioritize the importance of not focusing on current membership only but also the potential members who might join the ISA but cannot do so yet, for various reasons. Making membership interesting accessible for all, across the globe and regardless of position, is my first priority. This includes finding ways to make ISA congresses, forums and other meetings more affordable and attractive to all. I have long experience in collaboration with universities in Africa and central, eastern and northern Europe, in

development studies, gender studies, anthropology, STS, etc., and would like to make ISA the home of such transdisciplinary global scholars - while also valuing membership in the North, both among early career and precariously employed sociologists, and experienced professors. Serious, respectful debates across continents and positionalities are the true richness of the ISA. Therefore, the number of members can grow, including new institutional members like regional organisations. Early career scholars and students are the future of the ISA and we need to offer room and resources for their own engagements. Further, external funding and new collaborations, for example with large foundations, need to be explored. My orientation to the ISA finances is of a feminist sociologist with long leadership and financial experience from large international consortia and organisations: I see money matters a bit similar to good conferences. They need to be fair, realistic and well organized, yet with an eye on the bigger picture. Only functioning structures enable mutual sharing, critique and support, and a good time together.

The ISA is not an easy organization, but it is also uniquely important as it provides a platform for dialogue among social scientists with a genuinely global orientation, through the dynamic RCs and the lively contact between NAs. The valuable work in these need to be fostered and rewarded, and they form the base of the association. A broad membership base and an economically healthy, democratic and transparent organization with a dynamic culture that transcends yet takes seriously global political geography, is a feasible goal, yet requires a lot of (collective) labor. I have served in the EC 2018-2023 (and two terms in the European Sociological Association board a decade ago), so I have a realistic picture of what the VP position takes. The last 5 years have also made my motivation grow.
