# 1. Report on members, March 2024

As of March 15<sup>th</sup> 2024, RC05 had 139 active members, which means paid-up member of RC05, who are also members of ISA. We have seen an increase since our last published members report (15 October 2022) when RC05 had 123 members, with this increase mostly driven by the ISA World Congress in mid-2023, when membership numbers peaked at 145 (July 2023). Our members reside in 29 countries, down from 34 countries in 2022, and the majority of our members still live in the global North. The breakdown by country of residence is as follows, changes over the last 17 months are indicated in brackets: Australia: 18 (+6); Bangladesh: 1; Belgium: 1; Brazil: 3 (-3); Bulgaria: 1; Cameroon: 1; Canada: 17 (+6); Chile: 3 (+2); Egypt: 1; Germany: 6 (+1); Greece: 1; India: 5 (+5); Indonesia: 2 (+1); Ireland: 1 (-1); Italy: 4; Japan: 11 (+2); Qatar: 1 (+1); Mexico: 1 (-4); Nigeria: 1; Portugal: 1; Republic of Korea: 3 (+2); Singapore: 5 (+4); South Africa: 3; Spain: 3 (+3); Sweden: 1; Switzerland: 1; Trinidad and Tobago: 1; United Kingdom: 9 (+1); United States: 33 (+2). The breakdown by Category A, B and C economies is:

Member A: 115 or 83% Member B: 12 or 8.5% Member C: 12 or 8.5%

Since our last report in October 2022, the distribution of members has seen a slight increase in the share of nationals from category C economies (+3.5%) but the share of nationals from category B economies has decreased (-6.5%). Meanwhile, the share of nationals from category A economies has increased slightly (+3%).

Over the 17 months we have gained some members from: Australia and Canada (+6 each); Singapore (+4); Spain (+3); Chile, Republic of Korea, and United States (+2 each); Germany, Indonesia, and United Kingdom (+1 each), and we have gained representation from India (+5) and Qatar (+1). Over the same period, we have lost some members from Brazil (-1), Ireland (-1), Mexico (-4), and we have lost representation from Ecuador (-1), Israel (-2), Netherlands (-1), New Zealand (-3), Turkey (-1).

We urge you as RC05 members to encourage sociologists from your country and neighbouring/nearby countries to become members of RC05. Membership provides an excellent opportunity to broaden your networks and to connect with researchers and scholars globally who are engaged with the critical issues around racism, nationalism, indigeneity, and ethnicity that concern us all. We also welcome suggestions for how we can broaden our membership to become more representative of the global community of scholarship that we are part of.

Remember that you can always contact the RC05 mailing list if you wish to share anything with your fellow sociologists, so please do share any events or opportunities that you think may be of interest.
