## **MESSAGE FROM THE RC-32 CO-PRESIDENTS**



We are very pleased to report that the submission of papers and sessions for the ISA Rabat Forum was finalized in December.

We are also very proud that RC32 received 289 abstracts submission for our 35 sessions!

Our sessions include: (a) the Presidential Session; (b) 27 regular sessions; (c) 4 joint sessions hosted by RC32; (d) 2 round tables including 61 abstracts; and (e) our Business Meeting. On top of that, RC32 is participating in 22 joint sessions hosted by other RCs, WGs and TGs!

It is also important that the abstracts and sessions submitted by RC32 cover a wide range of issues in the main Forum theme Knowing Justice in the Anthropocene and, more specifically, in the RC32 programme for Forum titled "Intersectional, Feminist Transformations: Theory, Methods, And Praxis", which includes five main thematic axes:

- 1. Gender, Feminism and the Assault on Democracy
- 2. Climate Justice in an Intersectional Feminist Perspective
- 3. Decolonial and Postcolonial Approaches to Anthropocene
- 4. Feminist Epistemologies, Theories and Methods: antidotes to deal with civilizational collapse
- 5. 30 years of the UN Beijing Conference

One of our goals was to make sure that the RC32 sessions in the ISA Rabat Forum – the first to take place in the Middle East and North Africa region – would include sessions addressing the lives of MENA women and LGBTQ+ individuals and, most importantly, would also include several speakers from the region. The RC32 Presidential Session titled "Women, War and Security: MENA and Global Perspectives" will bring together three of MENA's outstanding feminist scholars: Valentine Moghadam, Fatima Sadiqi and Yakın Ertürk. Moreover, several other sessions will also include Moroccan and other MENA region speakers.

The Forum Scientific Committee developed a new initiative that introduces a special time in the conference – through six semi-plenaries – dedicated to integrative sessions organized by groups of RCs/WGs/TGs and national associations. We are very thrilled that the RC32 proposal in collaboration with R24: Environment and Society and RC05 Racism, Nationalism, Indigeneity and Ethnicity was accepted! Our Integrative session/ semi-plenary is titled "Gender, Race Class and the Manthropocene: Justice for Whom?

Organizing 35 relevant, diverse and inclusive sessions has certainly only been possible through a very active collective collaboration among our RC32 members. We would like to thank all session organizers, the RC32 Board Regional Representatives and the RC32 Board Officers. A special thank goes to Hara Bastas and Manisha Desai - RC32 Co-Presidents Elect – for organizing over sixty abstracts into our two roundtables.

**Please Note:** We would also like to call your attention to the call for ISA and RC32 registration and travel grants we will send out in the in the first week of January.

Last but not least, we would like to wish all RC32 members a 2025 year with many happy and meaningful moments!

Prof. Patel's achievements serve as a source of inspiration, not only for her colleagues but for the broader academic community worldwide.




## CELEBRATING ACCLAIMED SCHOLARSHIP

## The Political Economy of Patriarchy in the Global South

By Ece Kocabiçak Now Freely Accessible to Readers Worldwide

Ece Kocabiçak's groundbreaking book, The Political Economy of Patriarchy in the Global South (2023, Routledge), stands at the intersection of gender, political economy, and sociology. This transformative work investigates how gender shapes macro-level political economies in the Global South, offering an innovative critique of classical and Marxist assumptions that capitalism alone drives social change.

By decentering theories grounded in the Global North, Kocabiçak uncovers the intricate role of uneven gender relations in shaping socio-economic transformation, state formation, and civil society.

## A Paradigm-Shifting Analysis

The book challenges reductionist perspectives that attribute diverse development trajectories to cultural or religious barriers. Instead, it reveals how patriarchal labour relations, particularly in agriculture, are central to shaping capitalist transformation. The analysis highlights how gendered property and labour relations influence initial capital accumulation, labour supply, and wage structures, while preventing the dominance of bourgeois farmers and sustaining the category of the 'patriarchal farmer.'

Through an alternative approach, Kocabiçak examines the mutual shaping of capitalism and patriarchy. Her work critiques existing frameworks, such as the social reproduction approach and gender regime scholarship, for neglecting the specificities of the Global South. The book introduces the concept of a 'premodern form of domestic patriarchy' and explores how gender, religion, and ethnicity-based oppressions intersect to create unique conditions for women in urban and rural settings.

#### Significance and Recognition

By questioning widely accepted assumptions about the gender-development relationship, The Political Economy of Patriarchy in the Global South proposes a new conceptual framework, including the category of the patriarchal farmer, and calls for rethinking political economic theories. Its implications extend across disciplines such as international development, sociology, economics, gender studies, and social policy.

This seminal work has received critical acclaim, named an 'essential reading' title by Choice Reviewed Titles (American Library Association) and nominated for the British Sociological Association's Philip Abrams Memorial Prize. Professor Birol Yeşilada of Portland State University described the book as "a breathtaking study that will stand the test of time."

## RC-32 MEMBERS REPORT

Transnational feminist networks, the political economy of women in Iran and the Middle East more broadly, gender regimes, globalization, and the women, peace, and security agenda (its promises and weaknesses) are the areas of my research and publications. In July 2024, I attended the conference of the International Association for Feminist Economics, which convened in Rome, and presented the co-authored paper with Prof. Karshenas that is scheduled for publication in December 2024 (see below).

Having written, edited, or co-authored several books, I have a contract for a book project, a gendered institutional study of UNESCO. When I was employed at UNESCO, April 2004-December 2006, I began to write about its early history and later analyzed programs and budgets. Most recently I have been examining the record of the Organization's first two women Directors-General, itself an achievement but one accompanied by formidable fiscal and geopolitical challenges.

For my work in Middle East Studies, I recently received an award: The 2024 Middle East Studies Association's Jere Bacharach Award for Service to the Profession (awarded on 16 Nov. 2024 during the annual MESA meetings). It was an honor and delight to have been nominated and then awarded.

I look forward to seeing many of you at the ISA's Fifth Forum in Rabat, July 2025, where I will be speaking at an RC-32 Presidential Session, presenting a paper at an RC-02 / WG11 session on the "Political Economy of Violence", and moderating an RC-02 / WG 11 session on "Revisiting Revolutions: Debates and Trajectories".

In what follows, I list recent and upcoming publications. It's worth adding that having published a paper with two Kurdish-Iranian sociologists (in Gender & Society), I have a forthcoming article with the senior scholar, Dr. Omid Ghaderzadeh (Sociology, University of Kurdistan, Sanandaj, Iran). A study of violence against women in Iran, in law and practice, and with focus on Iranian Kurdistan, the paper was presented virtually at the 2023 World Congress of Sociology, in Melbourne, Australia. It is to be part of a journal symposium edited by Margaret Abraham (Sociology, Hofstra University), which is currently under review.

#### **Recent conference**

The biennial Australian Women's and Gender Studies (AWGSA) conference took place on November 13-15 at Southern Cross University, Queensland, Australia.



Keynote speakers included Dr Mehreen Faruqi (Deputy Leader of the Australian Greens, Senator for New South Wales) and Professor Simone Fullagar (Chair of the Sport and Gender Equity research hub, Griffith University), and a keynote panel on women's leadership in academia with Professor Alison Pullen (Professor of Gender, Work and Organisation, Macquarie University), Dr Bindi Bennett (Professional Research Fellow, Federation University), Professor Meredith Nash (Director – Sexual Harassment and Gendered Violence, KPMG Australia), and Professor Liz Mackinlay (Professor – Faculty of Education, Southern Cross University).
