GREETINGS FROM RC 32 CO-PRESIDENTS





Dear RC32 members.

We are very pleased to write our first Newsletter message as the new RC32 Co-Presidents.

In this message, we would like to highlight the discussions and work we have conducted in the Board meetings as we seek to

expand and foster collaboration among RC32 members, especially as we prepare for the 5 th ISA Forum of Sociology Rabat.

Drawing on the remarkable work of previous RC32 Boards, we sought to introduce new ways to foster our collaboration and conversations across borders, and by doing so further accomplish our responsibilities and duties as Board members:

We decided to hold regular virtual meetings of the RC32 Board Officers (Co-Presidents, Co-Presidents Elect, Secretary, Treasurer and Newsletter Editor) as well as meetings of the whole RC32 Board (Officers and Regional Representatives from Asia, Africa, Europe, North America, Latin America and the Caribbean, and Australia). We were thrilled that – despite the challenging differences in time zones – we did manage to hold very well attended Board Officers meetings as well as meetings of the whole Board – Officers and Regional Representatives!

We strongly believe that it is very important to hold regular meetings of the Board Officers with all Regional Representatives in order to share information, foster inter-regional connections, and stronger exchanges and collaborative work.

We also decided to innovate in how our sessions for the ISA Forum are organized. RCs are allocated a number of sessions by ISA. For the ISA Form Rabat RC32 was allocated 35 sessions, the largest number of sessions given to a RC and based on membership numbers (we are all certainly very proud to have been for a long time the largest or one of the largest RCs)!

ISA instructs RCs to organize one Presidential Session, one Business meeting, Invited Sessions (in which the session organizers choose the topic and invite the speakers), and Regular Sessions (any member could propose a session content or description as ISA sent out a call for sessions proposal to all ISA members).

This year, as the RC32 Session Organizers, we also innovated extending the opportunity to organize Invited Sessions to all Board Officers and Regional Representatives (one Invited Session by region).

In order to further promote RC32 among all ISA members and give more visibility to research conducted by our members, we also decided to innovate by submitting a proposal for a Plenary Session to the Forum Rabat President (the ISA vice-president, Allison Loconto). In that process we were glad to find out that the Forum organizers are also innovating for the ISA Rabat Forum and RCs will be given the opportunity to collaborate on Plenary Sessions Proposals.

We have already contacted a number of RCs to propose collaboration on a Plenary proposal on the Rabat Forum theme Knowing Justice in the Anthropocene.

We would also like to highlight that are very pleased that ISA is taking place for the first time in a MENA country, and we have submitted a number of session proposals, including the RC32 Presidential Session – to include, promote and give further visibility within ISA to the scholarly work and praxis of MENA feminisms.

Finally, we would like to call your attention to the coming deadline for the Rabat Forum, and we would like to encourage all RC32 members to submit paper proposals when ISA sends out the call for papers/abstracts submissions:

August 5 - October 15, 2024 (24:00 UTC/GMT)

We are very much looking forward to working with all RC32 members before, during and after the 5 th ISA Forum of Sociology Rabat. We hope to carry out work during this presidency that is as transparent, collaborative, democratic and participatory as possible, and your participation could help us a lot on this journey.

I am excited to inform you that I have recently taken charge as the editor of the Women, Gender, and Society Research Committee (RC32) Newsletter for the International Sociological Association.


This newsletter aims to serve as a platform for sharing research, insights, and innovative ideas that advance our understanding and engagement with gender issues globally.

Abstract: During the COVID-19 pandemic, global gender inequalities in academia were highlighted. The Red Feminista de las Ciencias Sociales in Chile supports women researchers and advocates for gender equality and structural changes. This article reviews the Red's activities from mid-2021 to mid-2022, proposing strategies for a decentralised, decolonised, and feminist social science academia in Chile. The strategies include equity and justice in knowledge production, dignified work conditions, a harassment-free environment, and the democratisation of knowledge access, providing insights into promoting gender equality and collaborative work in academia.
