A collaborative webinar comprising pioneers from RC41 Sociology of Population; RC46 Clinical Sociology; and TG03 Human Rights and Global Justice titled 'Sociology-Policy Interface: Applied and Clinical Sociology' on Zoom, 30 May 2025 was Convened by Prof. M. Thamilarasan, Head of the Department of Sociology, University of Madras, Chennai, India. He is a member of the International Sociological Association's (ISA), RC-32 & RC-41 as well as serving as a Member of the ISA Research Council Webinar Working Group. It was *Co-Convened by Prof. Namita Gupta*, Chairperson, Centre for Human Rights and Duties at Panjab University, India. She is also Chair to the International Sociological Association's TG03 Human Rights and Global Justice. The webinar gave way to pragmatic insights led by sociology & policy driven social scientists. The prolific panel comprised Prof. Jan Marie Fritz, University of Cincinnati; Distinguished Visiting Professor, Professor, University of Johannesburg; Visiting Professor, Uppsala Universität and ISA Executive Committee Member elaborated on a much coveted topic of 'Human Rights and Addressing Mandatory Retirement Policies and Practices'.

This was followed by a talk by **Prof. Tina Uys,** Professor, Department of Sociology, University of Johannesburg, South Africa and ISA Executive Committee Member titled 'Empowering Whistle-blowers: Clinical Sociology and Social Justice in the Workplace'. She is a certified Clinical Sociologist with the Association for Applied and Clinical Sociology Recently appointed to the United Nations Independent System-Wide Evaluation Mechanism. She was



Vice-President of the International Sociological Association; President of ISA's RC46 Clinical Sociology and RC42 Social Psychology divisions. Prof. Emma Porio, Professor, Sociology, Ateneo de Manila University, Philippines was President of the International Sociological Association's Clinical Sociology Division (2019-2023) and of the Asia Pacific Sociological Association (2020-2023). Currently, she is Project Leader and Principal Investigator of the transdisciplinary action research project, Coastal Cities at Risk: Investing in Climate and Disaster Resilience in the Philippines (CCARPH). She led a focused discussion in the webinar titled 'Climate Justice, Environment and Community Resilience' which highlighted necessity of balanced environmental work with communities. The last leg of the webinar was a talk deliberated by Prof. Yvonne, Visiting Professor, Salem State University in Massachusetts USA who deliberated upon the critical issue of 'Addressing Homelessness' and the necessity of Housing as a protective factor in effectuating human rights. She is a clinical sociologist who is the founding director of the Center for Childhood & Youth Studies at USA where she is Professor of Healthcare Studies. She is a member of RC46 and a board member of TG03. A unique blend of the above emerging paradigms of sociology collaborated scholar-practitioners from RC41 Sociology of Population; RC46 Clinical Sociology; and TG03 Human Rights and Global Justice for bringing to the fore, efficacious-positively driven changes in public policy.
