Sadly, I am currently not well enough to travel to Morocco, but will be keen to hear your reports (I hope to fully recover in the next couple of months, so don't worry too much about me). Our Vice Presidents, Matteo and Joao will be in Rabat, and am sure they will do a sterling job of communicating with you all. If you are attending, please join in our business meeting. There are a few strategies we need you to approve to assist the board with the work of managing RC08. Also, we are organising a time to have a meal together – a good chance to catch up with new and old friends.

In this newsletter, you will find information about the conference. There are so many interesting sessions, I am sure it will be easy to find something of interest for everyone. You will also find that our journal, Serendipities: Journal for the Sociology and History of the Social Sciences, has published another issue. Huge thanks to my fellow managing editor, Kristoffer Kropp, for his diligence and patience in getting this through to publication. A special issue of the journal will be published later this year, with special issue editors Vincent Gengnagel and Christian Schmidt-Wellenburg. Thank you also Vincent and Christian! The journal is in need of some new associate editors, so please contact me if you would like to be part of this venture.



Another piece of news I hope you will find worthy of your attention is the publication of an edited collection, the Research Handbook on the Sociology of Knowledge. I have been working on this collection for several years. It was rather interrupted through the Covid19 pandemic, but has finally come to fruition. When you read the list of chapters, I am sure you will find the names of many of your colleagues or friends, making it especially relevant for our RC08 group. Many of the chapters examine the history of sociology or the sciences through the lens of the sociology of knowledge, revealing the dynamic interconnections between the social context and ideas, beliefs, cognition, communication and thought. Many also delve into deeply complex social issues, such as recent developments in our university systems which are impacting on our capacity to produce, protect and disseminate useful and important forms of knowledge. As I write, four of the universities close to where I live are retrenching hundreds and hundreds of academics. This is on top of the thousands that have been sacked over the past two to three years in Australian universities. The universities use the Covid19 pandemic as an excuse, citing a drop in money from international students, but even their own financial reports show no evidence of an ongoing impact of the initial drop. Over several decades, the Australian professoriate has been progressively removed from having any voice in the running of the universities, with the 'management' now consistenting of business-minded operators who have never worked in a university before and treat it like cardboard box factories. Several of our chapters look into this, asking questions about what this means for the scholars and for scholarly knowledge. Other chapters examine much less recent issues which nevertheless continue to have salience, such as the gendering of knowledge, and the racialisation of knowledge. I hope you will all find something to interest you in the collection.

The newsletter contains many more items than this of course, and I hope you will find these of assistance in our research or teaching. If there is anything you would like us to include in the next newsletter, please let us know. For now however, I wish you all the best in the coming months,

A Three-Volume Edition Contains the Collected Works of the Russian and Soviet Thinker Nikolai Nikolaevich Andreev.

A three-volume edition contains the collected works of the Russian and Soviet thinker Nikolai Nikolaevich Andreev (1876-1954), sociologist, historian, and philosopher. His long career of half a century fell at a turning point in recent Russian history, and his work reflected the historical processes of that era and made a significant contribution to the development of Soviet Marxism.

Andreev N.N. belongs to the list of scholars who shaped the fashion of Soviet social studies in the 1920s and 1940s. However, the works of N.N. Andreev are poorly known to specialists today and have practically not been reprinted. This edition includes already published books, brochures and articles, as well as unique materials from his recently discovered personal archive, including handwritten works, lections, academic and diary entries. Thus,


extensive unique material on sociology, history, anthropology, cultural studies, religious studies, and philosophy is introduced into scientific circulation.



An In-Depth Study of Surprising Insights Impressively Demonstrates the Ambivalent Legacy of Colonial Sociology.

The world we live in is shaped by the traces of modern colonial empires. What influence does this influence have on the social sciences and on postmodern sociology?

Colonial studies were once of crucial importance for this newly emerging discipline. From the 1930s onward, sociologists were called upon to apply their expertise to social issues such as "detribalization," urbanization, poverty, and labor migration. This colonial orientation permeated all major areas of research.

Especially during the era of decolonization, colonial sociology was at the forefront of its field, especially in imperial countries such as Great Britain and the Netherlands, but especially in France. There, more than half of sociologists researched colonial issues, both in the colonies and in the metropolises; among them were not only apologists but also of fierce critics imperialism. Numerous institutions emerged, including universities, research



institutes, government organizations, and museums dedicated to researching empires.

This in-depth study presents surprising insights and impressively demonstrates that the ambivalent legacy of colonial sociology has enormous influence on contemporary social science thought.

Serendipities values papers on any aspect of a sociological or historical analysis of the development of the social sciences.

In brief, we seek to publish papers that may be a combination of the best of 'sociology of' and 'social studies of' perspectives on those fields of inquiry which belong to what Wolf Lepenies called the third culture, a social space between science and literature. Papers might examine a subject from an historical point of view or challenge present day practices of any aspect of the social sciences. We also welcome contributions applying ideas or concepts from other disciplines, as long as the subject belongs to the social sciences.

Some of the topics the editors hope to see and publish in *Serendipities* concern the development of methodologies and research techniques; the institutionalisation processes of disciplines and their research directions; the 'traveling of ideas' from one scholarly culture to another; the role of funding agencies; and the relation between the social sciences, the state and social movements.

Finally, the interaction of social science with publics and various kinds of clients is a matter of great interest to the editors. From a methodological point of view, we particularly invite submissions which engage with the still underdeveloped field of sociological semantics, prosopography, and advanced quantitative and qualitative approaches to analyse the personnel of the social sciences, their practices and the knowledge they produce.
