





When people migrate and settle in other countries, do they automatically form a diaspora? In *Insurgent Communities*, Sharon M. Quinsaat explains the dynamic process through which a diaspora is strategically constructed. Quinsaat looks to Filipinos in the United States and the Netherlands—examining their resistance against the dictatorship of Ferdinand Marcos, their mobilization for migrants' rights, and the construction of a collective memory of the Marcos regime—to argue that diasporas emerge through political activism. Social movements provide an essential space for addressing migrants' diverse experiences and relationships with their homeland and its history. A significant contribution to the interdisciplinary field of migration and social movements studies, *Insurgent Communities* illuminates how people develop collective identities in times of social upheaval.

The Border Within: Vietnamese Migrants Transforming Ethnic Nationalism in Berlin (Stanford University Press), by Phi Hong Su, Williams College



When the Berlin Wall fell, Germany united in a wave of euphoria and solidarity. Also caught in the current were Vietnamese border crossers who had left their homeland after its reunification in 1975. Unwilling to live under socialism, one group resettled in West Berlin as refugees. In the name of socialist solidarity, a second group arrived in East Berlin as contract workers. *The Border Within* paints a vivid portrait of these disparate Vietnamese migrants' encounters with each other in the post-socialist city of Berlin. Journalists, scholars, and Vietnamese border crossers themselves consider these groups that left their homes under vastly different conditions to be one people, linked by an unquestionable ethnic nationhood. Phi Hong Su's rigorous ethnography unpacks this intuition. In absorbing prose, Su reveals how these Cold War compatriots enact palpable social boundaries in everyday life. This book uncovers how 20th-century state formation and international

migration—together, border crossings—generate enduring migrant classifications. In doing so, border crossings fracture shared ethnic, national, and religious identities in enduring ways.

From Chinatown to Everytown: How Chinese Immigrants Have Expanded the Restaurant Business in the United States (University of California Press), by Zai Liang, State University of New York

From Chinatown to Every Town explores the recent history of Chinese immigration within the United States and the fundamental changes in spatial settlement that have relocated many low-skilled Chinese immigrants from New York City's Chinatown to new immigrant destinations. Using a mixed-method approach over a decade in Chinatown and six destination states, sociologist Zai Liang specifically examines how the expansion and growing popularity of Chinese restaurants has shifted settlement to more rural and faraway areas. Liang's study demonstrates that key players such as employment agencies, Chinatown buses, and restaurant supply shops facilitate the spatial dispersion of immigrants while simultaneously maintaining vital links between Chinatown in Manhattan and new immigrant destinations.




Migration represents a challenge and opportunity. Among the world's migrants are nearly 34 million refugees and asylum seekers; of these, half are estimated to be children. As the world struggles to cope with global economic imbalances, diverging demographic trends, and climate change, international and internal migration are increasingly salient for the wellbeing, social integration, and civil and human rights of children and youth. *Migrant* Children and Youth includes contributions that illuminate and engage with children and youth as migrants. Featuring chapters from a global and diverse collection of authors, the chapters provide empirical insights from a global perspective of children and youth who are affected by migration processes. Examining root causes and agency, the authors ask, what extent do children and youth exercise volition in the decision to migrate either internally or internationally? From their vantage points to what extent are children and youth on the move, uprooted, and vulnerable? Upon resettlement, what are the social integration challenges and opportunities for children or youth, and to what extent are children and youth migrants constrained in this new context? What do children and youth experience because of migration, and what does this mean for their wellbeing, social integration, and rights?


Research on immigrant entrepreneurs initially attracted attention by collision with disciplinary orthodoxies. In the social sciences, extreme structuralism had long rejected any role for agency in small and medium business. Nonetheless, researchers into immigrant business required agency to explain their results. This agency they learned to call social and cultural capital. Already friendly to agency, business researchers speedily embraced the concepts of social and cultural capital as well as the insights of structuralism. The resulting theoretical synthesis took the name mixed embeddedness. Mixed embeddedness theory accepts input from both structure and agency but leaves their relative on a case-by-case basis. This structure/agency foundation opens and structures new avenues for research in a multiplicity of spun-off directions.





[Unofficial translation] If there is one subject prone to misconceptions, it is migration—a topic where public discourse rarely embraces nuance. Some nostalgically recall the "good old days" of Italian and Portuguese migration, allegedly marked by seamless integration, and now fear an influx of populations from the "Global South," supposedly facilitated by a porous Europe, thereby invoking the specter of the "great replacement." As a result, some call for the construction of walls and the closure of borders, even if it means turning the Mediterranean into a graveyard. Others, in contrast, argue for the inevitability of migration and stress its necessity in offsetting declining demographics and labor shortages—even if it deprives origin countries of their youth and skilled workers. In this analysis, Catherine Wihtol de Wenden highlights the significant gap between public perception and the actual data on migration flows, skillfully deconstructing many common myths.

The 23rd Annual Conference and 30th Anniversary of the International Society for Quality-of-Life Studies

22-25 July, 2025, Luxembourg

A special session titled "Effects of Spatial Mobility on Subjective Well-Being" will be featured at the ISOOLS 2025 Conference, taking place in Luxembourg from 22 to 25 July 2025. The session invites contributions that explore how various forms of spatial mobility—including internal and international migration, commuting, educational or professional relocations, recreational travel, and digital mobility (e.g., remote work)—influence subjective well-being.
