## RC20 Business Meeting at ISA Rabat 2025

The RC20 Business Meeting was held at AJSE032 of Muhammad V University, Rabat, Morocco, on July 8, 2025, chaired by David Weakliem, RC20 vice president. (1) It was reported that there were 66 presentations in 18 sessions (joint 4, regular 13, business 1), coordinated by Kseniya Kizilova, RC20 vice president. (2) Preparations for the RC20, RC33, and RC56 Joint Online Regional Conferences in 2026 were conducted as planned, coordinated by Fumiya Onaka, RC20 executive secretary, and several Thai researchers. (3) Discussions were held regarding the XXI World Congress of Sociology set to be held in Kwangju, South Korea in 2027. Fumiya Onaka was thus proposed to play the role of program coordinator for the Congress. (4) The Second RC20 (Comparative Sociology) Best Paper Award would be awarded at the RC20, RC33, and RC56 Joint Online Conference, and the schedules for call for application would be circulated in the future. (5) It was reported that the number of RC20 members had increased and now exceeds 100. (6) The RC20 finance was reported to be in good standing. (7) There were no objections to revisions of the Aims and Requirements Document proposed by the Research Council.

# Recent Papers on Populism and Authoritarianism in *Comparative*Sociology

Populism and authoritarianism are important issues in the contemporary world, and *Comparative Sociology* has published a number of articles on these topics. Some of these are listed below, along with short abstracts.

Frane Adam and Matevž Tomšič "The Future of Populism in a Comparative European and Global Context" (2019)

This article deals with the recent rise of populist tendencies and their meaning in contemporary democracies within the EU, including Eastern Europe. It stresses the importance of two interrelated and interconnected processes that provide a fertile ground for the emergence of different types of populism – crisis of parliamentary multi-party democracy and pressures of supranational integration and globalisation. Populism has the ambition to address both, to solve the political crisis and defend national sovereignty against globalism by personifying politics as a way of concentrating power. This means a tendency toward a (semi)-authoritarian (but still competitive) regime and state-led capitalism.

Efe Peker and Emily Laxer "Populism and Religion: Toward a Global Comparative Agenda" (2021)

This article proposes analytical tools for global comparisons of the populism-religion relationship. First, drawing on the ideational, performative, and strategic approaches to populism, the authors articulate how populists deploy religion in each category. Second, the authors employ this tridimensional conception to operationalize the "covert" and "overt" modes of religious populism identified in the literature. Third, the authors exemplify these ideal types via two pairs of case studies: France and Québec (covert), and India and Turkey (overt).

Ralph Schroeder "The Populist Revolt against the West: Alternative Paths within a Globalizing Modernity?" (2021)

The question this article tries to answer is: to what extent can the recent rise of populism outside of the West be attributed to anti-Western sentiment? Interest in populism has focused on Western democracies, with far less attention devoted to

regimes in non-Western parts of the world. This article takes three major cases – India, China, and Turkey. The article examines the recent intensification of populism in the three cases but also shows how populism fits into the longer comparative-historical trajectories of a revolt against Western domination. The conclusion puts populism in a wider perspective: how do these non-Western assertions of populism shed light on debates about alternative paths within modernity and on the nature of populism in Western democracies?

Geélison Ferreira da Silva, Robert Bonifácio da Silva, Mateus Rennó Santos, and Rafael Soares Duarte de Moura "Democracy and Crime in Latin America: What Do We Know about the Relationship from an Attitudinal Perspective?" (2024)

Do firm stances against crime, up to a level at which they disregard human rights, overflow the sphere of crime control and associate with a preference against democracy. Although no significant effects were found on democracy as the best form of government, victimization increases the likelihood of wanting a firearm, favoring the death penalty, and supporting coups, while it reduces the satisfaction with democracy and trust in institutions. Therefore, the results confirm that crime not only favors public support for harsh measures to control it but also weakens democracy and its institutions.

Abu Bakarr Bah and Sirojuddin Arif "Digitalized Electoral Democracy, Subversive Politics, and Islam: Indonesia in Comparative Perspective" (2024)

Increasingly democracy is becoming digitalized through the use of information technologies in the conduct of elections and political campaigns. At the same time, politics is becoming more contentious, and even subversive, as democracy fuses with divisive social issues and identity politics. Muslim-majority countries face major challenges in making democracy work due to subversive politics and the political and ideological conflicts between different Muslim groups. The authors argue that Indonesia stands as an in-between case in the continuum of subversive politics. They show this by explaining how democracy failed in some Muslim countries, became threatened in consolidated democracies, and survives in Indonesia. The combination of institutional quality and relative independence of religious organizations in politics has been crucial for the way Indonesia deals with subversive politics.

Suchismita Das and Satanik Pal "The Popularity of Donald Trump in India—Explained" (2025)

This article examines the curious popularity of Donald Trump in India by investigating pivotal events of Indian socio-political history and the embedded yet imperceptible tenets of Indian culture. The article reveals the processes that have nurtured affinity for populist leadership in India since the country's independence The analysis reveals a dialectical relationship between the demand for strong leadership and how it apparently guarantees individual freedom in India. Indians have previously displayed affinity for populist leaders both in their country and abroad – this article demonstrates how these ambivalences have come to exist

among Hindu nationalists wherein they support Indian and foreign populists simultaneously.
