From the President

“My religion is very simple. My religion is Kindness.” This simple but powerful message of His Holiness Dalai Lama did not stop resounding in my mind, on 14 December when the terrorist mass shooting occurred at Bondi Beach, Australia at targeted innocents on the Jewish holiday of Hanukkah. Ironically, this happened 4 days after the United Nations commemorated the iconic International Human Rights Day on 10 December 2025 embracing an ordinary yet remarkable theme. ‘Our Everyday Essentials’ entail the food we eat to the air we breathe; from the words we speak to the identity we claim; and from the rights enforced to the human right violations indifferently ignored.

Intolerance anywhere creates panic, hysteria and suspicion everywhere.

Where there is suspicion there is insecurity & distrust.

And with distrust, there can be no development.

Humanity thrives in certain core ethical principles. Despite dividing differences, every human being has the right to safety, speech, accessibility, health and participative decision making which holistically comprise this ‘everyday essentials’ campaign; empowering, connecting and sustaining all people across the seven continents.

This further only emphasises the significant contribution of the necessity to philosophise concepts of a holistic Anthropocene which has been developed in a plethora of parallel versatile academic dialogues at Rabat, Morocco in July this year.

The Mohammed V University in diverse university disciplines like Social Sciences, Economics, Law and Education identified the 2025 theme “Knowing Justice in the Anthropocene’. The ISA at this forum looked into distinct boundaries of Knowledge, Information, Pragmatic Reasoning and Justice in the context of the Anthropocene. Rigorous debates on environmental impact; racial & gender inequality; along with emerging socio-digital concerns were intensively examined. Imperative to mention here is that the varied sessions encompassed a spectrum of sociological topics with avid participation from all ISA research committees, working groups, and thematic groups. The Opening Ceremony full of introductory traditional folk music, resonated to the Global audience as it opened the discussion into the ‘Rights of Anthropocene’.

Rabat, a city boasting of rich history, culture and contemporary infrastructure assumed a prominent pioneer position as global locale in the MENA/Africa-Mediterranean region for the holistic global sociological community. The Forum attracted international participation from sociologists, scholars, researchers, and student fraternity. The TG03 community explored impact on Human Rights of the escalating intolerance; discrimination; pollution and toxicity levels in the environment where all nations have come to admit and acknowledge the existence of today’s shared fragile eco-system.

The Anthropocene epoch after all, is a Human Geological Era, which ironically has the solution, to the problem it confronts in the first place.

Summary of the 5th ISA Forum of Sociology (6-11 July 2025)

The ISA forum hosted 4842 registered participants from 112 countries over a full week of parallel robust rounds of 1300 sessions. Within this, the TG03 Human Rights and Global Justice conducted a total of 17 *sessions*; of which 9 sessions were held in joint collaboration with diverse multiple working groups & regional committees part of the ISA. These sessions coordinated by **Program Coordinator Dr. Bhup SINGH**, Maharishi Dayanand University; and **President TG03 Human Rights and Global Justice, Dr. Namita GUPTA**, Professor, Centre for Human Rights and Duties, Punjab University; revealed a versatile linkage of Human Rights with emerging sociological issues like Health, Social Identity & Justice, Dignified Aging, Sustainable Development, Gender Diversity, Student Mobilities in the Global South, Rule of Law in the Anthropocene.

1. *The First Joint Session JS-19 titled ‘How do the Arts play a role in Social Justice?’* was held by TGO3 Human Rights and Global Justice in collaboration with **Research Committee RC37 Sociology of Arts**. Ayca KURTOGLU, Acibadem Mehmat Ali Aydinlar University and Ilaria Riccioni, Free University of Bozen-Bolzano, were the Session Organizers. A total of four papers were presented by Jules Andre DEBUYST; Anna Lisa TOTA; Nuria SUERO COMELLAS; and Lia LUCHETTI.

2. *The second Joint Session of TG03, Human Rights and Global Justice, JS-29 titled ‘Dignified Aging in the Digital Age’* was in collaboration with **WG10 Digital Sociology** along with **RC03 Community Research, RC06 Family Research, RC07 Future Researches** and **RC11 Sociology of Aging**. - ***Jan Marie Fritz***, ISA EC Member and ISA Senior Representative to the UN in the same context, scheduled online training sessions use of Universal Periodic Review, which took place on the 2.12.2025 and 10.12.2025. On **Human Rights Day**, the **Global Rally 2026** was formally announced which will take place **1st-7th February 2026**. The Global Rallies are flagship initiatives for the Age With Rights campaign. They have mobilised thousands of people around the world through their activities and reached millions of people through social and other media. They present a key moment to mobilise ahead of key UN sessions and have contributed to positive steps forward at the international level. This upcoming Rally is critical to ensure that older persons have an equal voice in the negotiations of the UN convention.

From the Editor's Desk

Author Octavia Butler, says that Change is the one unavoidable and irresistible ongoing reality of the universe. The Etymological term ‘Anthropocene’, means Human (Anthros) & Research (Cene); which means the ‘Age of Humans’. It can be safely stated that in the Anthropocene, *there are no disinterested observers, only participants.* Paradoxically, the contradiction of human power is that we are at the same time, powerful, yet not nearly powerful enough. Human Beings, are significantly strong enough to radically manipulate and impact Earth’s climate and biodiversity, but not powerful to choose how we re-shape or even restore them. Our species has incredible acumen which has led to astronauts crossing the Earth’s atmosphere, yet we are not equipped enough to save those we love from suffering.

Thus, spatial and temporal future of Humanity in the biosphere, even in its inevitability, will always be vague and nebulous. Undoubtedly, human actions that define Anthropocene are climate, change, industrialisation, pollution, deforestation, biodiversity loss, ocean changes, and urbanisation. Anthropocene, in the ISA forums delved into conversations about human beings being strong formidable agents almost equivalent to natural forces, like volcanoes, avalanche, snow, blizzards, earthquakes etc. History has been witness to the fact that Humanity as a species, is resilient and has the tenacity to survive natural/man-made disasters. Ironically, for many lifeforms, humanity also signifies and threatens the ultimate collapse.
